- (c) the area of operation of the Orange Vaal Water User Association includes all properties in respect of which any person is entitled to use water (surface and underground water) by virtue of entitlements in terms of section 22 (1) of the Act, from—
 - (i) the Vaal and Orange Rivers and accompanying waterworks in respect of the area downstream from and including the farms De Bad 155 and Sivonel 42 on the Vaal River up to its confluence with the Orange River and downstream from the boundary of the Lower Orange Water Management Area on the northern bank of the Orange River from and including the farm Nottingham 153 up to and including the farm Mazelsfontein 75; and
 - (ii) any other water resource situated outside the area described in paragraph (c) (i) above, which water resource and accompanying area the Department of Water Affairs and Forestry or the responsible authority may require the Association to control;

which is situated in water management area number 14 in the Northern Cape Province; and

- (d) the constitution of the Orange Vaal Water User Association has been approved.

NATIONAL HERITAGE RESOURCES ACT, (Act No. 25 of 1999)

DECLARATION OF TYPES OF HERITAGE OBJECTS

In terms of section 32(5)(b)(i) of the National Heritage Resources Act, 1999 (Act No. 25 of 1999), and its definitions in section 2, the South African Heritage Resources Agency hereby declares the list of heritage objects, as fully described below, to be types of heritage objects that are deemed protected in terms of the National Heritage Resources Act and for which a permit in terms of the said Act is required for export from the country.

TYPES OF HERITAGE OBJECTS:

1. Any archaeological artefact, palaeontological and rare geological specimens and meteorites found in South Africa and its territorial waters and maritime cultural zone;
2. Antiquities such as coins, utensils, pottery, jewellery, seals, weapons (including firearms) tools and inscriptions that have been in South Africa for more than 100 years;
3. Original fabric removed from South African historical buildings;
4. South African ethnographic art and objects;
5. Items relating to South African history, including the history of science and technology, military and social history, as well as to the life of peoples and national leaders, thinkers, scientists and artists and to events of national importance;
6. South African items of artistic interest that have been in South Africa for 50 years or more, including—
 - (a) paintings and drawings produced by hand on and in any material;
 - (b) original prints, posters and photographs, as the media for creative activity;
 - (c) original artistic assemblages and montages in any material;
 - (d) works of statuary art and sculpture in general;
 - (e) works of applied art in such materials as glass, ceramics, metal and wood; and
 - (f) objects of ritualistic and symbolic significance and personal adornment such as beads, leather or metalwork;

7. South African items of numismatic (medals and coins) and philatelic (stamps and cancellations) interest that have been in South Africa for more than 100 years;
8. Manuscripts, books, documents or publications of special interest to South African history and culture that have been in South Africa for 50 years or more; or that are otherwise deemed of special interest and importance to South African heritage as recommended by the National Archives Advisory Council;
9. South African archives, including written records, maps and other cartographic materials, prints, photographs, cinematographic films, sound recordings and machine-readable records that have been in South Africa for more than 50 years; or that are listed in the national registers of manuscripts, photographs, audio-visual material or oral sources;
10. South African furniture, tapestries, carpets, items of dress and musical instruments older than 100 years; and
11. South African zoological, botanical and geological specimens that have been in South Africa for more than 100 years.
12. The above exclude any object made by any living person.

An application has been filed with the Competition Commission by South African Airways (Pty) Limited (SAA) and Qantas Airways Limited (Qantas) for an exemption from certain of the provisions of Chapter 2 of the Competition Act, 1998 (the Act) in respect of a code sharing agreement and a commercial agreement on the South Africa/Australia route.

The most important features of the agreement between the parties is that it provides for:

- ☐ The parties to co-ordinate their activities in respect of the route between South Africa and Australia. SAA is to operate between Johannesburg and Perth, while Qantas is to operate between Johannesburg and Sydney.
- ☐ The parties shall purchase a fixed percentage of the seat capacity on the other's aircraft.

The agreement would, on the face of it, contravene section 4 (1) (b) (ii) of the Act. The act provides, in section 10 (3) (b) for four grounds on which an exemption application may be granted. A further ground in respect of the protection of rights acquired in terms of the intellectual property laws of this country is also provided for in section 10 (4). The parties aver that two of these grounds are relevant, namely—

- ☐ The maintenance and promotion of exports [section 10 (3) (b) (i)]; and
- ☐ A change in productive capacity necessary to stop decline in an industry [section 10 (3) (b) (iii)].

Notice is hereby given in terms of section 10 (7) of the Act that an exemption has been granted until 18 December 2005 of section 10 (2) (a) of the act, Section 10 (2) (a) provides that exemptions may be granted subject to conditions.

The conditions in this case are:

- ☐ The exemption is granted on the facts put forward by the applicant.
- ☐ The parties to the agreements shall not share or pool revenues with each other under the code share or commercial agreements.
- ☐ The parties to the agreements must each independently establish and determine their own tariffs and fares on the code share flights, and market these flights separately.
- ☐ Qantas and SAA withdraw from all IATA tariff coordination activities in relation to airfare levels between Australia and South Africa.
- ☐ Any amendment to the agreement shall not be of force and effect until approved by the Commission.
- ☐ Parties must add a clause to their agreements stating that the agreements are subject to the above-mentioned conditions, and in so far as there is a conflict between any term of the agreement between the parties on the one hand and these conditions on the other hand, the conditions shall prevail.

BOARD NOTICE 101 OF 2002**THE SOUTH AFRICAN PHARMACY COUNCIL****INVESTIGATION IN TERMS OF SECTION 4(K) OF THE PHARMACY ACT, 1974 (ACT 53 OF 1974) ("the Act") OF THE PRINCIPLE OF FRANCHISING OF RETAIL PHARMACIES IN SOUTH AFRICA AND THE USE OF TRADING TITLES OR TRADEMARKS OR LOGOS OR "BRAND NAMES" BY RETAIL PHARMACIES****1.**

Please take note that the South African Pharmacy Council ("the Council") has resolved to investigate the principle of franchising of retail pharmacies in South Africa and of the use of trading titles or trademarks or logos or "brand names" by retail pharmacies.

2.

To achieve this objective, the Council has resolved to appoint its Registration and Permits Committee ("the Committee") to conduct an investigation into the above issues.

3.

The Committee will meet at the offices of the South African Pharmacy Council on a date to be determined for such investigation.

4.

The issues which the Committee shall consider, will include the following:

- 4.1 Whether the franchising of retail pharmacies constitutes a contravention of the provisions of the Pharmacy Act, 53 of 1974 ("the Act") and, if so, in what respect. The legality or not of the use of trading titles, trademarks, brand names or logos by pharmacies where the lawful owner of the trading title, trademark, "brand name" or logo is not a registered retail pharmacist?
- 4.2 Whether the concept of franchising of retail pharmacies and the use of trading titles, trademarks, "brand names" or logos in circumstances as set out in paragraph 4.1 above constitute a contravention of the provisions of rule 21 of the *Rules relating to acts or omissions in respect of which the Council may take disciplinary steps* (GN R. 599 of 31 March 1999, as amended) or not?
- 4.3 The setting of guidelines and/or criteria in order to determine the conditions upon which the franchising of retail pharmacies should be allowed, should it be concluded that franchising is in fact permissible in terms of the Act.
- 4.4 The setting of guidelines and/or criteria in order to determine the conditions upon which the use of trading titles, trademarks, "brand names" or logos in the circumstances as set out in paragraph 4.1 should be allowed, should it be concluded that the use of such trading titles, trademarks, "brand names" or logos is in fact permissible in terms of the Act.

5.
