



The approved amount of additional industrial investment allowance in respect of industrial assets to be used for Sublime Technologies (Pty) Ltd is R139 156 468 (one hundred and thirty nine million, one hundred and fifty thousand, four hundred and sixty eight rands only), 100% of R 139 156 468, the cost of qualifying industrial assets.
- 1.8 The potential national revenue to be forgone by virtue of deduction of the approved allowance for Sublime Technologies (Pty) Ltd will be R 139 156 468.
