MARINE LIVING RESOURCES ACT, 1998 (ACT NO. 18 OF 1998)

FISHING HARBOUR FEES

I, Mohammed Valli Moosa, Minister of Environmental Affairs and Tourism, acting with the concurrence of the Minister of Finance, hereby under section 27(3) of the Marine Living Resources Act 18 of 1998, determine the fees payable for the use of fishing harbour facilities as set out in the Schedule.

SCHEDULE

1. In this Schedule any word or expression to which a meaning has been assigned to in the Act, shall bear the meaning so assigned to it and, unless the context indicates otherwise—

"active lay-up" means a vessel that is moored for a period that is longer than the norm for purposes of being repaired, altered, modified in part or whole or for some other acceptable on-going purpose, but where such vessel does not pose a threat or danger to other vessels in the harbour or to other harbour-users;

"commercial activity or commercial use" means with a purpose to secure a financial return;

"departmental" means ownership to or direct association with the Department of Environmental Affairs and Tourism;

"fishing vessel" means any vessel, boat, ship or other craft which is used for, equipped to be used for or of a type that is normally used for fishing or related activities, and includes all gear, equipment, stores, cargo and fuel on board the vessel;

"hawker" means any person who does not use a semi-fixed structure and who does not lease a temporary site to trade from;

"leisure or recreational vessel" means a vessel that is not used for commercial purposes;

"mediterranean mooring" means the configuration of mooring a vessel so that its bow or stern is fastened to a quay, jetty, sea-wall, or breakwater, whilst its stern or bow (as applicable) is fastened to an anchor or block on the harbour floor, via a mooring line;

"normal working hours" means from 08h00 to 16h00 Monday to Friday (excluding public holidays);

"passenger" means any person carried in a vessel except a person employed or engaged in any capacity on board the vessel on the business of the vessel and a child under one year of age;

"per month or part thereof" means from the first to the last day of a month;

"per week or part thereof" means periods which extend from Monday to Sunday;

"per year" means from 01 January to 31 December of a calendar year;

"register tons and register tonnage" means the tonnage of the vessel, either gross or net as the case may be, recorded in the vessel register referred to in section 15 of the Merchant Shipping Act, 1951 (Act No. 57 of 1951);

"safety certificate" means a certificate issued under section 194(1)(a) or (b)(ii) of the Merchant Shipping Act, 1951 (Act No. 57 of 1951);

"swing mooring" means a mooring configuration where the vessel is moored by one mooring line attached at one end to the bow and the other end to an anchor or block on the harbour floor;

"the Act" means the Marine Living Resources Act, 1998 (Act No. 18 of 1998);

"trader" means any person who uses a semi-fixed structure and/or leases a temporary site to trade from;

"trot mooring" means a configuration where a vessel is moored by means of fastening two mooring lines, one from the bow and the other from the stern, each fastened at their other ends to their own anchor or block on the harbour floor;

"unseaworthy", used in relation to a vessel, means that she is not in a fit state as to the condition of her hull, equipment or machinery, the stowage of her cargo or ballast, or the number or qualifications of her master or crew, or in any other respect, to encounter the ordinary perils of the voyage upon which she is engaged or is about to enter or be placed;

"unseaworthy vessel" means a vessel that is not in a fit state as to the condition of her hull, equipment or machinery, the stowage of her cargo or ballast and fuel, or the number or qualifications of her master or crew, her provisions and in all other relevant respects, to encounter the ordinary perils of the purpose to which the vessel is engaged or about to be placed.

"vessel" includes any canoe, lighter, floating platform, decked boat, carrier vessel, vessel equipped with an inboard or outboard motor or any other craft, whether a surface craft or submarine;

2. All fees are payable in advance provided that any permit or ticket which has been issued in accordance with the provisions of the Marine Living Resources Act 18 of 1998, and which has not yet expired at the date of this Notice, shall be deemed to be a valid permit or ticket issued in terms of this Notice.

3. The tariffs as set out in paragraph 5, shall include the slipping and un-slipping of vessels during normal working hours and shall for all fishing harbours, be:

- (i) measured between the extreme points the nearest full meter (only where the tariff is length-based) and calculated from the time the slipway takes the vessel until the time the vessel leaves the slipway, and
- (ii) payable for each continuous period of 24 hours or part thereof, including Saturdays, Sundays and public holidays, during which the slipway is occupied, provided/excepting that the booking fee must be paid in advance /is payable in advance in order to secure a position on the slip.

Attention is drawn to the fact that the temporary leasing of a site within a fishing harbour shall be subject to the applicant obtaining prior written approval from the National Department of Public Works for the leasing of such site.

 - (vii) any bus carrying supervised scholars and teachers on official school outings.

23. In terms of section 81(1) of the Act, the Minister may, if he or she is of the opinion that there are sound reasons for doing so, and subject to the conditions that he or she may determine, in writing exempt any person or group of persons or organ of state from a provision of this notice.

24. Any person who contravenes or fails to comply with any provision of this notice shall be guilty of an offence and liable on conviction to a fine not exceeding two million rand, or to imprisonment for a period not exceeding not exceeding five years.

25. Government Notice No. 1692 dated 24 December 1998 is hereby repealed.

26. This notice takes effect on 1 February 2003.

Ek, Mohammed Valli Moosa, Minister van Omgewingsake en Toerisme, handelend in oorleg met die Minister van Finansies, bepaal kragtens artikel 27(3) van die Wet op Lewende Mariene Hulpbronne, Wet 18 van 1998 hiermee die gelde betaalbaar vir die gebruik van vissershawefasilitete soos in die Skedule uiteengesit.

SKEDULE

1. In hierdie Skedule het 'n woord of uitdrukking waaraan in die Wet 'n betekenis geheg is, daardie betekenis, en tensy uit die samehang anders blyk, beteken—
 - “aktief stilgelê” dat 'n vaartuig vasgemeer word vir 'n langer tydperk as normaalweg ten einde gedeeltelik of in geheel herstel, gewysig of verander te word, of vir 'n ander aanvaarbare voortdurende doel, mits so 'n vaartuig nie 'n bedreiging of gevaaer inhoud vir ander vaartuie in die hawe of ander hawegebruikers nie;
 - “departementeel” eienaarskap deur, of direkte assossiasie met die Departement van Omgewingsake en Toerisme;
 - “die Wet” die Wet op Lewende Mariene Hulpbronne, 1998 (Wet No.18 van 1998);
 - “geregistreerde ton en geregistreerde tonnemaat” die tonnemaat van die vaartuig, óf bruto óf netto soos die geval ook al mag wees, aangeteken in die vaartuigregister waarna verwys word in artikel 15 van die Handelskeepvaartwet, 1951(Wet No. 57 van 1951);
 - “handelaar” 'n persoon wat van 'n vaste struktuur gebruikmaak en/of 'n tydelike terrein huur waarvandaan hy/sy handel dryf;
 - “kommersiële aktiwiteit of kommersiële gebruik” met die doel om finansiële opbrengste te verseker;
 - “mediterense vasmeerstelsel” dat 'n vaartuig so vasgemeer word dat haar boeg of agterstewe vas is aan 'n kaai, steier of golfbreker, terwyl haar agterstewe of boeg (die een van toepassing) vas is aan 'n anker of blok op die hawevloer, deur middel van 'n ankertou;
 - “normale diensure” vanaf 08h00 tot 16h00 Maandag tot Vrydag (openbare vakansiedae uitgesluit);
 - “onseewaardig” in verband met 'n vaartuig, dat die vaartuig wat die toestand van sy romp, uitrusting of masjinerie, die berging van sy vrag of ballas, of die aantal of die kwalifikasies van sy gesagvoerder of bemanning betref, of in enige ander opsig nie in 'n geskikte toestand verkeer om teen die gewone gevare van die reis waarop die vaartuig is of op die punt staan om te gaan, bestand te wees nie;

"onseewaardige vaartuig" 'n vaartuig wat nie in 'n gesikte toestand is nie met betrekking tot die toestand van haar romp, toerusting of masjinerie, die laairuimte van haar skeepslading of ballas en brandstof of die aantal kwalifikasies van haar gesagvoerder of bemanning, haar voorraad en in alle ander toepaslike aspekte, om die gewone gevare gepaardgaande met die doel waarvoor dit gebruik word of geplaas gaan word, te hanteer;

"passasier" enige persoon wat vervoer word in 'n vaartuig, behalwe 'n persoon in diens van, of betrokke in die bedryf van die vaartuig in enige kapasiteit aan boord van die vaartuig en 'n kind onder die ouderdom van een jaar;

"per jaar" vanaf 1 Januarie tot 31 Desember van 'n kalenderjaar;

"per maand of gedeelte daarvan" vanaf die eerste tot die laaste dag van 'n maand;

"per week of gedeelte daarvan" tydperke wat duur van Maandag tot Sondag;

"smous" enige persoon wat nie van 'n vaste struktuur gebruik maak nie en ook nie 'n tydelike terrein huur waarvandaan hy/sy handel dryf nie;

"sport- of ontspanningsvaartuig" 'n vaartuig wat nie gebruik word vir kommersiële doeleindes nie;

"swaai-vasmeerstelsel" dat 'n vaartuig vasgemeer word deur een ankertou wat aan die een punt vasgemaak is aan die boeg en aan die ander punt aan 'n anker of blok op die hawevloer;

"vaartuig" ook enige kano, ligter, drywende platform, dekboot, draboot, vaartuig toegerus met n binneboord- of buiteboordmotor of enige ander tuig, het sy 'n oppervlaktuig of duikboot;

"veiligheidsertifikaat" 'n sertifikaat uitgereik kragtens artikel 194(1)(a) of (b)(ii) van die Handelskeepvaartwet, 1951 (Wet No.57 van 1951);

"vissersboot" 'n vaartuig, boot, skip of enige ander tuig wat gebruik word vir, toegerus is vir, of 'n soort wat gewoonlik gebruik word vir die vang van vis of verwante bedrywighede, met inbegrip van alle vistuig, toerusting, voorrade, vrag en brandstof aan boord van die vaartuig;

"voor en agter vasmeerstelsel" dat 'n vaartuig vasgemeer word deur middel van twee ankertoue, een vanaf die boeg en die ander vanaf die agterstewe, elkeen aan die ander punt vasgemaak aan hul eie ankers of blokke op die hawevloer;

2. **Alle tariewe is vooruit betaalbaar, met dien verstande dat enige permit of kaartjie wat uitgereik is ingevolge die bepalings uitgevaardig kragtens die Wet op Lewende Mariene Hulpbronne, Wet 18 van 1998 en waarvan die geldigheidsduur by die inwerkingtreding van hierdie kennisgewing nog nie verstryk het nie, geag word 'n geldige permit of kaartjie uitgereik ingevolge hierdie kennisgewing, te wees.**

3. Die tariewe soos uiteengesit in paragraaf 5, sluit die opneem en aflaat van vaartuie gedurende normale diensure in en sal as volg wees vir alle hawens:

- (i) gemeet van die twee verste punte, die naaste volle meter (slegs waar die tarief lengtegebaseer is), en bereken vanaf die tyd waarop die sleephelling die vaartuig neem tot die tyd waarop die vaartuig die sleephelling verlaat; en
- (ii) betaalbaar vir elke aanenlopende tydperk van 24 uur of gedeelte daarvan, met inbegrip van Saterdae, Sondae en openbare vakansiedae waartydens die sleephelling beset word, op voorwaarde/uitgesonderd dat die besprekingsfooi vooruit betaalbaar is om 'n plek op die sleephelling te verseker.



