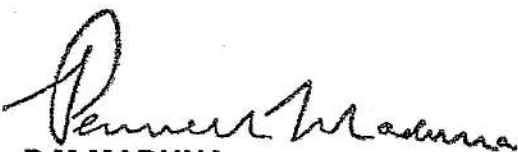

**APPOINTMENT OF HA-MAKUYA AS A PLACE FOR THE HOLDING OF A PERIODICAL

I, Penuell Mpapa Maduna, Minister for Justice and Constitutional Development, acting under section 2(1) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby-

- (a) appoint Ha-Makuya within the district of Thohoyandou as a place for the holding of a periodical court; and
- (b) prescribe the local limits of the district of Thohoyandou as the local limits within which the said court shall have jurisdiction.

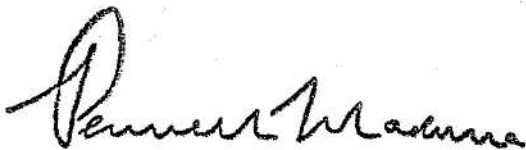
