APPOINTMENT OF LEEU-GAMKA AS A PLACE FOR THE HOLDING OF A PERIODICAL COURT WITHIN THE DISTRICT OF PRINCE ALBERT

I, Penuell Mpapa Maduna, Minister for Justice and Constitutional Development, acting under section 2 (1) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), hereby—

- (a) appoint Leeu-Gamka within the district of Prince Albert as a place for the holding of a periodical court; and
- (b) prescribe the local limits of the district of Prince Albert as the local limits within which the said court shall have jurisdiction.
