# OBJECTS OF DECLARED CULTURAL INSTITUTION IN TERMS OF SECTION 8 (5) OF THE CULTURAL INSTITUTIONS ACT, 1998 (ACT NO. 119 OF 1998)

I, Baldwin Sipho Ngubane, Minister of Arts, Culture, Science and Technology approved the objects of certain declared cultural institutions on 27 March 2003, in terms of section 8(1) of the Act hereby publish the objects of the institutions as required by section 8(5) of the Act, in the Schedule.

#### SCHEDULE

# A. ARTSCAPE

- To advance, promote and preserve the various performing arts in South Africa, but predominantly in the Western Cape by, inter alia, and without limiting the generality of the aforesaid:
  - 1.1 promoting and / or presenting, and or co-presenting, and / or producing, and /or co-producing, and /or investing in, and /or sponsoring, and/or entering into partnership for any performing arts initiative;
  - 1.2 making the performing arts accessible to the general public and ensuring that productions are a true reflection of the cultural diversity of South Africa.
  - 1.3 evaluating, maintaining and upgrading the Artscape Theatre Centre and its facilities so that the full range of performing arts productions can be presented in a world class environment;

- 1.4 making the Artscape Theatre Centre accessible to the general public;
- 1.5 promoting the appreciation, understanding and enjoyment of the performing arts among the general public.
- 1.6 providing high quality arts education and development with due consideration of the needs of the general public;
- 1.7 encouraging artists to adopt the stage and associated arts as their profession;
- 1.8 encouraging and promoting the writing and producing of new performing art works for presentation on stage;
- 1.9 encouraging indigenous art and creativity, including, but not limited to, script writing, musical composition and choreography;
- 1.10 encouraging tours of performing arts and art products;
- 1.11 facilitating manufacturing services for décor and costumes to enable arts practitioners to stage their productions;
- 1.12 conducting all such other activities as may be considered ancillary to any of the aforesaid.
- To be the appropriate legal recipient and accountable reporting body for funding received from the Department of Arts and Culture and grants received from third parties, and for expending such grants, in accordance with the terms and conditions under which same were received.

### **B. PERFORMING ARTS CENTRE OF FREE STATE (PACOFS)**

- To foster the expression of a national identity and consciousness by means of the performing arts.
- To present and professionally develop the performing arts to the benefit of all the people in the Free State.
- To identify, assist, encourage and develop local talent artistically and infrastructurally by actively pursuing the empowerment of performing artists and support staff within its artistic programme and employ.
- To educate and develop audiences through financially and the presentation of aesthetically accessible programmes.
- 5. To develop and promote the diverse cultures in the Free State province.
- To support and strengthen organizations, communities and individuals through arts and culture.
- 7. To develop programmes on the basis of community needs.
- To promote the appreciation, understanding and enjoyment of the performing arts.
- To give the historically disadvantaged additional help and resources to give them greater access to the performing arts.

### CHOICE ON TERMINATION OF PREGNANCY ACT, 1996 (ACT NO. 92 OF 1996)

### DESIGNATION OF FACILITIES FOR THE SURGICAL TERMINATION OF PREGNANCIES

I, Mantombazana Edmie Tshabalala-Msimang, Minister of Health, hereby designate, in terms of section 3 of the Choice on Termination of Pregnancy Act, 1996 (Act No. 92 of 1996), the institutions listed in the Schedule as facilities where the surgical termination of pregnancies may take place in accordance with the said Act.

#### SCHEDULE

#### Definitions

 In this schedule any word or expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context otherwise indicates -

"access" means access to resources without these necessarily having to be on site at a facility;

"operating theatre" means an operating unit which is fully equipped to administer a local or general anaesthetic and to deal with any complication that may arise as a result of such an anaesthetic;

"the Act" means the Choice on Termination of Pregnancy Act, 1996 (Act No. 92 of 1996).

Requirements to be met by public health facilities and private health facilities in order to be designated as facilities contemplated in section 3 of the Act

- Any public or private health facility must meet the following requirements in order to be designated in terms of section 3 of the Act as a facility where the surgical termination of pregnancies may take place:
  - (a) access to medical and nursing staff;
  - (b) access to an operating theatre;
  - (c) appropriate surgical equipment;
  - (d) drugs for intravenous and intramuscular injection;
  - (e) emergency resuscitation equipment and access to emergency referral center or facility;
  - (f) access to appropriate transport should the need arise for emergency transfer;
  - (g) facilities and equipment for clinical observation and access to in-patient facilities;
  - (h) appropriate infection control measures;
  - (i) access to safe waste disposal infrastructure; and
  - (j) telephonic means of communication.

Privileges and immunities are accorded to Mr. Kalumiya of the UNHCR not for the personal benefit of himself, but in order to safeguard the independent exercise of his functions in connection with the UNHCR's repatriation of Angolan refugees. Consequently, there is a duty to waive the immunity in any case where the immunity would impede the course of justice and it can be waived without prejudice to the purpose for which the immunity is accorded.
- 3. Mr. Kalumiya shall co-operate at all times with the appropriate authorities of South Africa to facilitate the proper administration of justice, secure the observance of the laws of South Africa and prevent the occurrence of any abuse in connection with the privileges and immunities mentioned above.
- 4. In the event that the UN issues a UN Laissez-Passer to Mr. Kalumiya, this Laissez-Passer shall be recognised and accepted as a valid travel document.

- (iv) "chief executive officer" means the person appointed as chief executive officer under section 8(1)(a) of the Act;
- (v) "Council" means the Engineering Council of South Africa established by section 2 of the Act;

#### Lodging of an Appeal

- 2. An appellant who intends to lodge an appeal in terms of section 24(1) of the Act, must do so within 30 days from the date on which the refusal to register him or her, or the cancellation of his or her registration, came to his or her knowledge, by lodging the appeal in the manner prescribed by these rules with the chief executive officer and paying the prescribed fee.
- 3. Such appeal must be in writing and must set out the grounds for the appeal and all relevant arguments, information and documentation in support thereof;
- The chief executive officer may grant extension of time for the lodging of an appeal for reasons that he/she deems sufficient.
- 5. The chief executive officer must, within 14 days after receipt of the appeal and the prescribed fee, submit the appeal, together with all documentation lodged with the appeal, to the relevant committee from which the first recommendation to refuse an application, or the decision to cancel the registration emanated, and request such committee to examine the grounds for the appeal and furnish its comments to the chief executive officer within 21 days after receipt of the request from the chief executive officer.

#### Appointment of Appeal Committee

- 6. The chief executive officer must appoint an appeal committee, consisting of no more than 4 members, from a panel of persons approved by the Council. These persons must be appropriately qualified to hear the particular case under appeal, and no member of the appeal committee so appointed may be a member of the committee from which the original decision emanated.
- The chief executive officer must designate the chairperson from the members of the appeal committee.

#### Hearing of an appeal

- 8. After receipt of the comments of the committee referred to in rule 5, the chief executive officer must without delay submit the appeal in question, together with all supporting documentation, as well as such comments to the appeal committee for consideration, and at the same time determine, in consultation with the members of the appeal committee, a date and venue for considering the appeal.
- 9. The appeal committee must invite the appellant to present his or her case and may call on a representative of the committee referred to in rule 5 to present the views of that committee.
- 10. The appeal committee must consider all evidence so presented and come to a decision by majority vote, which decision shall have the status of a recommendation. If there is an equality of votes the chairman has a casting vote.
  - (1) The chief executive officer must, without delay, submit the recommendation of the appeal committee to the Council for decision at its next scheduled meeting.
    - (2) If such meeting is not scheduled to take place within 60 days of receipt of the appeal, the chief executive officer must, in consultation with the president of the Council, convene a special meeting of the Council as soon as is practicable.
- 12. The Council may, in terms of section 24(2) of the Act, confirm, vary or revoke the recommendation of the appeal committee, or come to its own decision. The chief executive officer must notify the appellant of its decision and provide him or her with adequate reasons for its decision.
- 13. The notification referred to in paragraph 12 must contain an advice to the appellant that he or she may appeal against the decision to the Council for the Built Environment in terms of section 21 of the Council for the Built Environment Act, 2000.




