HIGHER EDUCATION ACT 101 OF 1997

UNIVERSITY OF PORT ELIZABETH AMENDMENT TO THE STATUTE

The Council of the University of Port Elizabeth has, with the approval of the Minister of Education, under section 32 of the Higher Education Act, 1997 (Act No. 101 of 1997) as amended, made the amendments of the Statute set out in the Schedule hereto.

- 1. In the Schedule, unless the context otherwise indicates, the expression "the Statute" means the Statute of the University of Port Elizabeth promulgated by Government Notice No. R. 766 of 28 May 1965, as amended by Government Notices, R. 27 of 7 January 1966, R. 1904 of 2 December 1966, R. 1629 of 20 September 1968, R. 554 of 10 April 1970, R. 890 of 28 May 1971, R. 1645 of 15 September 1972, R. 273 of 23 February 1973, R. 235 of 13 February 1976, R. 552 of 7 April 1977, R. 829 of 20 April 1979, R. 857 of 24 April 1981, R. 1159 of 18 June 1982, R. 1662 of 6 August 1982, R. 1274 of 17 June 1983, R. 1178 of 30 May 1985, R. 1032 of 8 May 1987, R. 2036 of 7 October 1988, R. 1257 of 8 May 1992, R. 225 of 5 February 1997, No. 787 of 18 June 1999 and No. 725 of 23 May 2002.
- 2. Paragraph 6 of the Statute is amended by the substitution of paragraph 6A(1) of the following paragraph:

"Council of University

6A. (1) The council of the University consists offour persons appointed by the Minister;

(b) [two] one person[s] elected by the donors;

- one person appointed by the local authority of the city of Port Elizabeth;
- (d) one person elected by the local authorities in the University's student feeder area, but excluding the local authority of the city of Port Elizabeth;
- (e) [four] two persons elected by the secondary schools;

(f) one person elected by organised business;

(g) one person elected by organised labour;

 (h) one person elected by education-related nongovernmental and other organisation;

- the principal, the vice-principal or vice-principals and (i) the registrar of the University by virtue of his, her or their office:
- three members of the senate who must be professors of (i) the University, but excluding associate professors, extraordinary professors and honorary professors, elected by the senate;

two academic employees of the University, elected by (k) the academic employees;

two non-academic employees of the University, elected (1) by the non-academic employees:

two students of the University elected by the students' (m) representative council:

[four] three persons elected by the alumni association: (n) Provided that at least two such persons shall be alumni of the University; and

not more than three other persons appointed by the (0) council to make the composition of the council representative of the community served by the University, or because they have appropriate knowledge and experience of matters relating to the aims and objectives of the University.".

Transitional arrangement

A person who on 31 October 2003 serves as an appointed or elected member of the council shall continue to serve on the council in terms of respectively paragraphs 6A(1)(a), 6A(1)(b), 6A(1)(c), 6A(1)(d), 6A(1)(e), 6A(1)(f), 6A(1)(g), 6A(1)(h), 6A(l)(j), 6A(l)(m), 6A(l)(n), or 6A(l)(o) of the Statute as hereby amended until the day before the Interim Council takes office.
