I, Alexander Erwin, Minister of Trade and Industry hereby publish, in terms of section 12G(16)d of the Income Tax Act, 1962 (Act 58 of 1962) as amended (hereinafter referred to as the Act), particulars of an application received for approval of a strategic industrial project under section 12G of the Act and the Regulations promulgated in the Government Gazette No. 22848 of 21 November 2001.

1. PARTICULARS OF APPLICANT

1.1 Name of applicant: Metal Box SA – Nampak Glass Division

1.2 Metal Box SA – Nampak Glass Division is a new project that will entail building a new technology furnace with an additional single/double gob injection system (IS). The technology will enable the production of larger and more complex speciality bottles. An additional packaging line will be added to process the increased production. The project will invest a total R 195 500 000, with value of qualifying industrial assets equal to R 178 533 854. The project is classifiable under SIC code 34112 and HSC code 7010.92.90.

- 1.7 Metal Box SA Limited – Nampak Glass Division was awarded 5 points and afforded a qualifying status. The approved amount of additional industrial investment allowance in respect of industrial assets to be used for Metal Box SA Limited – Nampak Glass division is R89 266 927 (eighty-nine million, two hundred and sixty-six thousands, nine-hundred and twenty seven rands only), 50% of R178 533 854, the cost of qualifying assets.
- 1.8 Potential national revenue to be forgone by virtue of deduction of the approved allowance for Metal Box SA Limited – Nampak Glass Division will be R26 780 078.
- 1.9 Metal Box SA Limited – Nampak Glass Division is expected to create 50 direct and 25 indirect jobs during the specified period.


1.8 Potential national revenue to be forgone by virtue of deduction of the approved allowance for Nampak Metal Packaging EOLE Project will be R23 867 770.


2. SUMMARY OF EVALUATION PROCESS

On 26 August 2003, I as the Minister of Trade and Industry endorsed the recommendation of the Strategic Industrial Projects Adjudication Committee meeting of 14 August 2003 not to approve the application of Norcros SA (Pty) Ltd as a Strategic Industrial Project (SIP) in terms of Section 12G of the Income Tax Act (Act No. 58 of 1962), as amended and the relevant Regulations. The project failed to comply with the mandatory requirement on industrial assets as contemplated in the Act and Regulation. Norcros is a turnkey project and has contracted for assets prior to the SIP approval. The industrial assets were also on site and in the republic prior to the SIP approval.
