INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA

APPLICATION TO AMEND THE COMMERCIAL SOUND BROADCASTING LICENCE OF RADIO ORANJE (PTY) LTD (OFM)

The Independent Communications Authority of South Africa hereby gives notice in accordance with the provisions of section 52(2) of the Independent Broadcasting Authority Act 153 of 1993 (hereinafter "the Act"), as amended, that an application have been received in accordance with the provisions of section 52(1)(C) of the Act, to amend to the technical specifications for the commercial sound broadcasting licence of Radio Oranje (Pty) Ltd. The amendments if granted would result in the following:

- The reactivation of two of the transmitters upon which OFM originally broadcast, namely Boesmanskop and Springfontein at the transmitter power 0.25 kW and 0.5kW, yielding 5.5 kW and 5kW effective radiated power ("ERP") respectively;
- The establishment of an additional OFM transmitter at Sasolburg in the Free State at the transmitter power of 0.25 kW, yielding 0.5 kW ERP; and
- 3. The reduction of transmitter power at two of its existing transmitters; namely
 - 3.1 Christiana: transmitter power to be reduced from 1 kW to 0.5kW reducing the ERP from 11 kW to 5.5 kW; and
 - 3.2 Ladybrand: transmitter power to be reduced from 1 kW to 0.25 kW reducing the ERP from 10 kW to 2.5 kW.

The effective date of the proposed amendments would, if granted, be the date on which the Authority's decision thereon is published.
