ACT

To amend the National Small Business Act, 1996, so as to repeal all provisions pertaining to the National Small Business Council; to empower the Minister to facilitate and establish an Advisory Body to represent the interests of small business; to make the Public Finance Management Act, 1999, applicable to the Agency; to make further provision in respect of the functions of the Agency; to do away with the requirement of calling for nominations for directors of the Board by notice in the *Gazette*; to repeal the provisions pertaining to alternate directors; and to substitute the Schedule to that Act, in order to reflect the current economic position; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 102 of 1996

1. Section 1 of the National Small Business Act, 1996 (hereinafter referred to as the principal Act), is hereby amended by the deletion of the definitions of “constitution of the Council”, “Council”, “National Co-ordinator” and “provincial council”. 5

Substitution of Chapter 2 of Act 102 of 1996

2. The following Chapter is hereby substituted for Chapter 2 of the principal Act:

“CHAPTER 2

Minister’s power to facilitate and establish Advisory Body 10

Minister’s power to facilitate and establish Advisory Body

2. The Minister must, within a reasonable time, facilitate a process aimed at the establishment of an Advisory Body to represent and promote the interests of small business as contemplated in the National Strategy for the Development and Promotion of Small Business in South Africa referred to in the definition of “National Small Business Support Strategy” in section 1. 15

Tot wysiging van die Nasionale Kleinsakewet, 1996, ten einde alle bepalings met betrekking tot die Nasionale Kleinsakeraad te herroep; die Minister te magtig om 'n Adviesliggaam te faciliteer en in te stel om die belang van kleinsake te verteenwoordig; die Wet op Openbare Finansiële Bestuur, 1999, op die Agentskap van toepassing te maak; verder voorsiening te maak ten opsigte van die werksaamhede van die Agentskap; die vereiste vir die aanvra van nominasies vir direkteure van die Direksie by kennisgewing in die Staatskoerant te skrap; die bepalings rakende alternatiewe direkteure te herroep; en die Bylae by daardie Wet te vervang ten einde die heersende ekonomiese posisie te reflekter; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:

Wysiging van artikel 1 van Wet 102 van 1996

1. Artikel 1 van die Nasionale Kleinsakewet, 1996 (hierna die Hoofwet genoem), word hierby gewysig deur die omskrywings van "konstitusie van die Raad", "Nasionale Koördineerde", "provinsiale raad" en "Raad" te skrap.

Vervanging van Hoofstuk 2 van Wet 102 van 1996

2. Hoofstuk 2 van die Hoofwet word hierby deur die volgende Hoofstuk vervang:

"HOOFSTUK 2

10 *Minister se bevoegdheid om Adviesliggaam te faciliteer en in te stel*

Minister se bevoegdheid om adviesliggaam te faciliteer en in te stel

2. Die Minister moet, binne 'n redelike tydperk, 'n proses faciliteer ten einde 'n Adviesliggaam in te stel om die belang van kleinsake te verteenwoordig en te bevorder soos beoog in die "National Strategy for the Development and Promotion of Small Business in South Africa", soos vermeld in die woordomskrywing van "Nasionale Kleinsakesteunstrategie" in artikel 1.

Minister's duty to determine Constitution of Advisory Body

- 3.** (1) The Minister must through an open and transparent process of consultation determine a constitution for the Advisory Body referred to in section 2. 5
- (2) The constitution of the Advisory Body must—
- (a) in general provide for—
 - (i) the composition of the Advisory Body;
 - (ii) the quorum and meetings of the Advisory Body;
 - (iii) the procedure for the functioning of the Advisory Body;
 - (iv) interaction with Parliament, the Department of Trade and Industry and statutory bodies; and
 - (v) any other matter that may be necessary to facilitate the proceedings, activities or business of the Advisory Body; and
 - (b) specifically require the Advisory Body to advise the Minister on—
 - (i) strategies to address identified market failures affecting the sector;
 - (ii) the impact of current and new legislation on small business;
 - (iii) national standards pertaining to small business development and regulation;
 - (iv) measures to ensure the creation of physical business infrastructure through viable business sites;
 - (v) the development of skills in all aspects of running a business;
 - (vi) steps to be taken to create access for small business into value chains;
 - (vii) constraints affecting the viability of the small business community;
 - (viii) methods to liaise with the small business community to identify their needs;
 - (ix) methods to monitor and influence the provision of support services to the small business sector; and
 - (x) any other matter that the Minister may deem appropriate.”. 30

Amendment of section 9 of Act 102 of 1996

- 3.** Section 9 of the principal Act is hereby amended by the addition of the following subsection, the existing section becoming subsection (1): 35
- “(2) The Public Finance Management Act, 1999 (Act No. 1 of 1999), applies to the Agency.”.

Amendment of section 10 of Act 102 of 1996

- 4.** Section 10 of the principal Act is hereby amended—
- (a) by the substitution in subsection (1) for paragraph (a) of the following paragraph: 40

“(a) to expand, co-ordinate and monitor the provision of training, advice and counselling [and any other non-financial services] to small business in accordance with the National Small Business Support Strategy;”;
 - (b) by the substitution in subsection (1) (c) for the words preceding subparagraph (i) of the following words: 45

“to consult with any organ of government, the [Council] Advisory Body or a service provider in order to—”;
 - (c) by the substitution in subsection (1) for paragraph (d) of the following paragraph: 50

“(d) to facilitate and co-ordinate research relating to support programmes by the Agency.”; and
 - (d) by the addition in subsection (2) to paragraph (b) of the word “and” and the deletion of paragraph (c). 55

Minister se plig om Konstitusie vir Adviesliggaam te bepaal

- 3.** (1) Die Minister moet deur 'n oop en deursigtige proses van raadpleging 'n konstitusie vir die Adviesliggaam in artikel 2 vermeld, bepaal.
- (2) Die konstitusie van die Adviesliggaam moet—
- (a) in die algemeen voorsiening maak vir—
 - (i) die samestelling van die Adviesliggaam;
 - (ii) die kworum van die vergaderings van die Adviesliggaam;
 - (iii) die procedure vir die funksionering van die Adviesliggaam;
 - (iv) interaksie met die Parlement, die Departement van Handel en Nywerheid en statutêre liggame; en
 - (v) enige ander aangeleentheid wat nodig mag wees om die verrigtinge, aktiwiteite en werksaamhede van die Adviesliggaam te faciliteer; en
 - (b) in besonder van die Adviesliggaam vereis om die Minister te adviseer oor—
 - (i) strategieë om geïdentifiseerde markmislukkings wat die sektor affekteer, aan te spreek;
 - (ii) die impak van heersende en nuwe wetgewing op kleinsake;
 - (iii) nasionale standarde met betrekking tot ontwikkeling en regulering van kleinsake;
 - (iv) maatreëls om die skepping van fisiese besigheidsinfrastruktuur deur lewensvatbare besigheidspersonele te verseker;
 - (v) die ontwikkeling van vaardighede in alle aspekte van die dryf van 'n besigheid;
 - (vi) stappe wat gedoen moet word om toegang vir kleinsake in waardekettings te skep;
 - (vii) beletsel wat die lewensvatbaarheid van die kleinsakegemeenskap belemmer;
 - (viii) metodes om met die kleinsakegemeenskap te raadpleeg om hul behoeftes te identifiseer;
 - (ix) metodes om die voorsiening van ondersteuningsdienste aan die kleinsakesektor te moniteer en te beïnvloed; en
 - (x) enige ander aangeleentheid wat die Minister wenslik mag ag.”.

35 Wysiging van artikel 9 van Wet 102 van 1996

3. Artikel 9 van die Hoofwet word hierby gewysig deur die volgende subartikel by te voeg, terwyl die bestaande subartikel subartikel (1) word:

“(2) Die Wet op Openbare Finansiële Bestuur, 1999 (Wet No. 1 van 1999), is op die Agentskap van toepassing.”.

40 Wysiging van artikel 10 van Wet 102 van 1996

4. Artikel 10 van die Hoofwet word hierby gewysig—

- (a) deur paragraaf (a) van subartikel (1) deur die volgende paragraaf te vervang:

“(a) om die lewering van opleiding, advies[,] en voorligting [en enige ander nie-finansiële dienste] aan kleinsake ooreenkomsdig die Nasionale Kleinsakesteunstrategie uit te brei, te koördineer en te moniteer;”;
- (b) deur in subartikel (1)(c) die woorde wat subparagraph (1) voorafgaan, deur die volgende woorde te vervang:

“om oorleg te pleeg met enige regeringsorgaan, die [Raad] Adviesliggaam of 'n diensverskaffer ten einde—”;
- (c) deur paragraaf (d) van subartikel (1) deur die volgende paragraaf te vervang:

“(d) die fasilitering en koördinering van navorsing met betrekking tot die ondersteuningsprogramme van die Agentskap.”; en
- (d) deur in subartikel (2) die woorde “en” by paragraaf (b) te voeg en paragraaf (c) te skrap.

Amendment of section 11 of Act 102 of 1996

5. Section 11 of the principal Act is hereby amended—

(a) by the substitution in subsection (3) for paragraph (a) of the following paragraph:

“(a) The Minister must, by notice in [the **Gazette** and in] two newspapers which have general circulation throughout the national territory of the Republic, invite nominations for directors to the Board referred to in subsection (1)(a) and (b).”;

(b) by the deletion of subsection (4); and

(c) by the substitution in subsection (6) for paragraph (a) of the following paragraph:

“(a) The Minister, with the concurrence of the Minister of Finance, determines the remuneration and allowances of directors [, **alternate directors and co-opted directors of the Board**] who are not in the full-time service of the State.”.

Amendment of section 19 of Act 102 of 1996

6. Section 19 of the principal Act is hereby amended—

(a) by the substitution in subsection (1) for paragraph (a) of the following paragraph:

“(a) As soon as practicable after the end of every financial year the **[Council] Advisory Body** and the Agency must each compile a report on their respective activities during that year.”;

(b) by the substitution for subsection (2) of the following subsection:

“(2) The **[Council] Advisory Body** and the Agency must furnish the Minister with any such other reports as the Minister may request.”;

(c) by the substitution in subsection (3) for paragraph (a) of the following subsection:

“(a) particulars of the work performed by the Agency and **[Council] Advisory Body** and of progress achieved in furtherance of the objects of the National Small Business Support Strategy;”; and

(d) by the substitution for the second subsection (3) of the following subsection:

“[(3)] (4) The Director-General must submit the Annual Review of Small Business to the Minister before the end of **[February]** June of each year and the Minister must table it in Parliament.”.

8. The following long title is hereby substituted for the long title to the principal Act:

“To provide for the establishment of the **National Small Business Council** Advisory Body and the Ntsika Enterprise Promotion Agency; [and] to provide guidelines for organs of state in order to promote small business in the Republic; and to provide for matters incidental thereto.”.

9. This Act is called the National Small Business Amendment Act, 2003.

- 15 **6.** Artikel 19 van die Hoofwet word hierby gewysig—
 (a) deur paragraaf (a) van subartikel (1) deur die volgende paragraaf te vervang:
 “(a) So gou doenlik na die einde van elke boekjaar moet die [Raad] Adviesliggaam en die Agentskap elk 'n verslag oor hulle onderskeie aktiwiteite gedurende daardie jaar opstel.”;
- 20 (b) deur subartikel (2) deur die volgende subartikel te vervang:
 “(2) Die [Raad] Adviesliggaam en die Agentskap moet die Minister van die ander verslae voorsien wat die Minister versoek.”;
- 25 (c) deur paragraaf (a) van subartikel (3) deur die volgende paragraaf te vervang:
 “(a) besonderhede van die werk deur die Agentskap en die [Raad] Adviesliggaam gedoen en van vordering gemaak in die bevordering van die oogmerke van die Nasionale Kleinsakesteunstrategie;”; en
- 30 (d) deur die tweede subartikel (3) deur die volgende subartikel te vervang:
 “[(3)] (4) Die Direkteur-generaal moet die Jaarlikse Kleinsakeoorsig voor die einde van [Februarie] Junie van elke jaar aan die Minister voorlê en die Minister moet dit in die Parlement ter tafel lê.”.

 “Om voorsiening te maak vir die instelling van die [Nasionale Kleinsakeraad] Adviesliggaam en die Ntsika-ondernemingontwikkelingsagentskap; [en] om riglyne vir staatsorgane te verskaf ten einde kleinsake in die Republiek te bevorder; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.”.
