ESTABLISHMENT OF THE INKOMATI CATCHMENT MANAGEMENT AGENCY, IN THE PROVINCE OF MPUMALANGA, SOUTHERN PART OF THE LIMPOPO PROVINCE AND THE NORTHERN PART OF THE KINGDOM OF SWAZILAND, WATER MANAGEMENT AREA NUMBER 5

I, Ronald Kasrils, Minister of Water Affairs and Forestry, hereby in terms of section 78(1) of the National Water Act, 1998 (Act No 36 of 1998), declare that-

- (a) the Inkomati Catchment Management Agency is established;
- (b) the Catchment Management Agency's name is the Inkomati Catchment Management Agency;
- (c) the area of operation of the Inkomati Catchment Management Agency includes all properties in respect of which any person is entitled to use water by virtue of entitlements in terms of section 22(1) of the Act from –
 - (i) the Sabie-Sand-, Crocodile (East)-, Komati River-, Nwaswitsontso- and Nwanedzi Catchments (Primary drainage region X); and
 - (ii) any other water resource situated outside the area described in paragraph (c)(i) above, which water resource and accompanying area the Department of Water Affairs and Forestry or the responsible authority may require the Inkomati Catchment Management Agency to control,

which is situated in the Water Management Area number 5 in the Province of Mpumalanga, southern part of the Limpopo Province and the northern part of the Kingdom of Swaziland; and

- (d) the proposal of the Inkomati Catchment Management Agency has been approved.

Ek, Ronald Kasrils, Minister van Waterwese en Bosbou, verklaar hiermee kragtens artikel 78(1) van die Nasionale Waterwet, 1998 (Wet No 36 van 1998), dat-

- (a) die Inkomati Opvanggebiedbestuursagentskap gestig is;
- (b) die Opvanggebiedbestuursagentskap as die Inkomati Opvanggebiedbestuursagentskap bekend sal staan;
- (c) die bedryfsgebied van die Inkomati Opvanggebiedbestuursagentskap alle eiendomme insluit ten opsigte waarvan enige persoon kragtens artikel 22(1) van die Wet die gebruiksreg het op water vanuit –
 - (i) die Sabie-Sand-, Krokodil (Oos)-, Komatirivier-, Nwaswitsontso- en Nwanedzi opvanggebiede (Primêre dreineringsgebied X); en
 - (ii) enige ander waterbron geleë buite die gebied in paragraaf (c)(i) beskryf, welke waterbron en gepaardgaande gebied deur die Departement van Waterwese en Bosbou of deur 'n verantwoordelike gesag vereis mag word om deur die Opvanggebiedbestuursagentskap beheer te word,

wat in die waterbestuursarea nommer 5 in die provinsie van Mpumalanga, die suidelike deel van die Limpopo provinsie en die noordelike deel van die Koninkryk van Swaziland geleë is; en

- (d) die voorstel vir die Inkomati Opvanggebiedbestuursagentskap goedgekeur is.
