**GENERAL NOTICE****NOTICE 1086 OF 2004****INDEPENDENT COMMUNICATIONS AUTHORITY OF SOUTH AFRICA****APPLICATION FOR THE EXTENSION OF KAYA FM'S COVERAGE AND  
AMENDMENT OF JACARANDA FM (PTY) LIMITED'S CONTROLLING STRUCTURE**

1. The Independent Communications Authority of South Africa hereby gives notice in terms of section 41(6) of the Independent Broadcasting Authority Act (IBA), 153 of 1993 that it has received in terms of section 52(1) (c) of the IBA Act as applications to increase KAYA FM's coverage area and to amend Jacaranda fm's controlling structure.

**Schedule**

2. KAYA FM has applied to increase its coverage area by requesting council of the Authority to approve one of one of the 3 options Listed in order of the applicant's preference:

**2.1 Option 1**

The establishment of additional transmitters at the following sites for the following frequencies:

- 2.1.5 Nelspruit, 99.43 MHz
- 2.1.6 Nylstroom, 89.7 MHz
- 2.1.7 Potgietersrus, 89.7MHz
- 2.1.8 Pretoria, 98.9 MHz
- 2.1.9 Rustenburg, 97.4 MHz
- 2.1.10 Thabazimbi, 97.4 MHz
- 2.1.11 Tzaneen, 97.6 MHz
- 2.1.12 Welverdiend, 103.7 MHz

## 2.2 Option 2

By establishing additional KAYA FM transmitters at the following sites and for the listed frequencies:

- 2.2.1 Heidelberg, 89.9 MHz
- 2.2.2 Nylstroom, 99.4 MHz
- 2.2.3 Pretoria, 98.9MHz
- 2.2.4 Rustenburg, 90.7 MHz
- 2.2.5 Thabazimbi, 97.4 MHz
- 2.2.6 Welverdiend, at the transmitter power 1Kw YIELDING 20Kw ERP.

## 2.3 Option 3

Establish additional KAYA FM transmitters at the following sites, for the listed frequencies:

- 2.3.1 Pretoria, 98.9 MHz
- 2.3.2 Heidelberg, 89.9 MHz
- 2.3.3 Welverdiend, at the transmitter power 1kW yielding 20Kw ERP.

3. Jacaranda FM has applied to amend its controlling structure.

3.1 The licensee's current shareholding structure is as follows:

- 3.1.1 New Africa Broadcasting (Pty) Limited ("NAB") 42.5%. NAIL hold 87.5% of the shares in NAB resulting in NAIL directly holding 37.2% of the Licensee
- 3.1.2 Naledi Media Investment Holdings (Pty) Limited ("Naledi") 42.5%. Kagiso Media Limited ("Kagiso Media") holds 100% of the issued shares in Naledi resulting in Kagiso Media holding 42.5% of the Licensee's shares.
- 3.1.3 Lagardere Active Radio International SA ("LARI")
