ACT

To amend the Electoral Commission Act, 1996, so as to authorise the President to extend the term of office of a member of the Commission; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 7 of Act 51 of 1996

1. Section 7 of the Electoral Commission Act, 1996, is hereby amended by the substitution for subsection (1) of the following subsection: 5

“(1) The term of office of a member of the Commission is seven years unless—

(a) he or she resigns or dies at an earlier date[, or];

(b) he or she is removed from office in terms of subsection (3); or

(c) the President, on the recommendation of the National Assembly, extends the member’s term of office for a specified period.” 10

Short title

2. This Act is called the Electoral Commission Amendment Act, 2004.

WET

Tot wysiging van die Wet op die Verkiesingskommissie, 1996, ten einde die President te magtig om die ampstermyn van 'n lid van die Kommissie te verleng; en om voorsiening te maak vir aangeleenthede wat daarmee verband hou.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 7 van Wet 51 van 1996

1. Artikel 7 van die Wet op die Verkiesingskommissie, 1996, word hierby gewysig deur subartikel (1) deur die volgende subartikel te vervang: 5

“(1) Die ampstermyn van 'n lid van die Kommissie is sewe jaar tensy—

(a) hy of sy bedank of vroeër te sterwe kom **[of]**;

(b) hy of sy ingevolge subartikel (3) van sy of haar amp onthef word; of

(c) die President, op die aanbeveling van die Nasionale Vergadering, die lid se ampstermyn vir 'n vermelde tydperk verleng.” 10
