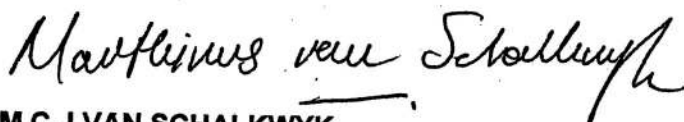

Persons nominated must be suitably qualified:

- To develop policies for the Weather Service and to advise the Minister on matters relating to weather-related and climate-related research programmes, technological development, service delivery to clients, marketing of services, international co-operation and the application of meteorology in weather sensitive industries.

Successful candidates will be appointed in their personal capacities. Appointments are made on a part-time basis for a period of three years only. Members are eligible for another final term of three years.

Members of the board are paid such remuneration and allowances as the Minister with the concurrence of the Minister of Finance may determine.

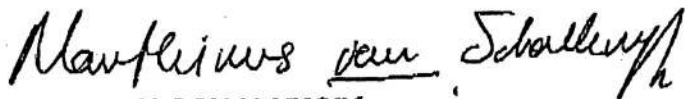
