#### **LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, 2003 EXEMPTIONS FROM SUPPLY CHAIN MANAGEMENT PROVISIONS**

---

The Minister of Finance has, in terms of section 177 (1) (b) of the Local Government: Municipal Finance Management Act, 2003 (Act No. 56 of 2003), exempted all municipalities and municipal entities from or in respect to the provisions of the Act as set out in the Schedule hereto to the extent that those provisions are applicable to the different classifications of municipalities and municipal entities.

#### **SCHEDULE**

All municipalities and municipal entities are exempted from or in respect of the following provisions of the Local Government: Municipal Finance Management Act, 2003 (Act No. 56 of 2003), until **30 June 2005**:

Section 62 (1) (f) (iv); and  
Sections 110 to and including 116.

AMENDMENT OF GOVERNMENT NOTICE No. 773 DATED 1 JULY 2004**

The Minister of Finance has, in terms of section 177 (1) of the Local Government: Municipal Finance Management Act, 2003 (Act No. 56 of 2003), amended the Government Notice No. 773 dated 1 July 2004 as set out in the Schedule hereto.

This notice takes effect on **1 December 2004**.

**SCHEDULE**

1. Clause 5 of the Schedule to Government Notice No. 773 dated 1 July 2004 is hereby amended by –

- (a) the substitution in subclause (2) for the expression “section 62 (1) (c) and (f)” of the expression “section 62 (1) (c) and (f) (i), (ii) and (iii)”;
- (b) the substitution in subclause (2) for the expression “sections 75, 111 and 112” of the expression “section 75”; and
- (c) the deletion in subclause (2) of the expressions “section 115 (1) (a)” and “section 116 (2) (c)”.

2. Clause 6 of the Schedule to Government Notice No. 773 dated 1 July 2004 is hereby amended by –

- (a) the substitution in subclause (2) for the expression “section 62 (1) (c) and (f)” of the expression “section 62 (1) (c) and (f) (i), (ii) and (iii)”;
  - (b) the substitution in subclause (2) for the expression “sections 75, 111 and 112” of the expression “section 75”; and
  - (c) the deletion in subclause (2) of the expressions “section 115 (1) (a)” and “section 116 (2) (c)”.
