

## NATIONAL CURRICULUM STATEMENT FOR GRADES 10-12 (GENERAL) – 2<sup>ND</sup> PHASE: CALL FOR WRITTEN SUBMISSIONS FROM STAKEHOLDER BODIES AND MEMBERS OF THE PUBLIC ON ADDITIONAL SUBJECTS; AGRICULTURAL TECHNOLOGY AND AGRICULTURAL MANAGEMENT PRACTICE

#### 1. INTRODUCTION

On 3 March 2004 the names of persons appointed to serve on various curriculum development structures of the Second Phase of the development of a National Curriculum Statement Grades 10-12 (General) were published by means of a Government Notice No. 285 in the Government Gazette Vol. 465, No. 26119. The aim of the second curriculum development phase is the development of two additional subject statements for Religion Studies and Civil Technology and the review of three technology subjects i.e. Electrical Technology, Engineering Graphics and Design and Mechanical Technology, as part of the National Curriculum Statement for Grades 10-12 (General) – Phase 2.

The mandate of the Ministerial Project Committee was later expanded to include two agricultural subjects namely, Agricultural Technology and Agricultural Management Practice. The names of the Subject Working Group members for Agricultural Technology and Agricultural Management Practices were published in Government Gazette Vol. 471, No. 26767, Government Notice No. 1052 of 15 September 2004.
