Safety in Mines Research Advisory Committee (SIMRAC)
on behalf of
Mine Health and Safety Council (the Council)

Invitation to submit project proposals

SIMRAC, a permanent committee of the Mine Health and Safety Council, was established in terms of the Mine Health and Safety Act (29/1996) to conduct research and surveys regarding, and for the promotion of, health and safety in the South African mining industry. Suitably qualified agencies and/or persons are invited to submit proposals in response to the project specifications in this Notice. In soliciting research projects for the 2005/2006-research programme, the Council has the following goals:

- to indicate the current research needs for research to commence in the 2005/2006 cycle;
- to invite research proposals in response to these defined priority areas of research; and
- to invite applications for postgraduate funding for research which will promote health and safety within the South African mining industry.

A consultative process has resulted in the Council formulating a co-ordinated, long-term health and safety research programme and identifying priority areas for research to commence in the 2005/2006 cycle. Researchers and agencies are invited to submit research proposals for the research projects indicated. Proposed research must be well designed with a detailed methods section, be ethical *and* must have the potential to add to existing knowledge, practice or technology, involve the end users and implement/transfer outputs. Research teams must have the specified skills.

Submission of Proposals

1. Proposals must be submitted in accordance with the prescribed format. **PLEASE NOTE THAT A NEW FORMAT FOR SUBMISSION OF PROPOSALS IS AVAILABLE ON THE SIMRAC WEBSITE www.simrac.co.za FOR THE 2005/6 PROGRAMME.**

3. Proposers are requested to take note of past work in the different thrust areas. (Details are available on website www.simrac.co.za.)
4. The closing time and date for the receipt of the proposals is **12:00 on Monday 16 May 2005**. Late entries will not be considered.

5. A proposal in the correct format can be e-mailed to nwoods@simpross.co.za prior to the closing time and date. Alternatively, two copies of each proposal, in a form suitable for photocopying **plus** a disk or CD with the proposal in MS Word or Rich Text Format, should be deposited in the repository labeled "Proposals" at the Council's offices².
6. The Council may at its sole discretion, decide to recommend the acceptance, rejection or amendment of any proposal and to commission the team to develop the proposal on the basis of which the contract is awarded. The Council shall not furnish any reasons for its decisions regarding proposals.
7. Every proposal accepted by the Council would be subject to a set of Terms and Conditions, which on acceptance of the final detailed proposal will form part of the contract applicable to the project. All prospective proposers should peruse a set of the standard terms and conditions prior to submitting a proposal. A copy of the draft standard terms and conditions can be obtained from Noeleen Woods at telephone 011 358 9180, fax 011 403 1821, e-mail nwoods@simpross.co.za. **PLEASE NOTE THAT THE RESEARCH CONTRACT IS CURRENTLY UNDER REVISION.**
8. In compiling proposals, prospective proposers should provide details of methods, identifiable outputs and estimated costs as indicated.
9. The Council will endeavour to solicit the services of South African organisations to undertake projects, but will consider proposals from overseas-based organisations if expertise, cost considerations and local capacity building components compare favourably.
10. The Council requires full disclosure regarding all subcontracts included in the proposal.
11. Where an output includes a device, mechanism, procedure, or system capable of being applied in the mining environment, a prospective proposer shall include in the proposal an output which suggests how the outputs in question might best be applied in practice. In drafting proposals, all prospective proposers should bear in mind the potential for technology transfer and phasing the project as indicated.
12. Each successful proposer may, during the contract period or shortly after its completion, be required to provide:
 - A competent spokesperson with appropriate materials to make not more than two separate presentations, on an annual basis for the duration of the project, and
 - A technical paper on the project for publication and/or a poster presentation, without additional remuneration or reimbursement of costs.These activities must be detailed and costed within the project.
13. Where relevant, proposers may obtain copies of earlier project reports and other information from the website address or from contacts listed (See paragraph 1 and 2).
14. Proposers are advised that all Council projects should be submitted to language editing and may be subjected to technical and financial audits. Funding for editing and audits should be included in the proposal budget.
15. Proposers should substantiate and cost separately, all proposed travel outside the borders of South Africa in connection with the project, and provide details of all expenses such as travelling and subsistence.

16. All proposed project costs must be expressed in South African Rands. Fluctuations in the exchange rate and purchase of forward cover should be considered when costing the proposal.
17. The Council will take all reasonable steps to ensure that confidentiality of proposals is maintained during the adjudication process. If a proposal is not accepted within the programme, the Council may invite additional proposals on the topic.
18. No unsolicited proposals will be included in the programme for 2005/6.

Objectives of the Council research programme

The **objectives** of the Council in commissioning health and safety research, for both general and commodity-based projects, are to:

- Obtain and evaluate information to establish evidence-based risk assessment, standard setting and health and safety performance measurement;
- Develop techniques or guidelines to prevent, reduce, control or eliminate risks;
- Develop and pilot innovative ideas and procedures, where appropriate, to eliminate, reduce or control risk;
- Obtain information on the extent of work-related ill health;
- Identify, develop and improve sampling and measurement techniques to detect environmental hazards and assess personal exposure;
- Understand the aetiology and identify and evaluate best-practice screening, diagnostic and treatment interventions to reduce the impact of occupational disease;
- Evaluate the effectiveness of control interventions;
- Understand risk perception, attitudes and behaviour related to health and safety and promote best practices in hazard recognition and procedural conformance;
- Empower its statutory committees to formulate policy, expedite research aimed at improving the health and safety in the South African mining industry; and
- Collaborate with national and international initiatives and research to promote health and safety in the mining industry.

The **criteria** by which proposals will be evaluated include:

- **Added value and impact** – the Council supports research which can contribute significantly to the improvement in the health and safety of South African miners;
- **Value for money** – the Council supports cost-effective research;
- **Innovation** – the Council welcomes new approaches or new areas of focus for research leading to technologies or best practices to improve health and safety;
- **Excellence** – the Council demands excellence, particularly in the methods employed to conduct research, be it quantitative or qualitative, and hence will consider the track record of the proposer/s for expertise and delivery (quality, time and to budget);
- **Use and development of research skills** – the Council requires research teams to possess the skills relevant to the success of the project and also favours projects which assist in developing research capacity, particularly in previously disadvantaged groups;
- **Collaboration** - the Council places a high priority on collaboration between researchers and the "teams of excellence" approach. Thus, the means of soliciting research proposals is intended to stimulate collaboration between centres of excellence and individual experts in order to optimise the use of the Council funding and the research outcomes.

- **Development of key indicators** – the Council recognises the challenge in assessing performance and improvement in health, as opposed to safety, in the mining industry. There is a lack of suitable occupational health (OH) indicators and baseline data. Thus innovative and robust research to develop relevant OH indicators and baseline values will be favourably considered.

The Council's research and implementation programme consists of occupational health and safety, addresses occupational medicine and hygiene, rock engineering, engineering and machinery, behavioural issues and technology transfer processes.

Each proposal must:

- Address only the research topic advertised and this must be specified;
- Be in the format indicated and the template specified using Word or Rich Text format; and
- Be phased as indicated in the project scope.

Adjudication of proposals

1. NATIONAL INSTITUTIONS

With a view to ensuring the long-term existence and development of competency in key areas of mine health and safety related research, at least 50% of the 2005/6 SIMRAC programme will be allocated to National and Tertiary Institutions.

This will provide these institutions with opportunities to:

- Maintain their current health and safety related research capacity.
- Build new research capacity.
- Remain at the forefront of international research developments related to mine health and safety.

In respect of these institutions, and particularly in respect of the universities, in due course, the basis of the project selection for inclusion within this preferential arrangement will be more specifically related to the areas of expertise that SIMRAC agrees need to be either preserved or developed.

2. BLACK ECONOMIC EMPOWERMENT

- SIMRAC adjudicates the BEE status of the tendering organisations based on progress achieved and planned on the various elements of BEE, taking account of the Code of Practice on Broad-Based Black Economic Empowerment issued by the DTI.
- For this purpose a BEE Questionnaire (Attachment A) should be completed by each supplier/researching agency that does not already have a Scorecard that complies with either the BEE Act or the Mining Charter.
- Please note that the Council will independently verify the BEE credentials of a proposer.
- The MHSC office will develop the appropriate database to monitor progress achieved by relevant organisations and will allow for a more objective consideration of this matter in the future.

3. ADJUDICATION PROCESS

1. Technical Advisory Committee Technical Evaluation:

- The TAC's used the project evaluation score sheet (Attachment B) to evaluate the technical aspects of each proposal
- The proposals were each given a score out of 100 that has been converted to a score out of 90 for the SIMRAC evaluation process
- The proposals with the highest score was recommended for inclusion in the 2005/6 programme

2. BEE Evaluation:

- The proposals were each given a score out of 100 that has been converted to a score out of 10 for the SIMRAC evaluation process
- Commercial Entities will be evaluated against the following criteria and weightings:
 - Ownership - 20%
 - Management - 10%
 - Employment Equity & Skills development – 30%
 - Preferential Procurement – 30%
 - SMME Status – 10%
- National Institutions and Public Entities will be evaluated against the following criteria and weightings:
 - Ownership - 0%
 - Management - 30%
 - Employment Equity & Skills development – 40%
 - Preferential Procurement – 30%

The two scores were added together and the proposal with the highest score was recommended for inclusion in the 2005/6 SIMRAC Programme.

PROPOSED PROJECT SCOPE FOR THE 2005/6 PROGRAMME

Project SIM 05 06 03

Description of risk

Exposure to airborne pollutants associated with clay mining and associated brick-making processes.

Title of research topic

A pilot study to determine the extent, nature, concentration and occupational exposure to airborne pollutants associated with clay mining and the different types of brick-making plants and associated processes.

Primary output/s of research

A concise report (15p) that includes:

1. A summary of typical airborne pollutants associated with clay mining and brick-making.
2. An assessment of the potential impact on the occupational health of mining and factory staff
3. Recommendations for the need for future research, including strategies for improved monitoring and reporting
4. Recommendations on the need and potential for the elimination, control and management of hazards, exposures and pollution.

Motivation

SIMRAC has not initiated any investigation into the possible occupational health and safety hazards associated with clay mines and associated brick-making processes in South Africa. Although the long-term safety performance of clay mines is relatively good, the introduction of the Air Quality Bill (2004) will place stringent environmental management responsibilities on potential polluters, especially coal-fired brickworks. A pilot project of limited scope needs to be undertaken to identify significant hazards and risks associated with clay mining and brick-making and to consider further focused research and intervention, if warranted. During 2002/3, 16 clay mines with associated brickworks, contributed R22 395 to the Mine Safety research levy. The corresponding figures for 2003/4 are: 33 mines and R110 219.

Potential impact of research

Improved understanding of the hazards and the potential to provide information to all stakeholders to assess the risks and formulate action plans, if required.

Scope of research

- 1 Conduct a desktop survey of available local and global literature and summarise the relevant information
- 2 Liaise with the Clay Brick Association to promote co-operation, information and data sourcing.
- 3 Select a representative sample (big and small operations- approximately 8) with a view to conducting site visits, sampling and analysis of airborne pollutants (by an accredited laboratory). If viable, restrict the site visits to the Gauteng region.
- 4 Field ovens, transverse arch and tunnel kilns (coal, gas and oil-fired) must be investigated.

- 5 Compile a preliminary, generic risk assessment and report on the merits of additional analysis to cater for climatic and seasonal influences, coal and clay characteristics, etc.
- 6 Occupational Exposure Limits, Ambient Standards and Emission Standards, as referred to in the relevant legislation, must form the basis of the monitoring and analyses.

Duration and cost

The project should be scheduled to be carried out in approximately 25 days over a period of three months. The envisaged start date is 1 June 2005.

Expenses such as consultancy, traveling, laboratory, documentation and presentation costs must be budgeted for and should not exceed R120 000 (incl. VAT).

Requirements for technology transfer

A reader-friendly report in the prescribed format

A presentation/workshop with industry stakeholders at a central venue

Special skills required from project team

Knowledge of the clay and brick-making industry, relevant legislation, occupational health, risk assessment and research experience.

The Clay Brick Association must be involved with the project and provision must be made within the proposal to formalise their input and guidance. Contact details will be made available to project proposers.





THE SOUTH AFRICAN HUMAN RIGHTS COMMISSIONTERMS OF REFERENCE**PUBLIC INQUIRY INTO EQUALITY AND VOLUNTARY ASSOCIATIONS:**

This public inquiry is the South African Human Rights Commission's (SAHRC) response to complaints pertaining to alleged violation/s of the right to equality of those who find themselves excluded from joining voluntary associations based on an alleged arbitrary or non objective criteria.

A)

Background:

1. In terms of Section 184 (1) of the Constitution of the Republic of South Africa, the SAHRC has a mandate to--

"(a) promote respect for human rights and a culture of human rights;

(b) promote the protection, development and attainment of human rights; and

(c) monitor and assess the observance of human rights in the Republic of South Africa."

2. The SAHRC has the power, in terms of Section 184(2) of the Constitution read with Section 9 of the Human Rights Commission Act No.54 of 1994:

"(a) to investigate and to report on the observance of human rights;

(b) to take steps to secure appropriate redress where human rights have been violated;

(c) ...

(d) ...

3. The Bill of Rights (Chapter 2 of the Constitution) guarantees *inter alia*:-

Section 9 : The right to Equality;

Section 10 : The right to human dignity;

Section 18 : Freedom of association;

Section 30 : The right to use language and culture of choice; and

Section 31 : The rights of cultural, religious and linguistic communities

B)

Definitions:

“Act” refers to Human Rights Commission Act No. 54 of 1994.

“Constitution” refers to the Constitution of the Republic of South Africa, Act 108 of 1996.

“Chairperson” refers to the Chairperson of the Human Rights Commission or any other person designated by him.

“Commission” refers to the Human Rights Commission as established by section 181 of the Constitution.

C)

Terms of Reference:-

- 1 The Terms of Reference for the Inquiry are set out in the Government Gazette as required by the Human Rights Commission Act, 54 of 1994:
 - 1.1 to investigate alleged discriminatory practices whereby people are excluded from joining voluntary associations with others in violation of their protected fundamental rights.
 - 1.2 the Human Rights Commission will consider submissions and hold public hearings to determine:
 - 1.2.1 the constitutionality of voluntary associations;
 - 1.2.2 whether such associations violate, among other rights, the right to equality and human dignity of those excluded from such associations; and
 - 1.2.3 what appropriate relief would be available for the victims of such discriminatory practices.

D)

Rules and Procedures:

1. The investigation and inquiry will be conducted in terms of the rules of procedure promulgated in terms of Section 9(6) of the Human Rights Commission Act No. 54 of 1994 published in Government Gazette Number 17457 of October 1996.

2. The Commission will call for submissions from the public and interested parties including institutions, organisations and individuals on any matters referred to in the terms of reference of this investigation and inquiry.
3. The said submissions shall be lodged with or posted to the offices of the Commission at any of the addresses mentioned below.

If needed, the Legal Department of the Commission will assist persons in formulating the said submissions. The submissions shall be in writing and must disclose the name, address and other contact details of the deponent. Anonymous submissions will not be entertained.

Where, however, the deponent does not wish to have his or her name published, the Commission will respect such a wish together with disclosures made under the cover of the Protected Disclosures Act No. 26 of 2000. Such confidential submissions will be considered however, they will not form the basis of the findings against individuals or institutions.

4. The closing date for the submissions is **10 June 2005**. However, the Head of the Legal Department may at his discretion also consider late submissions.
5. The Commission may furnish any person who has been referred to or likely to be referred to in those submissions, with a copy thereof. Such copy may be accompanied by a written notice requiring such person to:-
 - 5.1 submit a written response to the allegations/submission to the Legal Department of the Commission within 14 days of the delivery of such written notice; and

- 5.2 appear before a panel of the Commission at a public hearing to be held on a date and place to be announced in the Government Gazette, in order to respond to the allegations against him or her.
6. The Commission may invite to the hearing specific individual organisations, institutions and any other interested parties to make documentary and/or oral submissions and testimony at the public hearing. Such testimony shall be given under oath or affirmation.
 7. Pursuant to the provisions of the Act, a panel will preside over the Public Hearing and the Chairperson of the Commission or a person designated by him/her.
 8. The panel may subpoena any person in possession of any information or documents relevant to the hearing to appear before the panel and give testimony.
 9. The person referred to in 5, above, shall be entitled to be represented by his/her legal representative and shall give his/her testimony under oath or affirmation.
 10. At the conclusion of the hearing the panel will make findings and recommendations.
 11. Such findings and recommendation will be made public.
