#### ESTABLISHMENT OF THE MVOTI TO MZIMKULU CATCHMENT MANAGEMENT AGENCY (WATER MANAGEMENT AREA NUMBER 11) IN THE PROVINCE OF KWAZULU NATAL

I, Buyelwa Sonjica, Minister of Water Affairs and Forestry, hereby in terms of section 78(1) of the National Water Act, 1998 (Act No 36 of 1998), declare that-

- (a) the Mvoti to Mzimkulu Catchment Management Agency is established;
- (b) the Catchment Management Agency's name is the Mvoti to Mzimkulu Catchment Management Agency;
- (c) the area of operation of the Mvoti to Mzimkulu Catchment Management Agency which is situated in the Water Management Area Number 11 in the Province of KwaZulu Natal includes all properties in respect of which any person is entitled to use water by virtue of entitlements in terms of section 22(1) of the Act from:
  - i) The Mvoti to Mzimkulu Water Management Area, Number 11, as described in the National Water Resource Strategy, as published on the 28<sup>th</sup> January 2005 in Government Gazette No. 27199, Notice No. 65, and which includes ten tertiary catchments of which the Mvoti, Umgeni, Umkomazi and Umzimkulu are major river systems.
  - ii) Any other water resources situated outside the area described in paragraph (c)(i) above, which water resources and accompanying area the Department of Water Affairs and Forestry or the responsible authority may require the Mvoti to Mzimkulu Catchment Management Agency to control,
- (d) The proposal of the Mvoti to Mzimkulu Catchment Management Agency has been approved.

Ek, Buyelwa Sonjica, Minister van Waterwese en Bosbou, verklaar hierby kragtens artikel 78(1) van die Nasionale Waterwet, 1998 (Wet No. 36 van 1998), dat –

- (a) die Mvoti tot Mzimkulu Opvanggebiedbestuursagentskap ingestel word;
- (b) die Opvanggebiedbestuursagentskap se naam die Mvoti tot Mzimkulu Opvanggebiedbestuursagentskap is;
- (c) die bedryfsgebied van die Mvoti tot Mzimkulu Opvanggebiedbestuursagentskap wat in die Waterbestuursgebied Nommer 11 in die provinsie KwaZulu-Natal geleë is, alle eiendomme omvat ten opsigte waarvan enigiemand geregtig is om water te gebruik uit hoofde van gebruiksregte ingevolge artikel 22(1) van die Wet vanuit –
  - (i) die Mvoti tot Mzimkulu Waterbestuursgebied, No. 11, soos beskryf in die Nasionale Waterhulpbronstrategie wat op 28 Januarie 2005 by Goewermentskennisgewing No. 65 in die Staatskoerant No. 27199 gepubliseer is, en wat tien tersiêre opvanggebiede insluit waarvan die Mvoti, Umgeni, Umkomazi en Umzimkulu die gelangrikste rivierstelsels is;
  - (ii) enige ander waterhulpbronne geleë buite die gebied beskryf in paragraaf (c)(i) hierbo, welke waterhulpbronne en omliggende gebied die Departement van Waterwese en Bosbou of die verantwoordelike owerheid kan vereis dat die Mvoti tot Mzimkulu Opvanggebiedbestuursagentskap moet beheer;
- (d) die voorstel van die Mvoti tot Mzimkulu Opvanggebiedbestuursagentskap goedgekeur is.

- c) Isigungu saseMvoti-Mzimkulu sisendaweni yokuphatha amanzi isiceme seshumi nanye esifundazweni saKwaZulu Natali, ihlanganisa yonke imigcele, ngokuhlonpheki leyo noma ubani onelungelo loku sebenzisa amanzi ngokwesigaba 22(1) yomthetho Sisekelo Wezwelonke Wezamanzi :
  - i) Indawo yokuphatha amanzi yoMvoti-Mzimkulu eyingxene yeShumi nanye yaKwaZulu Natali njengokuchaza kwenqubo yezwelone yamanzi eyashicilewa ngomhlaka 28 January 2005 kusaziso sikahulumeni no. 27199, isaziso no. 65, ethayisele izinkwazi ezinkulu zemifula ezifake phakathi uMvoti, Umgeni, Umkomazi noMzimkulu.
  - ii) Noma imiphi imifula engaphandle kwesiychaze ngaphezu (c)(i) Umnyango Wezamanzi nezamahlathi noma umuphi omunye onegunya angacela isigungu sokusingatha izinkwazi uMvoti-Mzimkulu ukuba ulawule.
- d) Isigungu sokusingatha izinkwaza sase uMvoti-Mzimkulu simukeliwe
