#### NOTICE OF INTENT

#### **NATIONAL ROAD N2 SECTION 9: NOTICE OF INTENTION TO EXTEND THE EXISTING TSITSIKAMMA TOLL ROAD BY DECLARING PART OF THE EXISTING NATIONAL ROAD N2 SECTION 9 TOWARDS THE EAST OF THE EXISTING TOLL ROAD, UP TO THE ELANDS RIVER, AS A TOLL ROAD**

In terms of Section 27 (4) (a) of The South African National Roads Agency Limited and National Roads Act, 1998 (Act No. 7 of 1998), The South African National Roads Agency Limited hereby gives notice of its intention to recommend to the Minister of Transport the declaration of the following National Road section as a toll road:

Portion of National Road N2 Section 9 starting at the end of the existing Tsitsikamma Toll Road, approximately 1 kilometre west of the Elandsbos River, as declared in Government Gazette 9163 of 05 April 1984, from where it continues in an easterly direction along the existing National Road N2 section 9, as declared in Government Gazette 11862 of 12 May 1989 and as amended in Government Gazette 26330 of 07 May 2004, up to the Elands River, roughly 150km west of Port Elizabeth.

The extent of the proposed toll road and the position of the existing Toll Plaza are indicated on the attached key plan that is also available from the Regional Manager listed below.

In terms of Section 27 (4) (a) (i) of the said Act it is hereby declared that the existing plazas will serve the entire toll road and that it is not anticipated to erect other toll plazas, other than re-instating the ramp toll plazas of the existing Tsitsikamma mainline toll plazas.

In terms of Section 27 (4) (a) (ii) of the said Act all interested persons are hereby invited to comment and make written representations, within 30 days from the date of notice, to The South African National Roads Agency Limited, on the proposed declaration. The representations in question are to be addressed to The Regional Manager: Southern Region, The South African National Roads Agency Limited, P.O. Box 27230, Greenacres, Port Elizabeth, 6057.

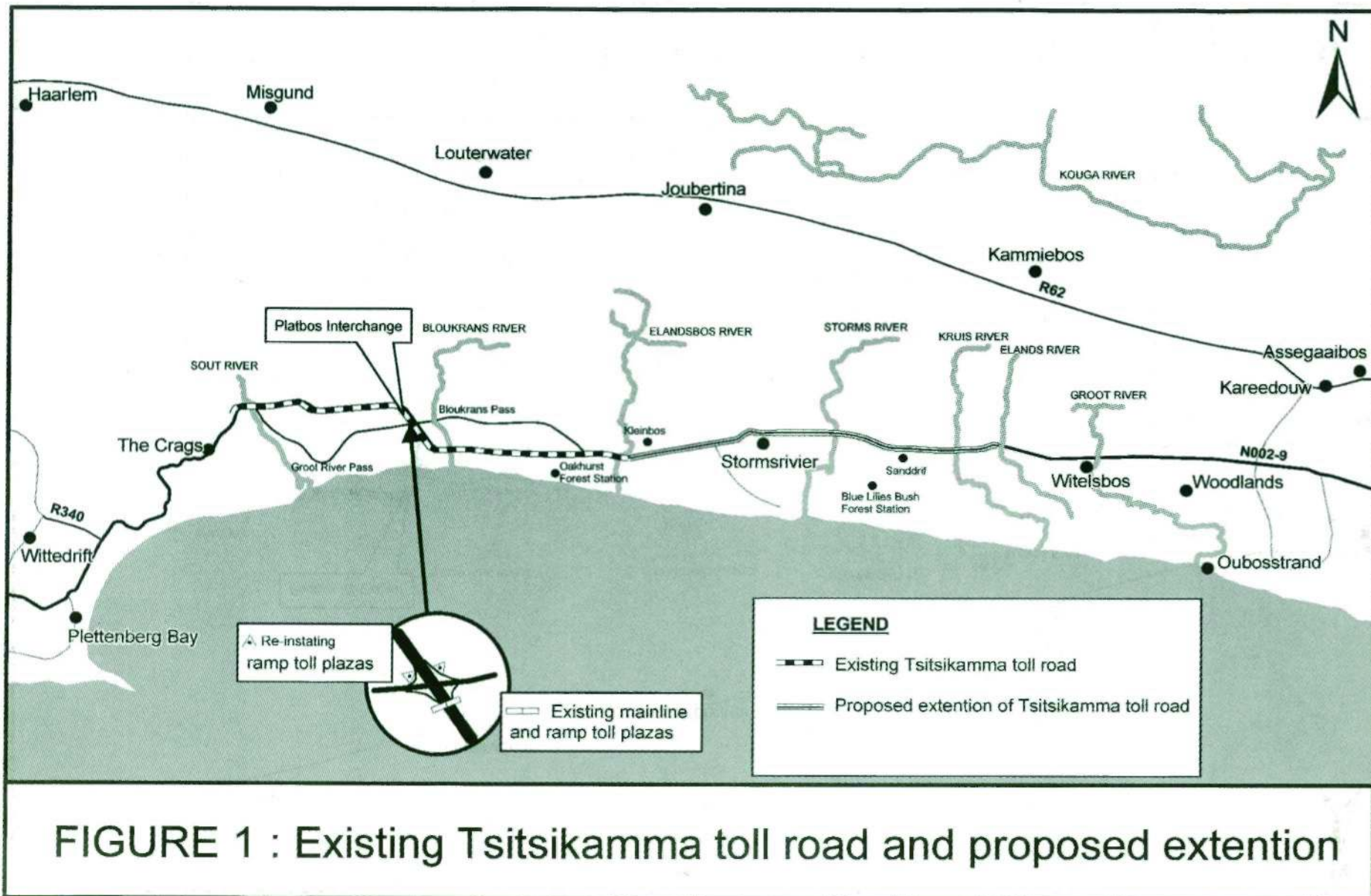
Gedeelte van Nasionale Pad N2 Seksie 9 beginnende by die einde van die bestaande Tsitsikamma Tolpad, ongeveer 1 kilometer wes van die Elandsbosrivier, soos verklaar in Staatskoerant 9163 van 05 April 1984. Van hier volg dit 'n oostelike rigting al langs die bestaande Nasionale Pad N2 Seksie 9, soos verklaar in Staatskoerant 11862 van 12 Mei 1989 en soos gewysig in Staatskoerant 26330 van 07 Mei 2004, tot by die Elandsrivier, ongeveer 150km wes van Port Elizabeth.

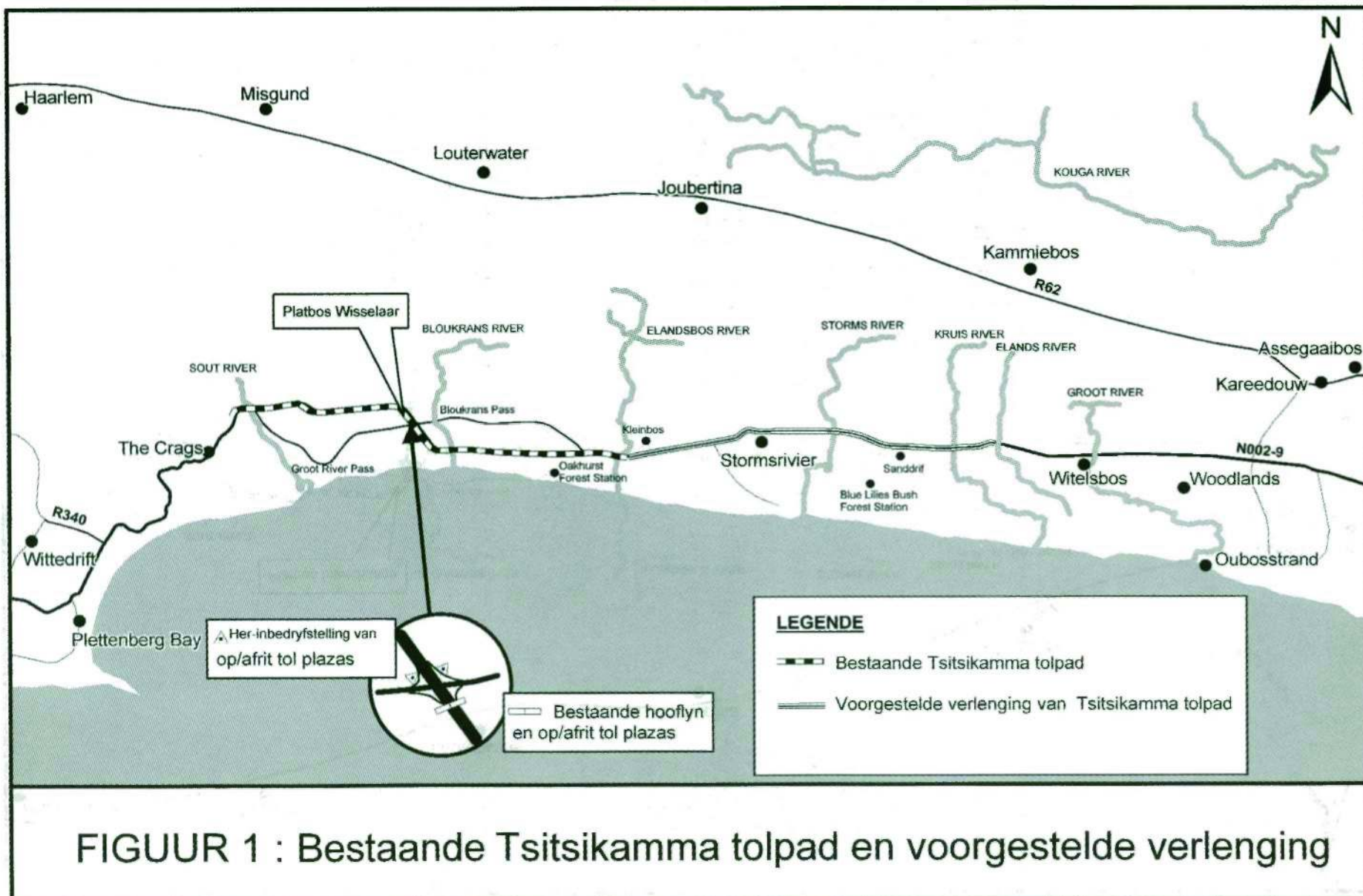
Die lengte van die voorgestelde Tolpad en die ligging van die bestaande Tolplaza word aangedui op die aangehegte sleutelplan wat ook verkrygbaar is vanaf die onderstaande Streekbestuurder.

Ingevolge Artikel 27(4)(a)(i) van die voorgemelde Wet word geen verdere nuwe tolplazas beplan nie, anders as die herinbedryfstelling van die huidige Tsitsikamma hooflyntolplaza se op- en afritplazas, en gevolglik sal bestaande tolplazas die hele gedeelte tolpad bedien.

Ingevolge Artikel 27(4)(a)(ii) van die voorgemelde Wet word alle belanghebbendes uitgenooi om binne dertig (30) dae vanaf die datum van hierdie kennisgewing skriftelike versoë tot die Suid-Afrikaanse Nasionale Padagentskap Beperk in verband met die voorgestelde verklaring te rig. Hierdie versoë moet gerig word aan die Streekbestuurder, Suidelike Streek, Die Suid-Afrikaanse Nasionale Padagentskap Beperk, Posbus 27230, Greenacres, Port Elizabeth, 6057.
