CALL FOR LODGING OF APPLICATIONS FOR THE REGISTRATION OF PRIVATE FURTHER EDUCATION AND TRAINING INSTITUTIONS

I, **Grace Naledi Mandisa Pandor, Minister of Education**, after consultations with the Council of Ministers and the Minister of Finance, hereby call all Private Further Education and Training Institutions to lodge applications for registration in terms of section 25 of the *Further Education and Training Act, 1998 (Act No. 98 of 1998)*.

All Private Further Education and Training Institutions seeking registration must contact the Department of Education on (012) 312-5880/ 5881/ 5263/ 5878 (office hours only) to be supplied with the application forms and schedule of fees or alternatively these may be obtained on the departmental website: <http://www.education.gov.za/FETregistration/applications.xls> The duly completed and signed application forms should reach the Department on or before 30 May 2006. The deadline will allow institutions that are currently not registered in terms of the *Companies Act, 1973 (Act No. 61 of 1973)* to convert their status as required in terms of the Further Education and Training Act.
