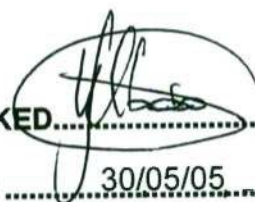

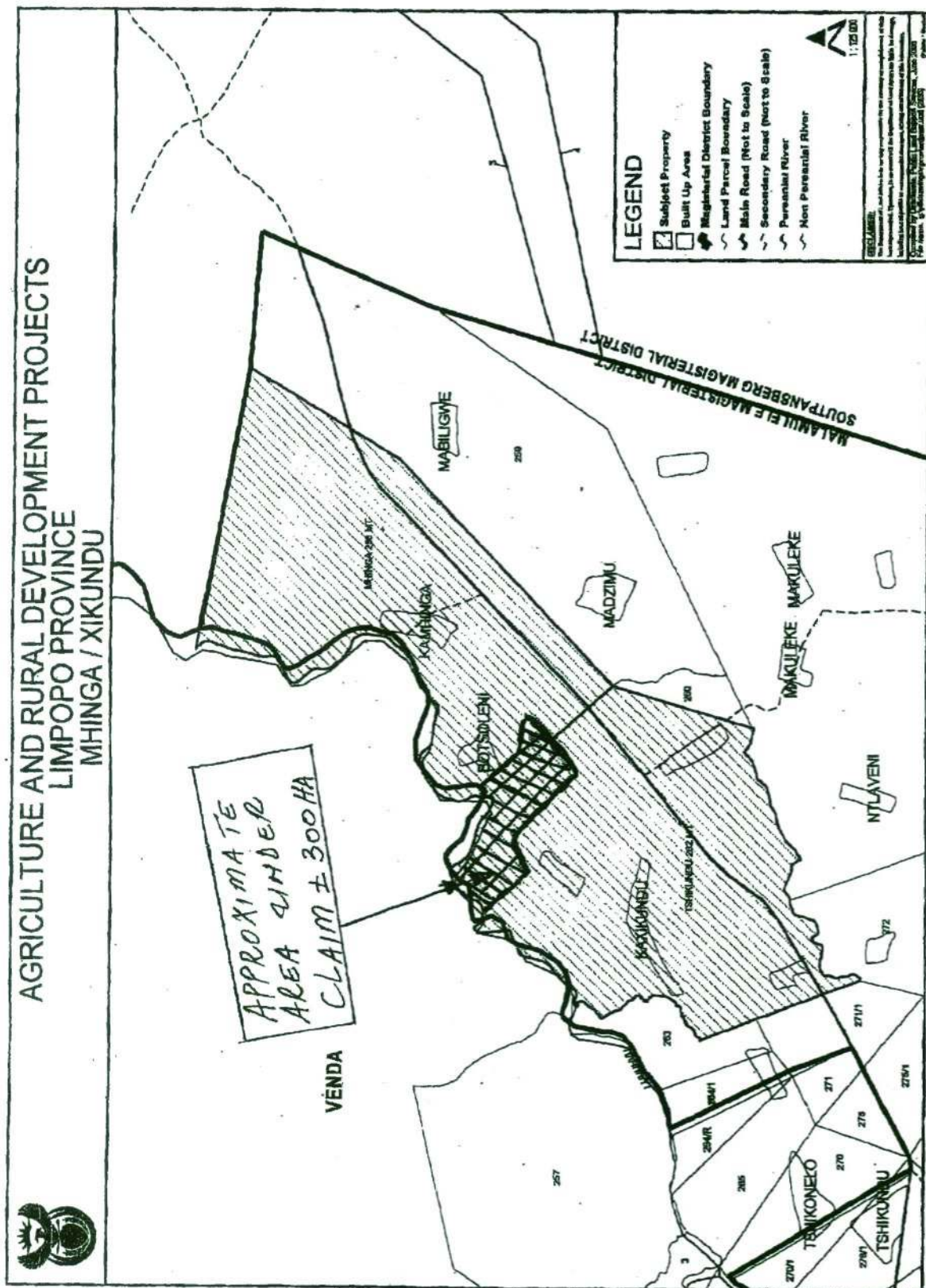

- (1) Notice is hereby given in terms of the provisions of the Regulations relating to the Election of Members of the Professional Board for Radiography and Clinical Technology that an election of one member of such board to serve during the remaining period ending the 1st day of May 2009 is about to be held, as follows:
- (2) Due to the resignation of an elected member, one new member have to be elected.
- (3) Nominations of eligible persons are awaited. Every person whose name appears on the relevant register or registers kept under section 18 of Act 56 of 1974-
 - (a) who has not entered into a composition with the creditors of his or her estate, or whose estate has not been sequestrated;
 - (b) who is not disqualified under the Act from practising his or her profession;
 - (c) who is a South African citizen and is permanently resident in South Africa;
 - (d) who is not a patient as defined in section 1 of the Mental Health Act, 1973; or
 - (e) who has not been convicted of an offence in respect whereof he or she was sentenced to imprisonment without the option of a fine,is eligible for nomination.
- (4) Each candidate must be nominated on a separate nomination form, but any person entitled to vote in the election may sign the nomination forms of any number of candidates NOT exceeding the number to be elected.
- (5) Each nomination form must -
 - (a) state the first names and the surname of the candidate nominated;
 - (b) state the candidate's registered profession and professional category, if any;
 - (c) state the other details of the candidate as required in the nomination form;
 - (d) be signed by two persons whose names appear in the register or registers referred to in paragraph (2) above; and
 - (e) be signed by the person nominated confirming that he or she consents to his or her nomination, while the postal addresses registered with the council of every person so signing, must be appended to his or her signature.
- (6) If the person nominated is unable to sign the nomination form, he or she may inform the returning officer by letter or facsimile transmission that he or she consents to his or her nomination.
- (7) Every nomination form must reach the returning officer, from whom nomination forms may be obtained on application, at the address given below not later than 31 July 2005.
- (8) A deposit of R200 must accompany the nomination.

- (9) Every nomination form in respect of which any of these provisions has not been complied with, or which is not received by the aforesaid date and time at the address given below, will be invalid.

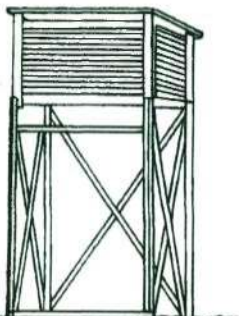
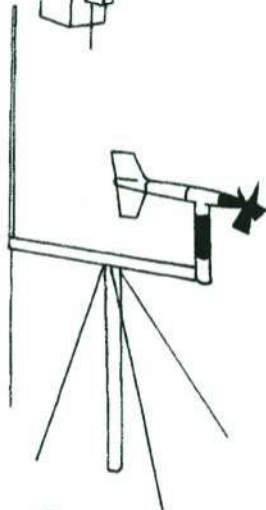
