**ACT**

**To authorise the re-determination of the boundaries of certain cross-boundary municipalities; to amend the Local Government: Cross-boundary Municipalities Act, 2000; and to provide for matters connected therewith.**

**PREAMBLE**

**WHEREAS** the re-determination of the boundaries of cross-boundary municipalities must be authorised with the concurrence of the legislatures of the provinces involved;

**AND WHEREAS** the re-determination of the boundaries of cross-boundary municipalities must be authorised by national legislation;

**B**E IT THEREFORE ENACTED by the Parliament of the Republic of South Africa, as follows:—

**Authorisation of re-determination of boundaries of cross-boundary municipalities**

1. Subject to section 2(a) of the Local Government: Cross-boundary Municipalities Act, 2000 (Act No. 29 of 2000), the re-determination of the boundaries of the municipalities referred to in the Schedule, is hereby authorised. 5

**Amendment of Schedule to Act 29 of 2000 as amended by section 2 of Act 69 of 2000**

2. The Local Government: Cross-boundary Municipalities Act, 2000 (Act No. 29 of 2000), is hereby amended by the substitution for the Schedule of the following Schedule: 10
