AMENDMENT OF GAZETTE NOTICE 1275 OF 2004 AS CONTAINED IN GOVERNMENT GAZETTE NUMBER 26540

Notice is hereby given in terms of section 11A(4) of Restitution of Land Rights Act, 1994 (Act 22 of 1994), as amended, that an error was committed on gazette notice 1275 of 2004 dated the 09th July 2004 as contained in gazette number 26540

Mention was only made of the Rammalo Mushwana Community as the only claimants on the Farm Tours 17 KT situated in Mopani District, Limpopo. It was later discovered that the Mogoboya Community is also claiming the same property. The error occurred as a result of an omission to include the Mogoboya Community.
