#### **APPLICATION FOR CHANGE IN THE CONTROL OF A SIGNAL DISTRIBUTION LICENCEE: ORBICOM (PTY) LTD**

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from Orbicom (Pty) Ltd for prior approval to change its shareholding structure, resulting in a change of control as per the attached schedule.

Orbicom (Pty) Ltd shall be entitled to respond in writing to the written representations made by interested persons on the proposed amendments, and any such written response must be submitted to the Authority within sixty (60) days of the date of publication of this notice in the *Government Gazette*. **SCHEDULE**

1. According to the application, Orbicom (Pty) Ltd, MTN Group (Pty) Ltd and MultiChoice Africa (Pty) Ltd entered into in an agreement in terms of which MultiChoice is to purchase the entire shares of MTN in Orbicom.
