"Von Reiche Inc" shall mean Von Reiche Inc, structured as an incorporated company, which renders legal services including legal advice and legal representation to individual clients and businesses/organisations;

"SAHRC" shall mean the South African Human Rights Commission.

"Information Officer" Mr von Reiche has been appointed as the Information Officer of Von Reiche Inc

The Minister of Justice and Constitutional Development has to date not published any regulations in terms of this Section.
