

"the Act" shall mean the Promotion of Access to Information Act, Nr. 2 of 2000, together with all relevant regulations published:

"the / this manual" shall mean this manual and with all annexures thereto as available at offices of Global Estates & Immigration CC from time to time; "Global Estates & Immigration CC" shall mean Global Estates & Immigration CC, structured as a close corporation which is an estate agency who sells property including the assisting in buying and selling of property of individual clients and businesses;

"SAHRC" shall mean the South African Human Rights Commission.

None of the information held by Global Estates & Immigration CC is automatically available without a person having request access in terms of and subject to the provisions of the Act. A request for information should be in the prescribed form, addressed to the Information Officer and submitted against payment of the prescribed fee.

OTHER INFORMATION (Section 51(1)(f) of the Act)

The Minister of Justice and Constitutional Development has to date not published any regulations in terms of this Section.

AVAILABILITY OF THE MANUAL (Section 51(3) of the Act)

This manual is available for inspection at the office of Global Estates & Immigration CC, free of charge.

A copy of the manual may be obtained, subject to the prescribed fees, at the offices of Global Estates & Immigration CC.
