# **ICASA LOW POWER SOUND BROADCASTING REGULATIONS, 2003**

The Independent Communications Authority of South Africa has in terms of section 5(2)(e) of the Broadcasting Act, (Act No.4 of 1999) read with section 78 (1) of the Independent Broadcasting Authority Act, (No. 153 of 1993) made the regulations in the Schedule.

### Definition

1. In these regulations "the Regulations" means the regulations published by Government Notice No. R. 25631 of 24 October 2003.

## Amendment of regulation 7 of the Regulations

- 2. Regulation 7 of the Regulations is hereby amended by the substitution of the heading with the following heading
  - "7. Broad-Based Black Economic Empowerment, Ownership and Control"

3. Regulation 7 of the Regulations is hereby amended by the insertion of the following regulation after regulation 7.2:

7.3 The Authority in accordance with the objectives of the IBA Act, the Broadcasting Act and the Broad-Based Black Economic Empowerment Act shall consider:

- (a) when granting a licence the empowerment of historically disadvantaged groups including women, the youth and people with disabilities;
- (b) the promotion of broad-based black economic empowerment; and
- (c) as far as is reasonably possible the application of any relevant code of good practice issued in terms of the Broad-Based Black Economic Empowerment Act when determining qualification criteria for the issuing of licences
