AIR SERVICE LICENSING ACT, 1990 (ACT No.115 OF 1990)

APPLICATIONS FOR THE GRANT OR AMENDMENT OF DOMESTIC AIR SERVICE LICENCE

Pursuant to the provisions of section 15 (1) (b) of Act No. 115 of 1990 and regulation 8 of the Domestic Air Services Regulations, 1991, it is hereby notified for general information that the applications details of which appear in the Appendix, will be considered by the Air Service Licensing Council.

SCHEDULE

NOTICE UNDER SECTION 12 (4) OF THE GRANTING OF AN EXEMPTION

(A) Full name and surname and the trade, if any, of the person to whom the exemption was granted. (B) The type of the air service in respect of which the exemption was granted. (C) The category of aircraft in respect of which the exemption was granted. (E) The conditions under which the exemption was granted.

(B) Class III: Type G7 (emergency medical facilities; transporting medical personnel) and G16 (aero medical patient transfers, movement of personnel, goods, equipment and occasional promotional flights. (C)) Categories: A3; H1 and H2 (being 3x Pilatus PC12 (Reg. No's ZS-SRH, ZS- BEB and ZS-PGX, Eurocopter AS350 (ZS-RCS), Eurocopter B0105 (ZS-RMR), Alouette (ZS-RIH). (D) Exemption was granted for 36 months. (E) Exemption is limited to the Republic of South Africa and subject to continued compliance with section 12 (2) of the Air Services Licensing Act, 1990.
