### NOTICE 2007 OF 2005

**Regulations Relating to a Transparent Pricing System for Medicines and Scheduled Substances – Medicines and Related Substances Act, 1965 (Act No 101 of 1965) (Government Gazette No 28214 of 11 November 2005)**

1. The Minister of Health intends, in terms of regulation 5(2)(g) of the abovementioned regulations, to determine a maximum logistics fee for logistical services in relation to medicines and hereby invites comments from all interested parties.
2. The Minister of Health also intends to determine and publish, in terms of regulation 5(2)(e) of the abovementioned regulations, a methodology for conforming with international benchmarks of the prices of medicines and hereby invites comments on the same from all interested parties.
3. The Minister of Health further invites comments from all interested parties on an increase in the Single Exit Price of medicines in terms of Regulation 8(1) of the abovementioned regulations.

Submissions on each of the three abovementioned topics should be made separately and forwarded for attention Dr Anban Pillay, Department of Health, Private Bag X828, PRETORIA, 0001. In addition an electronic copy of the submission may be e-mailed to [pee@medicalschemes.com](mailto:pee@medicalschemes.com). In making their submissions interested parties must take into account the requirements of the relevant regulations.

The closing date for submissions on all three items listed above is 05 March 2006.
