Announcement of Intention to Extend the Accreditation of the Energy Sector Education and Training Authority (ESETA)

The South African Qualifications Authority (SAQA) hereby notifies the public that as of 30th November 2005 it has transferred the qualifications listed below and the associated units standards to the Energy Sector Education and Training Authority (ESETA). The decision to transfer the listed qualifications is based on the declaration by the Minister of Labour as stated in the Government Gazette, Vol. 477, No. 27445, dated 31 March 2005, wherein the Minister of labour increased the scope of the Energy Sector Education and Training Authority (ESETA) to include the water sector, which was previously under the jurisdiction of the former Local Government and Water Sector Education and Training Authority (LGWSETA). The transfer includes the accreditation to quality assure the qualifications listed below that are registered on the National Qualifications Framework (NQF) as well as the providers and learners currently in the system.

For qualifications and unit standards on level 5 and higher on the National Qualifications Framework, a signed Memorandum of Understanding between the applying ETQA and the Council on Higher Education will be required. This is required within 6 months from the date of the transfer of the extension of accreditation.
