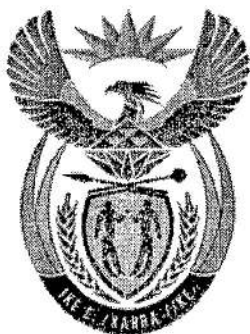

**GROENKLOOF NATIONAL PARK: EXCLUSION OF LAND FROM THE PARK  
IN TERMS OF THE NATIONAL PARKS ACT, 1976**

I, Marthinus van Schalkwyk, Minister of Environmental Affairs and Tourism,  
hereby –

- (a) under section 2A(2) of the National Parks Act, 1976 (Act No. 57 of 1976) hereinafter referred to as “the Act”
  - (i) and under the authority of a resolution of Parliament, exclude the land described in Schedule A hereto, from Groenkloof National Park, and
  - (ii) amend the definition of the area of the said Park in Schedule 1 to the Act by the deletion of the land defined in Schedule A.

**GROENKLOOF NATIONAL PARK: PROCLAMATION OF CONSOLIDATED  
LAND IN TERMS OF THE NATIONAL PARKS ACT, 1976**

I, Marthinus van Schalkwyk, Minister of Environmental Affairs and Tourism, hereby declare by virtue of the powers vested in me by section 2A(2) of the National Parks Act, 1976 (Act No. 57 of 1976) that:

- (a) the consolidated land in the Schedule be part of Groenkloof National; and
- (b) the description of land in the First Schedule to the said Act (See Government Gazette Notice No. 75 of 1968) be replaced by the addition of the description of the under-mentioned consolidated property to the definition of the said park.
