APPLICATION FOR THE AMENDMENT OF BROADCASTING LICENCE CONDITIONS: SOUTH AFRICAN BROADCASTING CORPORATION (PTY) LTD (SABC) UMHLOBO WENENE

- 1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice, in terms of the provisions of section 52(2) of the Independent Broadcasting Authority Act, No 153 of 1993, as amended, that it has received an application in terms of section 52 from SABC (Pty) Ltd for the amendment to the SABC licence (Umhlobo Wenene) in terms of section 52(1) (c) of the Act.
- 2. The amendment application is sought to enable SABC Umhlobo Wenene to expand its coverage in the area of Kimberley in the Northern Cape Province and allow it to the use of a spare frequency (106.9 MHz.) at Kimberley.
- 3. The application, relevant schedule and any representations received pursuant thereto is available and open for inspection by interested parties in the Authority's library during normal office hours.
