Mandate

- The Godisa Trust has been established by the Government of The Republic of South Africa through the Department of Science and Technology and the Department of Trade and Industry - it is a schedule 3A public company.
- The Godisa programme has no exclusive markets or technologies and it will be guided by the quality of Expressions of Interest provided by promoters. However, the Godisa Trust is eager to promote incubators in key areas, which will support national economic and social development.

Functions and Objectives

- The establishment of technology centres such as incubators, innovation centres, demonstration centres or hybrid centres with the aim of accelerating the establishment of technology driven enterprises.
- The enhancement of entrepreneurial and innovative thinking through effective and efficient centre processes.
- The facilitation of effective, efficient and economical transfer and development of technological and business skills and know-how in centres.
- The establishment and maintenance of networking arrangements between centres, as well as with other similar organisations.
- Improve the business performance, profitability and survival rate of newly established technology based SMMEs
- Provide sector focussed SMME clusters with access to up-to-date technology and management support.
- Promote technology transfer/diffusion within the small, medium and micro-enterprise (SMME) sector of the local economy.
- Promote economic growth and employment creation through the enhancement of technological innovation.
- Promote competitiveness and the assimilation of "best practice" production technologies
- Apart from financial aid, provide assistance, eg. training, consultation, advice or other measures deemed necessary for the effective, efficient and economical functioning of centres.
- Incorporation of the DTI incubator type centres into the Godisa Trust.
- Continual improvement of the Godisa Trust by benchmarking and research.

- Die Godisa program het nie enige eksklusiewe markte of tegnologieë nie en sal geleidelik word deur die kwaliteit van Uitdrukkings van Belange wat deur promotores verskaf word. Desnieteenstaande is die Godisa Trust ywerig om kweekmasjiene in sleutelareas te bevorder wat nasionale ekonomiese en sosiale ontwikkeling sal ondersteun.
