On 8 August 2005, the International Trade Administration Commission of South Africa (the Commission) formally initiated an investigation into alleged dumping of multi-ply paper and paperboard with a mass of 180g/m² or more, but not exceeding 550g/m², coated on one side with koalin clay, commonly known as "white liner" or "grey back paperboard", originating in or imported from the Republic of Korea. Notice of the initiation of the investigation was published in Notice No. 1356 of 2005 in *Government Gazette* No. 27846.

The investigation was initiated after the Commission considered an application by Mondi Paper Packaging Ltd (the Applicant), alleging that white lined paper board originating in or imported from the Republic of Korea was being imported at dumped prices thereby causing material injury to the SACU industry. The Commission was satisfied that there was a *prima facie* case of dumping, material injury and causal link.

Subsequent to the initiation of the investigation, all known importers and exporters were sent questionnaires to complete.

On 02 February 2006, the Commission considered all the facts before it and made a preliminary determination that dumping of white liner or grey back paperboard originating in or imported from the Republic of Korea is taking place, that the SACU industry is suffering material injury and that there is a causal link between dumping and injury suffered by the SACU industry. The Commission, however, decided not to implement provisional payments since it was of the opinion that the imposition of the provisional payments before verification would have a detrimental effect on the downstream paper products industry.

The Commission issued Report No 152 of 2006, wherein the decisions with regard to its preliminary determination were explained.

REQUEST FOR A STATUTORY MEASURE (LEVY) ON WHEAT, BARLEY, OATS AND DURUM WHEAT IN TERMS OF THE MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996 (ACT NO 47 OF 1996), AS AMENDED

STATUTORY MEASURE – LEVIES

The statutory measure that is requested to be established, is that the Minister, in terms of section 15 of the Act, by notice in the Government Gazette, direct that levies to the amounts of R9,00 per metric ton for wheat, R8,50 per metric ton for barley, R4,50 per metric ton for oats and R4,75 per metric ton for durum wheat, (VAT excluded), be imposed on all winter cereal sold, imported, processed or converted, exported, and in respect of which a SAFEX silo receipt has been issued if the levy in respect of such a winter cereal has not been paid before.

INFORMATION REQUIRED BY SECTION 10 OF THE ACT

The particulars as required by section 10 of the Act to be included in a request for the establishment of a statutory measure, are as follows:

- 2.1 The statutory measure that is requested would relate to wheat, barley, durum wheat and oats (hereafter referred to as winter cereal).
- 2.2 The categories of directly affected groups which would probably be affected by the proposed statutory measure, are those groups of persons who are party to the production, purchasing and processing of winter cereals as well as to the consumption of winter cereal products in the Republic of South Africa.
- 2.3 Letters of support for the proposed statutory measure on winter cereals, by the different categories of directly affected and other groups in the winter cereal industry were received.
- 2.4 The proposed statutory measure will apply to the whole of the Republic of South Africa, in order to have a uniform levy.
- 2.5 According to the applicant, the proposed statutory measure will further the objectives of the Act as stipulated in section 2(2) thereof. Such measure will also not contravene section 2(3) of the Act.
- 2.6 The manner in which the objectives referred to in section 2(2) of the Act will be furthered (namely the increasing of market access for all market participants, the promotion of the efficiency of the marketing of agricultural products, the optimisation of export earnings from agricultural products and the enhancement of the viability of the agricultural sector), are summarised below:

The purpose and aims of this statutory measure are to provide financial support to the gathering and dissemination of information as well as scientific research to the benefit of the winter cereal industry.

Support to the winter cereal information function:

The maintenance of macro industry information is regarded as critical for strategic planning by the winter cereal industry as well as the directly affected groups individually.

In order for the market to operate effectively and efficiently, the industry regards the supplying of generic market information to all role players on a continuous basis, as essential.

The South African Grains Information Services (SAGIS) has since its establishment been nationally and internationally accepted as an objective and reliable supplier of information. A statutory levy is required to ensure that the winter cereal industry also shares in the gathering and dissemination of information by SAGIS.

Proper and accurate winter cereal market information obtainable on a continuous and timeous manner, will not only increase market access for all participants, but will also promote efficiency in the marketing of winter cereal and winter cereal products. Winter cereal marketing will furthermore enhance the viability of the winter cereal industry in particular and the agricultural sector at large.

Market information will also enhance food security, as the information on national stock levels of winter cereal will be available. The measure will further not be detrimental to the number of job opportunities within the economy or to fair labour practice.

Winter cereal and winter cereal products are annually exported to neighbouring countries and in record crop years significant volumes are also exported overseas. To achieve optimisation of export earnings, reliable information is essential.

Support to research on winter cereals:

The agricultural sector is expected to ensure food security, strengthen the economy and promote social wealth by providing job opportunities in rural areas. This aim can be reconciled with the provisions of section 2(3) of the Act. In order to achieve these aims the agriculture sector is dependent on continued research.

According to experts in the field of research, the performance of the South African agricultural sector despite the lack of high-potential arable land, could to a great extent be attributed to the development and application of agricultural research results. The complex interaction between changing behavioral patterns of crops and external factors affecting them, such as disease and pests, often impacts negatively on production and quality, thus creating an urgent demand for new technology in order to keep the agricultural sector profitable. Account should also continually be taken of consumer preferences within the market.

As regards research on winter cereal, specific infrastructure has been created over time. It is essential that the above infrastructure created by contributions from the winter cereal industry be retained and maintained to the benefit of the winter cereal industry.

The development of new cultivars with improved quality characteristics constitutes an important part of the research undertaken by various organisations. The continuous development of new cultivars is indispensable to the sustained production of winter cereals.

No one of the objectives of the Marketing Act is envisaged to impact negatively on any of the other objectives. Furthermore, the measure would not contravene Section 2(3) of the Act.

2.7 DATE OF IMPLEMENTATION AND DURATION OF STATUTORY MEASURE:

The current statutory measures regarding levies in winter cereals as promulgated by Government Notices No. 1158 of 13 September 2002 expire on 30 September 2006.

The statutory measure requested should come into operation on 1 October 2006 and remains in place for a period of four years i.e. until 30 September 2010.

It should be borne in mind that the measures will, in terms of the Act, be subject to evaluation and review by the National Agricultural Marketing Council at least every two years. Furthermore, the Act provides for the application to be made for the repeal of statutory measures.

2.8 MOST APPROPRIATE BODY TO ADMINISTER MEASURE:

The administration of the Winter Cereal Trust will be responsible for the collection and administration functions associated with the statutory measure as requested. The Board of Trustees will appoint persons to carry out these functions. Such persons will have to be designated and authorised by the Minister as inspectors to perform the functions referred to in Section 21 of the Act. The Auditor-General will execute annual audits.

REQUEST FOR THE CONTINUATION OF STATUTORY MEASURES RELATED TO REGISTRATION AND PROVISION OF RECORDS AND RETURNS FOR COTTON, IN TERMS OF THE MARKETING OF AGRICULTURAL PRODUCTS ACT, 1996 (ACT NO 47 OF 1996), AS AMENDED

1. STATUTORY MEASURES - REGISTRATION, RECORDS AND RETURNS

The request received from Cotton South Africa, is that the Minister, in terms of section 10 of the Act, by notice in the Government Gazette, direct that the statutory measures, namely the keeping of records and the submission or returns to Cotton South Africa, by persons who purchase seed cotton from producers and who purchase lint from producers and ginners, processors of seed cotton and importers and exporters of cotton, and the registration with Cotton South Africa of persons who produce seed cotton, persons who purchase seed cotton from producers and who purchase lint from producers or ginners, processors of seed cotton and importers and exporters of cotton, be continued.

2. INFORMATION REQUIRED BY SECTION 10 OF THE ACT

The particulars as required by section 10 of the Act to be included in a request for the continuation of statutory measures, are as follows:

- 2.1 The statutory measures that are requested to be continued, would relate to cotton.
- 2.2 The categories of directly affected groups which would probably be affected by the proposed continuation of the statutory measures, are:

Registration:

Persons who produce seed cotton, persons who purchase seed cotton from producers and who purchase lint from producers or ginners, processors of seed cotton and importers and exporters of cotton.

Records and returns:

Persons who purchase seed cotton from producers and who purchase lint form producers or ginners, processors of seed cotton and importers and exporters of cotton.

- 2.3 Letters of support for the proposed continuation of the statutory measures on cotton were received from the following institutions:
 - National Cotton Producers' Organisation (NACPO);
 - SA Cotton Ginners' Association (SACGA);
 - SA National Consumer Union (SANCU); and
 - SA Clothing and Textile Workers Union (SACTWU).
- 2.4 The statutory measures will apply to the whole of the Republic of South Africa.

- 2.5 According to the applicant, the proposed continuation of the statutory measures will further the objectives of the Act as stipulated in section 2(2) thereof. Such continuation will also not contravene section 2(3) of the Act.
- 2.6 The manner in which the objectives referred to in section 2(2) of the Act will be furthered (namely the increasing of market access for all market participants, the promotion of the efficiency of the marketing of agricultural products, the optimisation of export earnings from agricultural products and the enhancement of the viability of the agricultural sector), are summarised below:

Since deregulation of the agricultural industry, great value is being placed on product market information, which is no longer as readily available and accessible as before. In this environment, Cotton South Africa has since 1998 established itself as the major local source of cotton market information, in that many role-players in the cotton industry have become dependent on the information services provided by Cotton South Africa, which is regarded as critical for strategic planning by the industry.

Unbiased and reliable market information, which is available on a continuous and timeous manner, will not only increase market access for all market participants, but also will also promote the efficiency of the marketing of cotton and enhance the viability of the cotton industry and the agricultural sector at large. Market information will furthermore lead to the optimisation of export earnings without being detrimental to the number of employment opportunities or fair labour practice.

The market information obtained up to now by way of these statutory measures has also proved to be invaluable to Cotton South Africa in its capacity as industry forum, as well as in the advancement of its main objectives such as the stimulation of the production and the usage of cotton; the enhancement of the marketability of cotton through research; the establishment of quality standards and norms and the facilitation of the development of the emerging cotton production sector.

Since deregulation, relevant market information obtained by way of statutory measures and other means has been disseminated among others, in the following manner:

- By way of monthly market reports on both the local as well as the international situation, posted and/or e-mailed monthly to more than 1100 core producers, which includes more than 400 small scale farmers, as well as to more than a 150 other role-players in the industry as well as to the media.
- By way of Cotton South Africa's website which records on average 4000 user sessions per month. The website has recently been upgraded to include more information and to make it more user friendly.
- By convening farmer information days. During 2005, 7 farmer days were hosted in different localities, which were attended by close to 400 farmers in total. One of these farmer days were aimed at the emerging sector exclusively and more than 200 small scale farmers attended these days, where relevant and useful information could be communicated to them.

- By way of publications such as the quarterly Cotton South Africa magazine, which since the July/August 2000 issue also incorporates the research publication "On the Boll" of the ARC's Institute for Industrial crops, providing feedback on research projects, as well as a regular section aimed at small scale farmers exclusively. The magazine is currently mailed to about 2100 farmers, which include about 500 small scale farmers, as well as to more than 600 other subscribers.
- By way of other means such as articles in various agricultural magazines as well as publications aimed at the small grower in particular, such as the monthly newspaper "Nufarmer" with a circulation figure of about 35 000 per month.
- A comprehensive Management Guide for Commercial Farmers as well as a Cotton Guide for Small Scale Farmers are also made available by Cotton South Africa to current and potential cotton farmers. The commercial farmer guide is in the process of being updated and reprinted whilst the small farmer publication has recently been revised and upgraded. This latter guide is fully illustrated in colour with captions in English and Zulu and covers the full spectrum of cotton farming and contain among others, chapters on cultivation guidelines, insect and disease control and the harvesting of cotton. Translations of the guide in Afrikaans and Sotho are also envisaged for the future.
- From time to time, Cotton South Africa also takes part in shows, exhibitions and expo's where market information is disseminated.
- By way of personal contact, ad hoc requests and international surveys.
- Information on various cotton matters are also being made available by way of the following publications which are obtainable from Cotton SA:
 - Core Cotton Statistics Booklet
 - Educational brochures (for schoolchildren and students)
 - Organisation Information Brochures
 - Small Farmer Weed Identification Guide
 - Scouting guide for Cotton Pests
 - Cleaner Cotton Production Guide
 - Integrated Pest Management CD
 - Organic Cotton CD
 - Video on Cotton Picking Techniques

In conclusion, in the yarn manufacturing industry, increased processing speeds, new spinning technologies and heightened quality expectations, have changed the industry's focus and buying strategy of raw materials, hence the fact that up to date crop information is now more critical than ever before. Fibre utilisation decisions taken by the ginning and spinning industries, therefore have a more direct impact on the primary cotton producing industry, be it emerging or commercial farmers. These farmers are totally dependent on proper and accurate market information to assist them to conform to the strict requirements set by the spinning industry with regard to their raw material inputs.

The statutory measures will not be detrimental to the number of employment opportunities within the economy or to fair labour practise.

2.7 The previous statutory measures as published in Government Gazette No. R.908 and R. 909 of 12 July 2002 lapse on 31 March 2006.

2.8 The status quo will be maintained in respect of the body that are responsible for the administration of the statutory measures and mentioned in the regulations, namely Cotton South Africa (a non profit seeking company under section 21 of the Companies Act, 1973 (Act No 61 of 1973).

- f) institute such disciplinary action as may be described against any person found to be in violation of any norms and standards, or guidelines set for the conducting research in terms of the Act; and
- g) advise the National Department of Health and the provincial departments of health on any ethical issues concerning research.

The functions of the council are such that only the nominations of persons with relevant qualification and experience in health research will be considered.

Members of the council will not serve on full time basis but will meet approximately four times a year in Pretoria. The National Department of Health will render secretariat functions to the council.
