1. The Independent Communications Authority of South Africa (the Authority) hereby gives notice in terms of section 41 of the Independent Broadcasting Authority Act, 153 of the 1993 that it has received in terms of section 5(2)(e) of the Broadcasting Act, 4 of 1999, as amended, read with the guidelines to apply for a low power sound broadcasting licences as per Notice No. 296 of 2005 in Government Gazette No. 27308 dated 18 February 2005, an application, for a commercial low power sound broadcasting service. The details of the application are contained in the schedule below.
2. The application is available and open for inspection by interested persons in the Authority's library during the Authority's normal office hours.

4. Persons who lodge representations in terms hereof must simultaneously indicate whether they also require an opportunity to make oral representations to the Authority.

5. Persons, who lodge representations in terms hereof, shall at the time of lodging such representation, furnish proof to the satisfaction of the Authority that a copy of the representation has been sent by registered post or delivered to Mr. H.G Van der NEST or posted to P.O Box 1932, KRIEL, 2271 or hand delivered to Mr. Van der Nest at 70 Groen Avenue, Kriel or fax to (017) 648 4895.

6. Soepa Soap Vervaardigers CC intending to broadcast as Standerton Info Radio shall be entitled to respond in writing to written representations made by interested persons on the proposed application and such written response must be lodged with the Authority within one month of the date of publication of this notice in the *Government Gazette*. Standerton Info Radio must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
