**AMENDMENT OF DECLARATION 543 of 2003, NATIONAL ROUTE N2
SECTIONS 2, 3 AND 4: GRABOUW TO SWELLENDAM: DISTRICTS OF
CALEDON AND SWELLENDAM.**

By virtue of section 40 (1) (b) of the South African National Roads Agency Limited and National Roads Act, 1998 (Act no 7 of 1998), I hereby amend declaration No. 543 of 2003 to include; a) a section of road described in the second schedule of ordinance No. 13 of 1961 for Trunk Road 272 between Compagniesdrift No. 436 and Main Road 28, which commences at the point of divergence from the eastbound carriageway of National Road N2 section 2, as declared by declaration No. 543 of 2003, and hence proceeding in a general southern direction to Hermanus for a distance of approximately 1660m to a point opposite the most westerly cadastral beacon of portion 3 of the farm Bot River Outspan 469, and b) the N2 road passing Vredendal at Bot River and Caledon and the section of the surfaced road, excluding parking areas, through the township of Riviersonderend.
