ACT

To amend the Deeds Registries Act, 1937, so as to provide for the continued registration of registrable transactions concerning rights acquired in terms of or under the Black Administration Act, 1927, or proclamations, regulations or by-laws under the latter Act despite its repeal; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 3 of Act 47 of 1937, as substituted by section 2 of Act 87 of 1965 and amended by section 1 of Act 41 of 1977, section 1 of Act 92 of 1978, section 1 of Act 44 of 1980, section 3 of Act 27 of 1982, section 28 of Act 88 of 1984, section 2 of Act 14 of 1993, section 9 of Act 122 of 1993, section 68 of Act 67 of 1995, section 1 of Act 11 of 1996, section 110 of Act 28 of 2002, section 53 of Act 24 of 2003 and section 46 of Act 11 of 2004 5

1. Section 3 of the Deeds Registries Act, 1937 (hereinafter referred to as the principal Act), is hereby amended by the insertion in subsection (1) after paragraph (p) of the following paragraph: 10

“(p)*bis* despite the repeal of the regulations, proclamations and by-laws made under sections 25(1), 30(2) and 30A(1) of the Black Administration Act, 1927 (Act No. 38 of 1927), by the Repeal of the Black Administration Act and Amendment of Certain Laws Act, 2005 (Act No. 28 of 2005)— 15

(i) continue to register any registrable transaction concerning a right originally acquired in terms of or under the Black Administration Act, 1927, in accordance with the legislation which created that right; and

(ii) exercise all the other powers and perform all the other duties vested in or imposed upon a Chief Commissioner or registration officer by or under the Black Administration Act, 1927.”.

Tot wysiging van die Registrasie van Aktes Wet, 1937, om voorsiening te maak vir die voortgesette registrasie van regstreerbare regshandelings betreffende regte verkry ingevolge of kragtens die Swart Administrasie Wet, 1927, of proklamasies, regulasies of verordeninge kragtens laasgenoemde Wet ondanks die herroeping daarvan; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Wysiging van artikel 3 van Wet 47 van 1937, soos vervang deur artikel 2 van Wet 87 van 1965 en gewysig deur artikel 1 van Wet 41 van 1977, artikel 1 van Wet 92 van 1978, artikel 1 van Wet 44 van 1980, artikel 3 van Wet 27 van 1982, artikel 28 van Wet 88 van 1984, artikel 2 van Wet 14 van 1993, artikel 9 van Wet 122 van 1993, artikel 68 van Wet 67 van 1995, artikel 1 van Wet 11 van 1996, artikel 110 van Wet 28 van 2002, artikel 53 van Wet 24 van 2003 en artikel 46 van Wet 11 van 2004

1. Artikel 3 van die Registrasie van Aktes Wet, 1937 (hieronder die Hoofwet genoem), word hierby gewysig deur in subartikel (1) na paragraaf (p) die volgende subartikel in te voeg:

“(p)*bis* ondanks die herroeping van die regulasies, proklamasies en verordeninge kragtens artikels 25(1), 30(2) en 30A(1) van die Swart Administrasie Wet, 1927 (Wet No. 38 van 1927), gemaak, deur die Wet op die Herroeping van die Swart Administrasie Wet en Wysiging van Sekere Wette, 2005 (Wet No. 28 van 2005)—

(i) betreffende 'n reg oorspronklik ingevolge of kragtens die Swart Administrasie Wet, 1927, verkry, voortgaan om enige regstreerbare regshandeling ooreenkomstig die wetgewing wat daardie reg geskep het, te registreer; en

(ii) al die ander bevoegdhede uitoefen en al die ander pligte verrig wat by of kragtens die Swart Administrasie Wet, 1927, gevestig is in of opgedra is aan 'n Hoofkommissaris of registrasiebeampte.”.

Insertion of section 16D in Act 47 of 1937

2. The following section is hereby inserted in the principal Act after section 16C:

“Registration of transfer of rights acquired in terms of or under Black Administration Act, 1927”

16D. Despite the repeal of the Black Administration Act, 1927 (Act No. 38 of 1927), by the Repeal of the Black Administration Act and Amendment of Certain Laws Act, 2005 (Act No. 28 of 2005), and despite the other provisions of this Act and any other law, a right originally acquired in terms of or under the Black Administration Act, 1927, shall be transferred in accordance with the legislation which created that right.”.

3. This Act is called the Deeds Registries Amendment Act, 2006.
