**Act No. 8, 2006 REPEAL OF THE BLACK ADMINISTRATION ACT AND
AMENDMENT OF CERTAIN LAWS AMENDMENT ACT, 2006**

(Assented to 20 July 2006.)*

ACT

To amend the Repeal of the Black Administration Act and Amendment of Certain Laws Act, 2005, so as to substitute a date; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Amendment of section 1 of Act 28 of 2005

1. Section 1 of the Repeal of the Black Administration Act and Amendment of Certain Laws Act, 2005, is hereby amended by the substitution in subsections (2), (3), (4), (5) and (6) for the date “31 July 2006”, wherever it occurs, of the date “30 September 2007”. 5

Short title and commencement

2. This Act is called the Repeal of the Black Administration Act and Amendment of Certain Laws Amendment Act, 2006, and comes into operation on 30 July 2006. 10

Wysiging van artikel 1 van Wet 28 van 2005

1. Artikel 1 van die Wet op die Herroeping van die Swart Administrasie Wet en Wysiging van Sekere Wette, 2005, word hierby gewysig deur in subartikels (2), (3), (4), (5) en (6) die datum "31 Julie 2006", oral waar dit voorkom, deur die datum "30 September 2007" te vervang. 5
