The Minister of Home Affairs intends introducing the Civil Union Bill, 2006 in the National Assembly during September 2006. An explanatory summary of the Bill is hereby published in accordance with Rule 241(1)(c) of the Rules of the National Assembly.

The Bill provides for—

- (a) a civil partnership/marriage between adult persons of the same sex, solemnized before the State, with all the legal consequences of a marriage being made applicable thereto; and
- (b) a domestic partnership between adult persons who have not concluded a marriage or civil partnership/marriage, of the same or opposite sex, with specific legal consequences being made applicable thereto as provided for in the Bill.

PUBLICATION OF EXPLANATORY SUMMARY OF THE FILMS AND PUBLICATIONS AMENDMENT BILL, 2006

The Minister of Home Affairs intends introducing the Films and Publications Amendment Bill, 2006 in the National Assembly during September 2006. An explanatory summary of the Bill is hereby published in accordance with Rule 241(1)(c) of the Rules of the National Assembly.

The aim of the Bill is to amend the Films and Publications Act, 1996 (Act No. 65 of 1996) in order to protect children from potentially disturbing, harmful and age-inappropriate materials in publications, films, interactive computer games, mobile cellular telephones and on the Internet.

The Bill provides for-

- (a) the insertion of certain definitions;
- (b) the amendment of the composition of the Board;
- (c) the amendment of the functions and powers of the Board;
- (d) the appointment and powers of compliance officers;
- (e) the composition, functions, powers and management of the classification office;
- (f) the repeal of certain sections and Schedules to the Act; and
- (g) the inclusion of broadcasters of films into the scope of the Act.
