#### AVIATION ACT, 1962(ACT NO 74 OF 1962)

#### PROPOSED AMENDMENTS TO THE CIVIL AVIATION REGULATIONS, 1997

##### Explanation of Interest of the Proposer

The proposer administers the Aviation Act, 1962, (Act No 74 of 1962) and Regulations and Technical Standards issued in terms thereof

#### 1.0 PROPOSAL TO AMEND REGULATION 65.3.11 OF PART 65 OF THE REGULATIONS

##### 1.1 Proposed amendment of regulation 65.3.11 by the substitution for sub-regulation (1) of the following sub-regulation:

“ Renewal of air traffic service assistant rating

- 65.03.11 (1) To renew an air traffic service assistant rating which has expired due to the lapse of the period referred to in Regulation 65.03.4 or in Regulation 65.03.9, the holder of the expired rating shall apply to the Commissioner for the renewal of such expired rating."

## **1.2 Motivation**

Regulation 65.03.11 provides for the Commissioner to renew a validated rating, which has expired under prescribed conditions, but omits provision for the renewal of an un-validated rating. This proposal seeks to correct this omission.

## **1.3 Current regulation**

### **"Renewal of air traffic service assistant rating**

- 65.03.11 (1) To renew an air traffic service assistant rating which has expired due to the lapse of the period referred to in Regulation 65.03.9, the holder of the expired rating shall apply to the Commissioner for the renewal of such expired rating.

### **ALLOCATION OF RADIO TELEPHONY (RTF) CALL SIGNS, 3 LETTER AIRCRAFT DESIGNATORS AND LOCATION INDICATORS**

#### **Applicability**

**176.00.1** This Part shall apply to applications for -

- (a) new allocations, changes or deletion of radio telephony call signs and 3 letter aircraft designators.
- (b) applications for new allocations, changes or deletion of location indicators

#### **Allocation of Radio Telephony (RTF) call signs and 3 letter aircraft designators**

##### **176.00.2**

An application to the Commissioner for the allocation of RTF call signs and 3 letter designators shall be accompanied by –

- (a) documentary proof of having been issued with an Air Services Licence or an International Air Service ;
- (b) the suggested RTF call signs for consideration; and.

(c) the appropriate fee as prescribed in Part 187 shall be applicable.

#### **Allocation of Location Indicators**

##### **176.00.3**

An application to the Commissioner for the allocation of location indicators shall be accompanied by-

- (a) documentary proof of having been issued with an aerodrome licence; and
- (b) provide the preferred location indicator for consideration.”

#### **11.2.Motivation**

It is imperative that these services performed by Aeronautical Information Service are regulated to ensure:

- that conditions and procedures are determined
- to advise the aviation community on requirements for application of such services
