CLOSURE OF THE CORRESPONDENCE COLLEGES COUNCIL AND THE FIDELITY GUARANTEE FUND

I, Grace Naledi Mandisa Pandor, Minister of Education, hereby give notice in terms of section 50(1) of the *Further Education and Training Act, 1998* (the Act) that the *Correspondence Colleges Council* and its *Fidelity Guarantee Fund* will close down on **31 December 2007**.

In view of the imminent closure of the Council and the Fund, I hereby invite any student that has a legitimate claim against any Correspondence College that was registered with and contributed an annual fee to the *Correspondence Colleges Council's Fidelity Guarantee Fund* until 2002, to lodge such a claim with the Council no later than **31 March 2007**. 
