#### **NOTICE 23 OF 2007**

#### INTERNATIONAL TRADE ADMINISTRATION COMMISSION

NOTICE OF INITITATION OF A SUNSET REVIEW OF THE ANTI-DUMPING DUTIES ON WOVEN FABRIC OF POLYESTER STAPLE FIBRES MIXED MAINLY OR SOLELY WITH COTTON, UNBLEACHED OR BLEACHED, DYED, COLOUR WOVEN AND PRINTED ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA

In accordance with the provisions of Article 11.3 of the World Trade Organisation Agreement on Implementation of Article VI of the General Agreement on Tariffs and Trade (the Anti-Dumping Agreement), the Commission on 26 May 2006, notified the Southern African Customs Union (SACU) industry through Notice No.673 in Government Gazette No.28847, that unless a substantiated request is made by it indicating that the expiry of the anti-dumping duties on the subject product originating in or imported from the People's Republic of China (PRC) would likely lead to the continuation or recurrence of dumping and injury, the anti-dumping duties will expire on 22 February 2007. An application for the sunset review was submitted to the Commission on 30 August 2006.

#### THE APPLICANT

The application was lodged by Textile Federation ("Texfed"), on behalf of Frame Textiles and Da Gama Textiles, the producers of the subject product in the SACU. The Applicant alleges that the expiry of the duties would likely lead to the continuation or recurrence of dumping and material injury. The Applicant submitted sufficient evidence and established a prima facie case to enable the Commission to arrive at a reasonable conclusion that a sunset review investigation should be initiated.

#### THE PRODUCT

The subject product is described as poly/cotton, or sheeting or shirting. The Applicant indicated every factory has its own "trade name". The subject product is classifiable under tariff subheadings 5513.11, 5513.21, 5513.31 and 5513.41, originating in or imported from the PRC.

#### THE ALLEGATION OF THE CONTINUATION OR RECURRENCE OF DUMPING

The allegation of continuation or recurrence of dumping is based on the comparison between the normal values and the export prices. The normal values for the PRC were based on the invoices for the fabrics bought in Guangzhou, Guangdong in the PRC. The export price was obtained by deducting approximately 5% from the FOB price to compensate for movement expenses in the exporting country (based on assumptions). On this basis, the Commission found that there was *prima facie* proof of the likely recurrence of dumping if the duties expire.

#### THE ALLEGATION OF MATERIAL INJURY AND/OR THREAT OF MATERIAL INJURY

The Applicant alleges and submitted sufficient evidence to show that there is price undercutting and that the imports in question are depressing and suppressing its selling prices. The Applicant's information indicated that it will experience a decline in sales volumes, profit margins, output, market share, productivity and a negative return on total net assets, if the duties expire. It was also indicated that the Applicant's market share will decrease at the expense of a corresponding increase in the market share of the dumped goods, if the duties expire.

On this basis the Commission found that there was *prima facie* proof of the likely continuation and/or recurrence of material injury.

#### PERIOD OF INVESTIGATION

The period of investigation for purposes of determining the continuation or recurrence of dumping from the PRC will be from 1 July 2004 to 30 June 2005. The period of investigation for purposes of determining the continuation or recurrence of injury will be from 1 July 2003 to 30 June 2005. The Commission will also consider an estimate of what the situation will be if the duties expire.

#### PROCEDURAL FRAMEWORK

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of a sunset review investigation, the Commission is initiating an investigation in terms of section 16 of the International Trade Administration Act, 2002 (the ITA Act). The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act, the Anti-Dumping Agreement and the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR). Both the ITA Act and the ADR are available on the Commission's website (<a href="www.itac.org.za">www.itac.org.za</a>) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential versions of the application and questionnaires to all known importers and exporters, and known representative associations. The trade representative of the exporting country has also been notified.

Importers and other interested parties are invited to contact the Commission as soon as possible in order to determine whether they have been listed and were furnished with the relevant documentation. If not, they should immediately ensure that they are sent copies.

#### CONFIDENTIAL INFORMATION

Please note that if any information is considered to be confidential then a non-confidential version of the information must be submitted for the public file, simultaneously with the confidential version. In submitting a non-confidential version the following rules are strictly applicable and parties must indicate:

- where confidential information has been omitted and the nature of such information;
- · reasons for such confidentiality;
- a summary of the confidential information which permits a reasonable understanding of the substance of the confidential information; and
- in exceptional cases, where information is not susceptible to summary, reasons must be submitted to this effect.

This rule applies to all parties and to all correspondence with and submissions to the Commission, which unless indicated to be confidential and filed together with a non-confidential version, will be placed on the public file and be made available to other interested parties.

If a party considers that any document of another party, on which that party is submitting representations, does not comply with the above rules and that such deficiency affects that party's ability to make meaningful representations, the details of the deficiency and the reasons why that party's rights are so affected must be submitted to the Commission in writing forthwith (and at the latest 14 days prior to the date on which that party's submission is due). Failure to do so timeously will seriously hamper the proper administration of the investigation, and such party will not be able to subsequently claim an inability to make meaningful representations on the basis of the failure of such other party to meet the requirements.

Section 33(1) of the ITA Act provides that any person claiming confidentiality of information should identify whether such information is confidential by nature or is otherwise confidential and, any such claims must be supported by a written statement, in each case, setting out how the information satisfies the requirements of the claim to confidentiality. In the alternative, a sworn statement should be made setting out reasons why it is impossible to comply with these requirements".

The following list indicates "information that is by nature confidential" as per section 33(1)(a) of the Main Act, read with section 36 of the Promotion of Access to Information Act (Act 2 of 2000):

- (a) management accounts;
- (b) financial accounts of a private company;
- (c) actual and individual sales prices;
- (d) actual costs, including cost of production and importation cost;
- (e) actual sales volumes;
- (f) individual sales prices;
- (g) information, the release of which could have serious consequences for the person that provided such information; and
- (h) information that would be of significant competitive advantage to a competitor;

Provided that a party submitting such information indicates it to be confidential."

Failure to submit an adequate non-confidential version of the response that complies with the rules set out above under the heading *Confidential Information* will be regarded as an incomplete submission.

#### **VERIFICATION**

The information submitted by any party may need to be verified by the Investigating Officers in order for the Commission to take such information into consideration. Parties should therefore ensure that the information submitted would subsequently be available for verification.

It is planned to do the verification of the information submitted by the exporters within three to five weeks subsequent to submission of the information. This period will only be extended if it is not feasible for the Commission to do it within this time period or upon good cause shown, and with the prior written consent of the Commission, which should be requested at the time of the submission. It should be noted that unavailability of, or inconvenience to consultants will not be considered to be good cause.

Parties should also ensure when they engage consultants that they will be available at the requisite times, to ensure compliance with the above time frames. Parties should also ensure that all the information requested in the applicable questionnaire is provided in the specified detail and format.

#### INFORMATION SUBMISSION FORMAT

The questionnaires are designed to ensure that the Commission is provided with all the information required to make a determination in accordance with the rules of Anti-Dumping Agreement. The Commission may therefore decide not to verify information that is incomplete or does not comply with the format in the questionnaire, unless the Commission has agreed in writing to a deviation from the required format.

Parties, who experience difficulty in furnishing the information required, or submitting in the format required, are therefore urged to make written applications to the Commission at an early stage for permission to deviate from the questionnaire or provide the information in an alternative format that can satisfy the Commission's requirements. The Commission will give due consideration to such a request on good cause shown.

#### ORAL HEARINGS

Any interested party may request an oral hearing at any stage of the investigation in accordance with Section 5 of the ADR, provided that the party indicates reasons for not relying on written submission only. # INTERNATIONAL TRADE ADMINISTRATION COMMISSION

NOTICE OF INITIATION OF THE REVIEW OF COUNTERVAILING DUTIES ON STRANDED WIRE, ROPES AND CABLES OF IRON OR STEEL, NOT ELECTRICALLY INSULATED, (EXCLUDING THOSE OF WIRE OF STAINLESS STEEL, BRASS PLAITED TYRE REINFORCING CORD, CONVEYER BEL CORD, THOSE OF WIRE PLAITED, COATED OR CLAD WITH COPPER AND EXCLUDING ROPE AND CABLES OF A DIAMETER OF 8MM AND LESS) ORIGINATING IN INDIA AND IMPORTED FROM USHA MARTIN LIMITED

The International Trade Administration Commission (ITAC) received an application for the interim review of the countervailing duties on wire ropes imported from Usha Martin Limited in India alleging that there has been significant change in circumstances to warrant the review of the countervailing duties imposed on exports of its subject product to the SACU market.

#### THE APPLICANT

The application was lodged by Adams and Adams, on behalf of Usha Martin Limited (the Applicant), being the manufacturer of the subject product in India subject to the countervailing duty.

#### THE PRODUCT

The subject product allegedly being investigated is stranded wire, ropes and cables of iron or steel, not electrically insulated, (excluding those of wire of stainless steel, brass plaited tyre reinforcing cord, conveyer belt cord, those of wire plated, coated or clad with copper and excluding ropes and cables of a diameter of 8 mm and less) classifiable under tariff subheadings 7312.10.20, 7312.10.25 and 7312.10.40.

## THE ALLEGATION OF CHANGED CIRCUMSTANCES

The Applicant stated that there has been significant change in circumstances to warrant the review of the countervailing duties imposed on exports of its products to the SACU market. The Applicant stated that it has brought the application for the interim review of the

countervailing duties on the subject product because it believes that there are changed circumstances resulting from the following factors:

- That the Duty Entitlement Passbook rate has been reduced to 3% on FOB, in addition, the Income Tax Exemption Scheme has been terminated and presently no deduction is allowed in respect of the assessment year beginning on the 1<sup>st</sup> of April 2005 and ending 31 March 2006, and any subsequent assessment year;
- That benefit conferred by the programme is de minimis

The Applicant substantiated its allegations by providing information on the two programmes and calculations on the effect of the subsidies for exports to SACU countries and exports to the rest of the world during the financial period 2005-2006. The Applicant, therefore, submitted that the countervailing duty of 17% be reduced to zero, as the benefit conferred by the subsidy is now less than 3 per cent.

## PROCEDURAL FRAMEWORK

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of an investigation, the Commission is initiating an investigation in terms of section 16 of the International Trade Administration Act, 2002 (the ITA Act). The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act, the World Trade Organisation Agreement on Subsidies and Countervailing Measures (the SCM Agreement) and the Countervailing Regulations of the International Trade Administration Commission of South Africa. Both the ITA Act and the Countervailing Regulations are available on the Commission's website (<a href="www.itac.org.za">www.itac.org.za</a>) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential version of the application to the SACU manufacturer and importers of the subject product. The trade representative of the exporting country has also been notified.

# CONFIDENTIAL INFORMATION

Please note that if any information is considered to be confidential then a non-confidential version of the information must be submitted for the public file, simultaneously with the confidential version. In submitting a non-confidential version the following rules are strictly applicable and parties must indicate:

- X where confidential information has been omitted and the nature of such information;
- X reasons for such confidentiality;
- X a summary of the confidential information which permits a reasonable understanding of the substance of the confidential information; and

NOTICE OF INITIATION OF AN INVESTIGATION INTO THE ALLEGED DUMPING OF CITRIC ACID ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC).

The International Trade Administration Commission (ITAC) accepted an application alleging that citric acid originating in or imported from the People's Republic of China is being dumped on the Southern African Customs Union (SACU) market, causing material injury to the SACU industry concerned.

#### THE APPLICANT

The application was lodged by Isegen South Africa (Pty) Ltd, being the only manufacturer of malic acid in the SACU, which the Commission concluded was a "like product" to the imported citric acid. The Applicant alleges that the allegedly dumped products are causing it material injury. The Applicant submitted sufficient evidence and established a *prima facie* case to enable the Commission to arrive at a reasonable conclusion that an investigation should be initiated on the basis of dumping, material injury and causality.

#### THE PRODUCT

The product allegedly being dumped is "citric acid" (subject product) classifiable under tariff subheading 2918.14. The SACU product is malic acid classifiable under tariff subheading 2918.19.10.

# LIKE PRODUCT DETERMINATION

On 22 February 2006, the Commission, after considering submission by the Applicant, decided that there is sufficient evidence to indicate that the imported and the SACU products are "like products".

The Commission used the following criteria to determine the likeness of the two products:

Correspondence of Commission's predecessor with and reports by the CSIR on the interchangeability of citric acid and malic acid indicated that in at least 75% of the applications for food and beverages the two acids are interchangeable.

#### THE ALLEGATION OF DUMPING

The allegation of dumping is based on the comparison between the normal values and the export prices from the subject country. The normal values for the subject country was calculated based on the published citric acid weekly prices from India. The export price was determined based on the official import statistics obtained from the South African Revenue Service. On this basis, the Commission found that there was *prima facie* proof of dumping.

## THE ALLEGATION OF MATERIAL INJURY AND CAUSAL LINK

The Applicant alleges and submitted sufficient evidence to show that there is price undercutting and that the imports in question are suppressing its selling prices. The Applicant's information indicated a decline in sales, profit margins, output and market share. It was also evident that the decrease in market share has been at the expense of a corresponding increase in the market share of the allegedly dumped citric acid imports. On this basis the Commission found that there was *prima facie* proof of material injury and causal link.

#### PERIOD OF INVESTIGATION

The period of investigation for purposes of determining the dumping margins in the respective exporting country or country of origin will be from 1 July 2005 to 31 August 2006. The period of investigation for purposes of determining injury will be from 1 July 2003 to 31 August 2006. If there are subsequent events that are relevant to injury the Commission may later request and consider further, more recent information.

#### PROCEDURAL FRAMEWORK

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of an investigation, the Commission is initiating an investigation in terms of section 16 of the International Trade Administration Act, 2002 (the ITA Act). The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act, the World Trade Organisation Agreement on Implementation of Article VI of the GATT 1994 (the Anti-Dumping Agreement) and the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR). Both the ITA Act and the ADR are available on the Commission's website (<a href="www.itac.org.za">www.itac.org.za</a>) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential versions of the application and questionnaires to all known importers and exporters, and known representative associations. The trade representatives of the exporting countries have also been notified. Importers and other interested parties are invited to contact the Commission as soon as possible in order to determine whether they have been listed and were furnished with the relevant documentation. If not, they should immediately ensure that they are sent copies. The questionnaire has to be completed and any other representations must be made within the time limit set out below.

#### VERIFICATION OF INFORMATION

The information submitted by any party may need to be verified by the investigating officers in order for the Commission to take such information into consideration. The Commission may verify the information at the premises of the party submitting the information, within a short period after the submission of the information to the Commission. Parties should therefore ensure that the information submitted would subsequently be available for verification.

It is planned to do the verification of the information submitted by the exporters within three to five weeks subsequent to submission of the information. This period will only be
