Persons who lodge representations in terms hereof, shall at the time of lodgement furnish proof to the satisfaction of the Authority that a copy of the representation has been delivered by hand to Ms. Justine White at Mkhabela Huntley Adekeye Inc, Unit A1, Building A, First Floor, Rutherford Estate, 1 Scott Street, Waverley, or sent by registered post to P.O. Red Pen 2 General Trading shall be entitled to respond in writing to written representations made by interested persons on the proposed transfer, and such written response must be lodged with the Authority within thirty (31) days of the date of publication of this notice in the *Government Gazette*. Red Pen 2 General Trading must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.

8. In the interest of administrative justice, the Authority may hold or convene a public hearing should it deem such necessary.
