IMPLICATIONS FOR SENIOR CERTIFICATE CANDIDATES

- I. The combination of the supplementary examination and the main Senior Certificate examination has the following implications for candidates:
- 1.1 The Senior Certificate supplementary examinations will be moved from February/March 2008 to May/June 2008.
- 1.2 The end-of-year examination for part-time candidates will be moved from October/November to May / June.
- 1.3 The last Senior Certificate supplementary examination will be conducted in May/June 2008, there after only one Senior Certificate examination will be written in May/June. on an annual basis until 20 II.

- 1.4 The registration date for the 2008 supplementary examination and for the end-of-year examination for part-time candidates moves from 15 March to 31 January 2008.
- 1.5 All candidates must have registered and sat for the Senior Certificate examination previously to qualify for registration in this examination and/or subsequent May/June examinations.
- 1.6 Candidates who registered for the Senior Certificate examination for the first time in 2007, and who wish to enter for the 2008 and subsequent Senior Certificate examinations, will only need to prove registration in the 2007 examination.
- 1.7 Candidates registering for the May/June 2008 Senior Certificate examination as a supplementary examination will not be limited to a maximum of two subjects, as current Senior Certificate policy prescribes.
- 1.8 Candidates registering for the May/June 2008 Senior Certificate examination as a supplementary examination will be restricted to subjects and subject grades for which they have registered in the October/November 2007 examination sitting.
- 1.9 Candidates registering as part-time candidates for the May/June 2008 Senior Certificate must have registered for, and sat for a previous Senior Certificate examination sitting.

POLICY CHANGES TO THE POLICY DOCUMENT, NATIONAL POLICY ON THE CONDUCT, ADMINISTRATIONAND MANAGEMENT OF THE ASSESSMENT OF THE SENIOR CERTIFICATE

- I. Repeal in the List of content:
 - No. 23: Supplementary examination: Norms and Standards.
- 2. Repeal in Definitions:

Examination Sitting is either a main examination sitting during October to November each year or a supplementary examination sitting. Examination sittings are only combined in cases where medical and/or other evidence warranting a combination of two assessment sittings is submitted to the satisfaction of the assessment body, being Umalusi, the Council for General and Further Education and Training Quality Assurance or the Matriculation Board, statutorily known as the Committee of Principals.

Replace with a new definition:

Examination Sitting is the main examination sitting during May to June each year from 2008 until 201 I.

3. Repeal paragraph 12(3):

To qualify for matriculation endorsement, full-time candidates for the Senior Certificate must, in accordance with the matriculation endorsement requirements as stipulated in the Matriculation Endorsement and Exemption Regulations, *Government Gazette*, Vol. 426, No. 21805 of 1 December 2000, as amended in *Government Gazettes*, Vol. 448, No. 23900 of 11 October 2002 and

No. 25506 of 26 September 2003, enter for at least six subjects at one and the same assessment sitting. An assessment sitting refers to the OctoberlNovember assessment sitting only, but in exceptional cases candidates, who are medically unfit or absent for other valid reasons, may have the supplementary assessment regarded as part of the same sitting.

Replace it with a new paragraph 12(3):

To qualify for matriculation endorsement, full-time candidates for the Senior Certificate must, 111 accordance with the matriculation endorsement requirements as stipulated in the Matriculation Endorsement and Exemption Regulations, *Government Gazette, Vol.* 426, *No.* 21805 of J December 2000, as amended in *Government Gazettes, Vol.* 448, *No.* 23900 of 11 October 2002 and *No.* 25506 of 26 September 2003, enter for at least six subjects at one and the same assessment examination sitting. An examination sitting refers to the May/June examination sitting only.

4. Repeal paragraph 13(5):

The common deadline for the registration of full-time candidates should be 15 March of the year of the examination. No registrations should be accepted after this date unless there are exceptional circumstances and the Head of Department or his or her representative approves such registration based on the exceptional circumstance. Candidates who wrote the supplementary examination and were unsuccessful will be given 15 working days following the release of the supplementary results to register for the examination.

Replace it with a new paragraph 13(5):

The common deadline for the registration of full-time candidates should be 31 January of the year of the examination. No registrations should be accepted after this date unless there are exceptional circumstances and the Head of Department or his or her representative approves such registration based on the exceptional circumstance.

5. Repeal paragraph 15(3):

A fee may be levied for the supplementary examination. In a case where a candidate is absent from the OctoberlNovember examination owing to medical or other special reasons, the assessment fee paid for the OctoberlNovember examination will be carried over to the supplementary assessment.

6. Repeal *paragraph 23(1):*

A candidate, who did not register for a subject in the November examination, may not be permitted to be examined in an examination in that subject in the supplementary examination.

7. Repeal *paragraph 23(2):*

Only the following candidates qualify for the supplementary examination, including:

- (a) A candidate who becomes ill during the OctoberlNovember examination, on condition that he/she produces a medical certificate;
- (b) A candidate who has not met the minimum promotion requirements in the examination but requires one subject to obtain a final promotion.

 Such a candidate may register for a maximum of two subjects;
- (c) A candidate who obtains a conditional exemption, i.e. one requirement short of a Senior Certificate with endorsement will be allowed to register for a maximum of two subjects; and
- (d) A candidate who provides documentary evidence that he/she qualifies for admission to university or any other higher education institution but does not satisfy the higher education faculty/department/subject requirements. Such a candidate will be allowed to register for a maximum of two subjects.

Replace it with a new paragraph 23(2):

Only the following candidates qualify for the last supplementary examination to be conducted for the last time in May/June 2008:

- (a) A candidate who becomes ill during the OctoberlNovember 2007 examination, on condition that he/she produces a medical certificate;
- (b) A candidate who has not met the minimum promotion requirements in the examination but requires one subject to obtain a final promotion. Such a candidate will not be limited to a pre-determined number of subjects;
- (c) A candidate who obtains a conditional exemption, i.e. one requirement short of a Senior Certificate with endorsement may register for the Senior Certificate examination in May/June 2008 as a supplementary examination. Such a candidate will not be limited to a pre-determined number of subjects, however, will be restricted to subjects and grades for which he/she has registered in the November 2007 examination sitting; and
- (d) A candidate who provides documentary evidence that he/she qualifies for admission to university or any other higher education institution but does not satisfy the higher education faculty/department/subject requirements. Such a candidate will not be limited to a pre-determined number of subjects, however, will be restricted to subjects and grades for which they have registered in the November 2007 examination sitting.

8. Repeal *paragraph 23(3):*

In the case of a death in the family or other special reasons for absence, admission to the supplementary examination is at the discretion of the Head of Department.

Replace it with a new paragraph 23(3):

In the case of a death in the family or other special reasons for absence, admission to the May/June 2008 supplementary examination is at the discretion of the Head of Department.

9. RepeaJparagraph 23(4):

In the case where an irregularity is being investigated, provisional entry may be granted to the candidate concerned, pending the outcome of the investigation.

Replace it with a new paragraph 23(4):

In the case where an irregularity is being investigated, provisional entry to the May/June 2008 supplementary examination may be granted to the candidate concerned, pending the outcome of the investigation.

10. Repeal paragraph 23(5):

In cases where the reason for admission to the supplementary examination needs to be supported by documentary evidence, it is imperative that the Head of the Institution be requested to recommend or not recommend the admission of the candidate concerned.

Replace it with a new paragraph 23(5):

In cases where the reason for admission to the supplementary examination of May/June 2008 needs to be supported by documentary evidence, it is imperative that the Head of the Institution be requested to recommend or not recommend the admission of the candidate concerned.

11. Repeal paragraph 23(6):

Candidates must write the supplementary examination on the same grade as the grade on which the subject was examined in the November examination.

Replace it with a new paragraph 23(6):

Candidates must write the May/June 2008 supplementary examination on the same grade as the grade on which the subject was examined in the October/November 2007 examination.

12. Repeal paragraph 29(1):

- (1) The Department of Education and assessment bodies must ensure that:
 - (a) Examiners in the respective subjects set the question papers and prepare the memoranda for the question paper concerned, for the final and the supplementary examination as well as an additional question paper;
 - (b) The October/November external question paper and the supplementary question paper are set at the same time so as to ensure that the standard of both these papers is the same;

13. Repeal paragraph 48(1):

A candidate may apply for the re-marking or re-checking of his or her assessment scripts, within thirty (30) days of the official release of results by the MEC. This applies to both the October/November and supplementary examinations.

Replace it with a new paragraph 48(1):

A candidate may apply for the re-marking or re-checking of his or her examination scripts, within thirty (30) days of the official release of results by the MEC. This applies to both the OctoberlNovember 2007 examinations of May/June 2008.

14. Repeal No.5 in Annexure A.-

Should no mark be received at the time of release, assessment centres will be given another opportunity to submit CASS marks together with an acceptable explanation. This must be completed within three (3) months of the publication of results or prior to the release of the next supplementary examination results, if and where applicable.

 - (a) The candidate produces documentary evidence in support of his request and submits a copy thereof to the assessment body, within 14 days from the date on which the specific examination was written;
 - (b) The Head of the Institution countersigns the evidence; and
 - (c) The Head of the Institution makes a recommendation on whether the candidate should be permitted to write the examination.
- (4) [f a candidate does not write a final examination for reasons other than an injury or illness, such as participating in international sports fixtures, the candidate may apply for special permission as stipulated in subregulation (2). The assessment body may arrange for a special examination session or allow such candidates to write the supplementary examination.
- (5) The assessment body may provisionally grant a candidate admission to the supplementary examination in the case where an irregularity regarding the candidate is being investigated.

- (6) If in the case of subregulation (5), the candidate is found guilty, the results of the supplementary examination are declared null and void.
- (7) A candidate may not change a subject or grade in the supplementary examination.
- (8) A candidate who did not write the examination or part thereof due to the reasons stated in subregulation 2(a) and (e), may be granted permission to write the supplementary examination only in the paper or papers that he or she did not write.

Replace it with a new paragraph 46:

Supplementary Examinations

- (I) A full time candidate who did not register for a subject in the OctoberlNovember 2007 examination, may not be permitted to write an examination in that subject in the May/June 2008 examination.
- (2) Only the following candidates qualify for the May/June 2008 supplementary examination:
 - (a) A candidate who becomes ill during the OctoberlNovember
 2007 examination, on condition that he or she produces a medical certificate;
 - (b) A candidate who has not met the minimum promotion requirements in the examination but requires one subject to meet the full promotion requirements. Such a candidate will not be limited to a pre-determined number of subjects;
 - (c) A candidate who obtains a conditional exemption, i.e, one requirement short of a Senior Certificate with endorsement.

 Such a candidate will not be limited to a pre-determined number

of subjects, however, will be restricted to subjects and grades for which he/she has registered in the October/November 2007 examination sitting;

- (d) A candidate who provides documentary evidence that he or she qualities for admission to university or any other higher education institution but does not satisfy the higher education faculty/department/subject requirements. Such a candidate will not be limited to a pre-determined number of subjects, however, will be restricted to subjects and grades for which they have registered in the November 2007 examination sitting.; and
- (e) In the case of a death in the family or other special reasons for absence, admission to the MaylJune supplementary examination is at the discretion of the Head of Department.
- (3) An assessment body may permit a candidate who is unable to write the final October/November 2007 examination due to an injury or illness or any other valid reason, to write the MaylJune 2008 examination based on the following conditions:
 - (a) The candidate produces documentary evidence in support of his request and submits a copy thereof to the assessment body, within 14 days from the date on which the specific examination was written;
 - (b) The Head of the Institution countersigns the evidence; and
 - (c) The Head of the Institution makes a recommendation on whether the candidate should be permitted to write the examination.
- (4) If a candidate does not write a final October/November 2007 examination for reasons other than an injury or illness, such as

participating in international sports fixtures, the candidate may apply for special permission as stipulated in sub-regulation (2). The examination body may arrange for a special examination session or allow such candidates to write the supplementary examination.

- (5) The examination body may provisionally grant a candidate admission to the May/June 2008 supplementary examination in the case where an irregularity regarding the candidate is being investigated.
- (6) If in the case of subregulation (5), the candidate is found guilty, the results of the May/June 2008 examination are declared null and void.
- (7) A candidate may not change a subject or grade in the May/June 2008 supplementary examination.
- (8) A candidate who did not write the examination or part thereof due to the reasons stated in subregulation 2(a) and (e), may be granted permission to write the May/June 2008 supplementary examination only in the paper or papers that he or she did not write.

(9) Repeal Annexure A, No.(a):

Candidate found in possession of unauthorised material during the examination session:

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the supplementary examinations.

Replace it with a new Annexure A, No. (a):

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the examination of May/June 2008.

10. Repeal *Annexure A, No.(b):*

Candidate found in possession of unauthorised electronic device during the examination session:

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the supplementary examinations.

Replace it with a new Annexure A, No. (b):

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the examinations of May/June 2008.

II. Repeal Annexure A, No.(c):

Candidate caught copying or obtaining help from a fellow candidate:

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the supplementary examinations.

Replace it with a new Annexure A, No. (c):

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the examinations of May/June 2008.

12. Repeal *Annexure A, No.(e):*

Presentation of fraudulent identification or impersonation:

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the supplementary examinations.

Replace it with a new Annexure A, No. (e):

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the examinations of May/June 2008.

13. Repeal *Annexure A, No.(f):*

Assistance provided by invigilator, teacher or principal to candidate

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the supplementary examinations.

Replace it with a new Annexure A, No. (f):

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the examinations of May/June 2008.

14. Repeal Annexure A, No. (71):

Two examination scripts with the same examination number:

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the supplementary examinations.

Replace it with a new Annexure A, No. (h):

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the examinations of May/June 2008.

15. Repeal *Annexure A, No.(j):*

Script removed from examination room and submitted later:

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the supplementary examinations.

Replace it with a new Annexure A, No. (j):

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the examinations of May/June 2008.

16. Repeal Annexure A, No. (k):

Submission of work that is not candidate's own work:

The candidate may be barred from a minimum of one and a maximum of three subsequent examinations, excluding the supplementary examinations.
