NOTICE OF INTENT

NATIONAL ROAD R21: SECTIONS 1 AND 2: NOTICE OF INTENTION TO DECLARE THAT SECTION OF THE NATIONAL ROAD R21 FROM THE HANS STRYDOM DRIVE TO THE RIETFontein INTERCHANGE AS A CONTINUOUS TOLL ROAD

In terms of Section 27(4)(a) of The South African National Road Agency Limited (SANRAL) and National Roads Act, 1998 (Act No. 7 of 1998), The South African National Roads Agency Limited hereby gives notice of its intention to recommend to the Minister of Transport the declaration of the following National Road section as a toll road:

A Portion of existing National Road R21: Sections 1 and 2, commencing from the common cadastral boundary of Portion 20 of the farm Waterkloof No. 378-JR and the Remainder of Portion 11 of the farm Waterkloof No. 378-JR, from where it proceeds in a southerly direction along the existing National Road R21: Sections 1 and 2, up to the existing National Road N12 section 19 as declared by Government notice no. 1322 of 1989 at a point on the Remainder of Portion 580 of the farm Klipfontein No. 83-IR and declared as a national road in terms of Government Gazette no: 30961 as per Government notice no: 409, 11 April 2008.

The total length of the proposed toll road is approximately 43 km. The route and approximate positions of the toll plazas, being the place at which the liability to pay toll will be recorded, are depicted on the attached plan. In this regard it is recorded that as the toll road will operate on the basis of open road tolling, there will be no requirement on motorists to stop and pay toll at the toll plaza, but rather the toll plaza, which will merely be a portal fixed over the road, will electronically record the liability to pay toll.

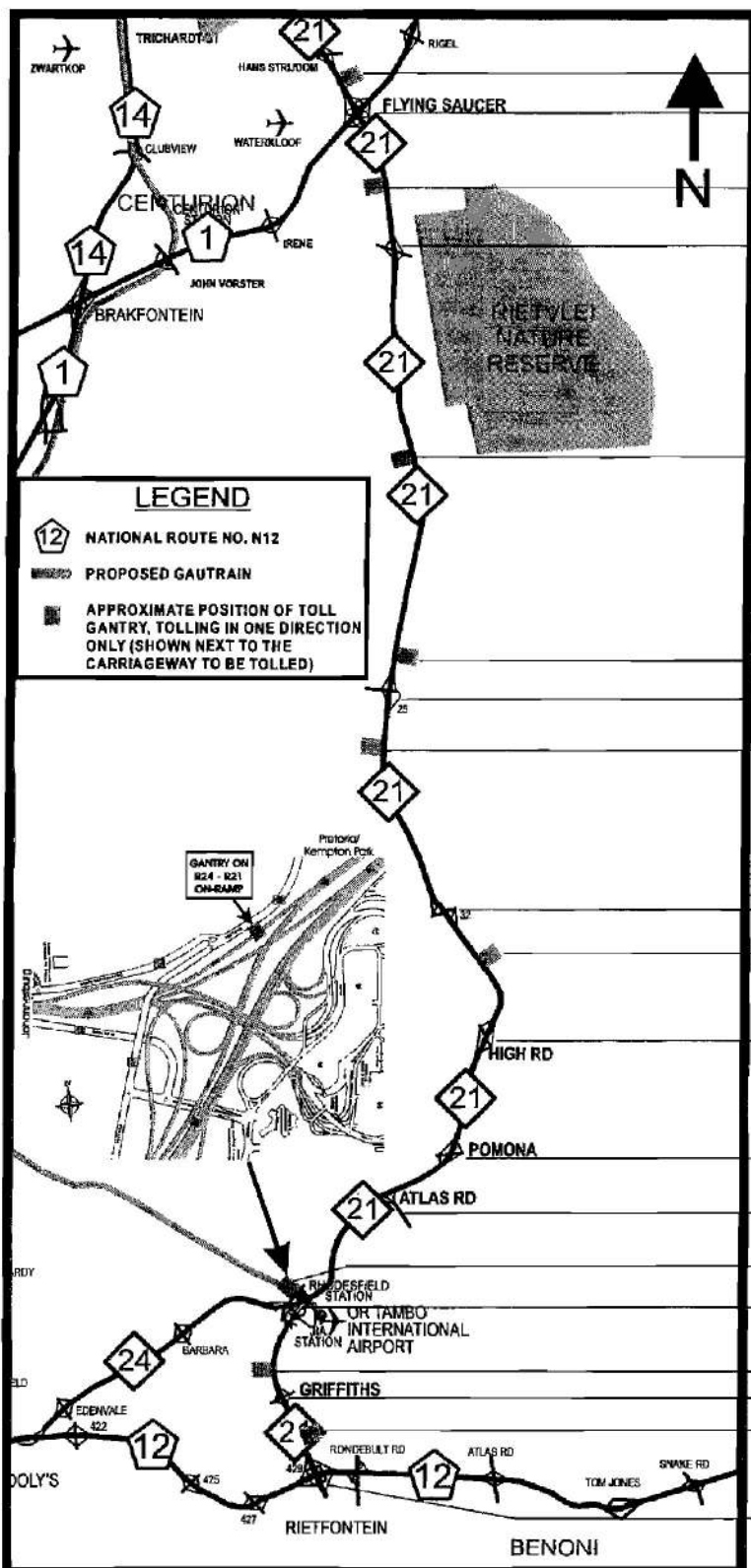
In terms of Section 27(4)(a)(ii) of the said Act all interested persons are hereby invited to comment and make written representations, by 21 May 2008 ("closing date"), being a date not less than 30 days from the date of this notice. All written representations must reflect the details of the proposed toll road in question and as described in this notice and must be addressed to the Regional Manager, Northern Region, The South African National Roads Agency Limited ("SANRAL") and be:

- telefaxed to the following number 086 647 0695; and/or
- posted to the following postal address, PostNet Suite 129, Private Bag X19, Menlo Park, 0102, save that SANRAL shall not be obliged to take into account any representations sent by post but not actually received and processed by SANRAL by the closing date, for whatever reason; and/or
- delivered to SANRAL, Northern Region, 38 Ida Street, Menlo Park, 0081 and deposited in the dedicated box available for purposes of written representations, save that SANRAL shall not be obliged to take into account any written representations delivered to the aforementioned address but which have not been deposited in the box provided for this purpose.

SANRAL shall only consider written representations forwarded to them in the manner contemplated above and which are actually received and processed by the closing date. All other representations may be disregarded.

KENNISGEWING VAN VOORNEME

NASIONALE PAD R21: SEKSIES 1 EN 2: KENNISGEWING VAN VOORNEME OM DAARDIE GEDEELTE VAN DIE BESTAANDE NASIONALE PAD R21 VANAF HANS STRYDOM RYLAAN TOT DIE RIETFONTEIN WISSELAAR AS 'N AANEENLOPENDE TOLPAD TE VERKLAAR

Ingevolge Artikel 27(4)(a) van die Wet op Die Suid-Afrikaanse Nasionale Padagentskap Beperk (SANRAL) en Wet op Nasionale Paaie, 1998 (Wet No: 7. van 1998), maak Die Suid-Afrikaanse Nasionale Padagentskap Beperk hiermee sy voorneme bekend om by die Minister van Vervoer aan te beveel dat die volgende gedeelte Nasionale Pad tot 'n tolpad verklaar word:

'n Gedeelte van die bestaande Nasionale Pad R21: Seksies 1 en 2, beginnende vanaf die gemeenskaplike kadastrale grens van Gedeelte 20 van die plaas Waterkloof no. 378-JR en die Restant van Gedeelte 11 van die plaas Waterkloof no. 378-JR, vanwaar dit verder gaan in 'n suidelike rigting op die bestaande Nasionale Pad R21: Seksies 1 en 2, tot by die bestaande Nasionale roete N12 seksie 19 soos verklaar deur Goewernmentskennisgewing no. 1322 van 1989 by 'n punt op die Restant van Gedeelte 580 van die plaas Klipfontein no. 83-IR en as nasionale pad verklaar is in Staatskoerant no: 30961 van Goewernmentskennisgewing no: 409, 11 April 2008.

Die totale lengte van die voorgestelde tolpad is ongeveer 43 km. Die roete en benaderde ligging van die tol plazas, wat die posisies aantoon waar motoriste se aanspreeklikheid om tol te betaal aangeteken word, is aangeloon op die aangehegte plan. In hierdie opsig word dit aangeteken dat die tolpad sal funksioneer op die beginsel van 'n oop pad tol stelsel. Daar sal nie van motoriste verwag word om te stop en tol te betaal by die tolplaza nie, maar die tolplaza, wat uit 'n portaal gevestig oor die pad bestaan, sal elektronies die aanspreeklikheid om tol te betaal aanteken.

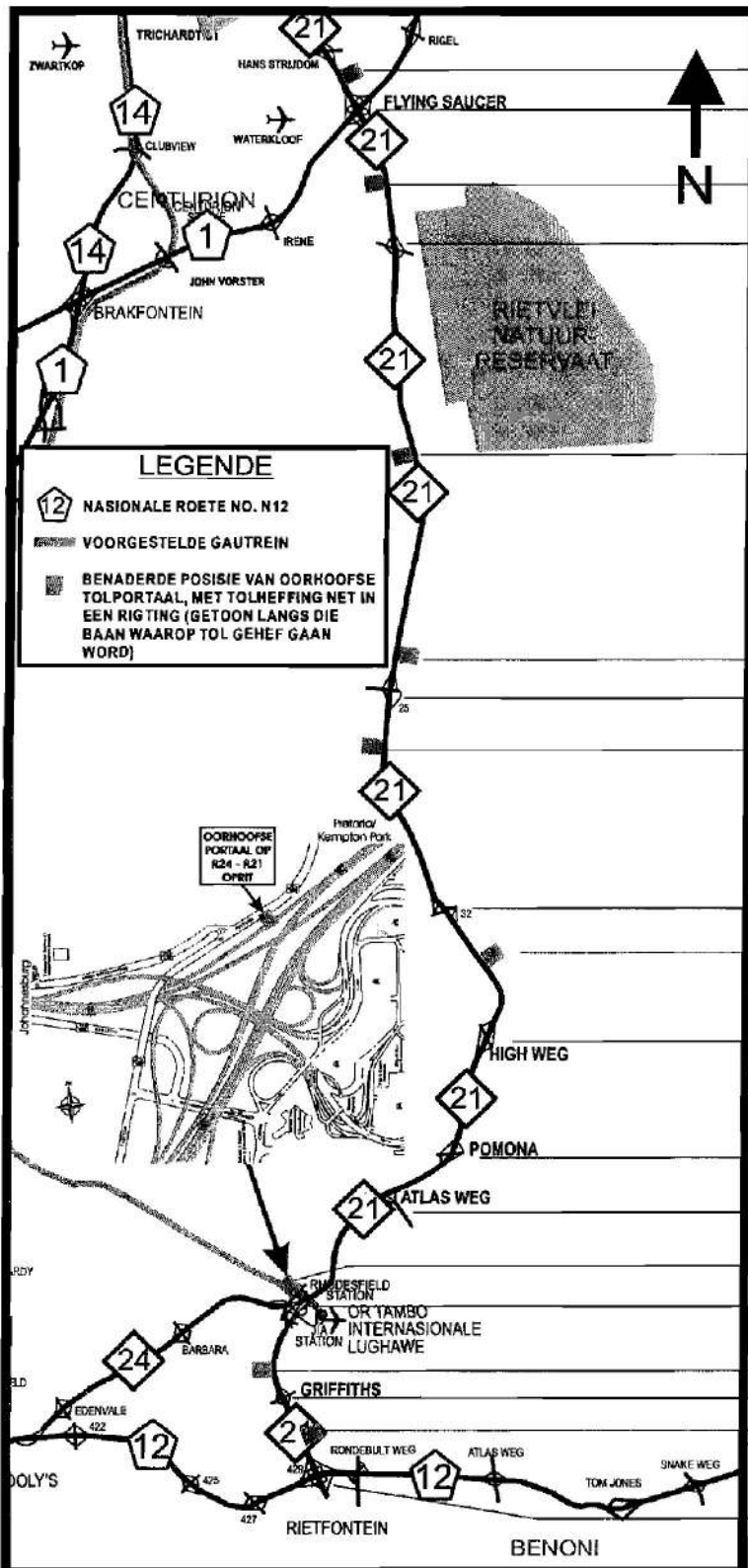
Ingevolge Artikel 27(4)(a)(ii) van die voorgemelde Wet word alle belanghebbendes uitgenooi om kommentaar en skriftelike versoë teen 21 Mei 2008 ("sluitings datum") aan te teken, 'n datum nie minder as 30 dae vanaf die datum van hierdie kennisgewing nie. Alle skriftelike versoë moet die besonderhede van die voorgestelde tolpad ter sprake en soos beskryf in hierdie kennisgewing, bevat, en moet gerig word aan die Streekbestuurder: Noordelike Streek, Die Suid-Afrikaanse Nasionale Padagentskap Beperk ("SANRAL") en moet:

- gefaks word na die volgende nommer 086 647 0695, en/of
- gepos word na die volgende posadres, PostNet Suite 129, Privaatsak X19, Menlopark, 0102, met dien verstande dat SANRAL nie verplig sal wees om enige versoë wat gepos is, maar nie fisies ontvang en verwerk is teen die sluitingsdatum nie vir welke rede ookal, in berekening te neem nie; en/of
- afgelewer by SANRAL, Noordelike Streek, Idastraat 38, Menlopark, 0081 en geplaas is in die toegewysde bus vir die doel van skriftelike versoë, met dien verstande dat SANRAL nie verplig sal wees om enige skriftelike versoë wat by die bogenoemde adres afgelewer is, maar nie in die toegewysde bus geplaas is, in berekening te neem nie.

SANRAL sal slegs geskrewe versoë deurgestuur aan hulle in die wyse soos omskryf hierbo en wat fisies ontvang en verwerk is teen die sluitingsdatum in berekening neem. Alle ander versoë mag verwerp word.
