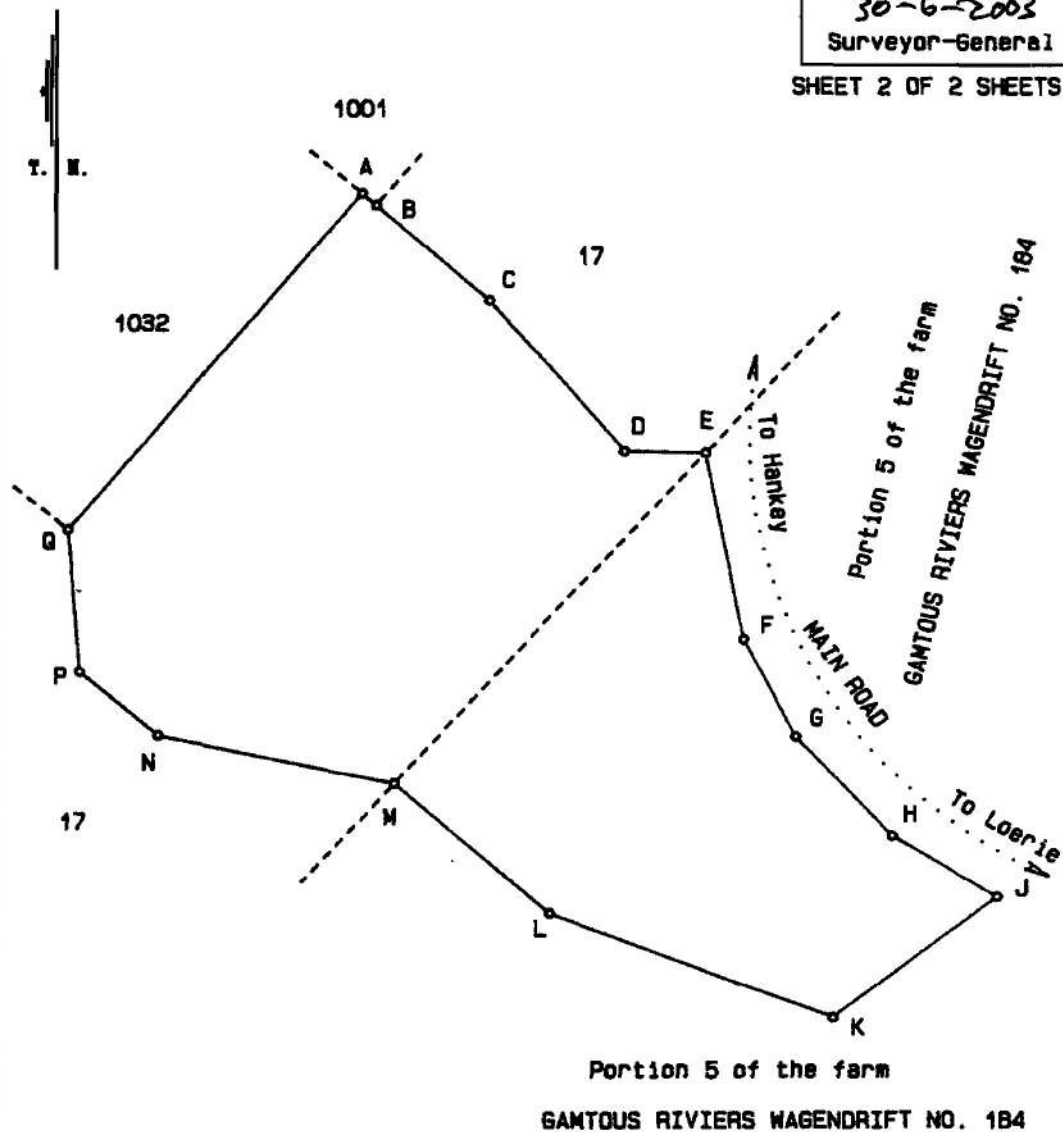

SCHEDULE

VARIATION OF POLICYHOLDER PROTECTION RULES (LONG-TERM INSURANCE), 2004

Section 62, Long-term Insurance Act, 1998

[Note: in this Schedule words in bold between brackets indicate deletions from, and words underlined indicate insertions in, the relevant existing enactment.]

Interpretation

1. In this Schedule "the Rules" means the Policyholder Protection Rules (Long-term Insurance), 2004, as published by GN No. R. 8070 in Gazette No. 26854 of 30 September 2004.

Variation of Rule 16

2. The following Rule is hereby substituted for Rule 16 of the Rules:

"Rejection of claims

16.1 An insurer ~~[shall ensure that,]~~ must where a decision [It rejects a] rejecting any claim [for a benefit] under a policy is made after 1 November 2008, or where [It disputes] the quantum of the benefit claimed [,] under the policy is in dispute after 1 November 2008, ensure that the ~~[person entitled to claim the benefit] policyholder concerned~~ is notified in writing of the reasons for ~~[the rejection]~~ such decision. ~~[or the calculation of the quantum, as the case may be. The person entitled to claim the benefit may within not less than 90 days after the date of such notification, make representations to the insurer in respect of the insurer's decision, but nothing in this subrule shall be construed as limiting any contractual or other right any party may have in regard to any claim for policy benefits.]~~ The insurer must, simultaneously with the above, notify the policyholder concerned in writing that the latter may, within 180 days of the date of the communication of the relevant decision, or such longer period as may be arranged for in the policy document,

- (i) make representations to the relevant insurer; or
- (ii) institute legal action,
regarding such decision.

16.2 If a claim is rejected or a quantum is disputed as contemplated in rule 16.1 on behalf of an insurer by a person other than that insurer, such other person must provide the ~~[rejection]~~ notice contemplated in that rule, provided that such ~~[rejection]~~ notice must also contain the name and contact details of the insurer and state that any recourse or enquiries must be directed directly to that insurer."

Short title

3. This Notice is called The Policyholder Protection Rules (Long-term Insurance) Variation Notice, 2008.

SCHEDULE B**MEMORANDUM OF REASONS FOR AND OBJECTS OF VARIATION OF RULE 16 OF THE POLICYHOLDER PROTECTION RULES (LONG-TERM INSURANCE), 2004****Introductory**

1. Rule 16.1 currently determines that the insurer involved shall ensure that where a decision has been made as to the rejection of any claim under a policy or where the quantum of a claim is in dispute, the policyholder concerned must be informed of the reason for the decision in writing and that the policyholder has a period of not less than 90 days after the date of the relevant decision to make representations to the relevant insurer in respect of such a decision. The 90 days referred to above is in addition to any time-barring period contained in the policy for challenging the decision.

Reason

2. The main reason for proposing variations to Rule 16 of the Policyholder Protection Rules (PPRs) is based on specific comments that were made by some judges in a recent Constitutional Court case of B.P. Barkhuizen vs. R.S. Napier regarding the reasonableness and justifiability of the time-barring period for challenging the rejection of a claim. Although the case relates to a short-term policy the principles would similarly apply to a long-term policy.

Objective

3. If there was no provision for a time-barring clause in the Rules, the insured would, in terms of the Prescription Act have a period of three years from the date on which the debt becomes due to institute action against the insurer. The provisions of the Prescription Act were, however, tempered by the introduction of a time-barring clause in the PPRs. The time-barring clause introduced in the PPRs had the effect of shortening the three years period to 90 days within which a policyholder has to issue a summons after the rejection of his/her claim by an insurer or when he/she is not in agreement with the quantum of the claim.

4. The rationale for the introduction of the time-barring period in the PPRs was to ensure that claims come to the attention of insurers speedily and that insurers have the advantage of recency to be able to investigate the circumstances leading to the claim. One example of a consequence of not acting speedily could be that evidence can become unavailable or that an essential witness becomes unavailable or forgets the circumstances relating to the claim. However, the counter argument to the above is that while the need for acting speedily is clearly important, the consequences of failing to claim timeously could be to the detriment of the insured. The proposed 180 days time-barring period is an attempt to be fair and reasonable to both insurers and insured persons.

5. As far as the nature and extent of the limitation is concerned, the time-barring period for challenging the rejection of a claim or disputing the quantum of a claim, involves a far-reaching and drastic protection of the insurer to the detriment of the insured. The challenge was for the regulator to decide whether to take action to address this matter.

Decision

6. After deliberations with the industry representative body and consultations with the Advisory Committee on Long-term Insurance it was agreed that the current minimum requirement of a 90 days time-barring period be replaced with a minimum 180 days time-barring period to challenge the rejection of a claim or dispute the quantum of a claim.

Commencement

7. It is currently expected that the so varied rule 16 will come into operation on 1 November 2008.

NOTICE 489 OF 2008**INTERNATIONAL TRADE ADMINISTRATION COMMISSION OF
SOUTH AFRICA****SUNSET REVIEW OF THE ANTI-DUMPING DUTIES ON LYSINE ORIGINATING IN OR
IMPORTED FROM THE UNITED STATES OF AMERICA: FINAL DETERMINATION**

In accordance with the provisions in Article 11.3 of the World Trade Organisation Agreement on Implementation of Article VI of the General Agreement on Tariffs and Trade, any definitive anti-dumping duty shall be terminated on a date not later than five years from its imposition, unless the authorities determine, in a review initiated before that date, on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry within a reasonable period of time prior to that date, that the expiry of the duty would likely lead to continuation or recurrence of dumping and injury.

On 26 May 2006 the International Trade Administration Commission of South Africa (the Commission) notified the interested parties through Notice No. 673 of 2006 in *Government Gazette* No. 28847, that unless a substantiated request is made indicating that the expiry of the anti-dumping duties on lysine originating in or imported from the United States of America (USA) would likely lead to the continuation or recurrence of dumping and injury, the anti-dumping duties on lysine originating in or imported from the USA will expire on 25 January 2007.

The investigation was initiated through Notice No. 6 in *Government Gazette* No. 29521 on 12 January 2007. The investigation was initiated after the Commission considered that there was *prima facie* proof that expiry of the duties would likely lead to the continuation or recurrence of dumping of the subject product originating in or imported from the USA and that there was *prima facie* proof of the likely continuation and/or recurrence of material injury.

After considering all parties' comments and representations in respect of the "essential facts" letters, the Commission made a final determination that the expiry of the duties is likely to lead to the continuation or recurrence of dumping of the subject product originating in or imported from the USA and that the expiry of the duties is likely to lead to the continuation or recurrence of material injury.

The Commission, therefore, recommended to the Minister of Trade and Industry that the anti-dumping duties on lysine originating in or imported from the USA, be maintained.

The Commission's detailed reasons for its decision are set out in Commission Report No.248 (Final report).

BILL

To amend the Air Traffic and Navigation Services Company Act, 1993, so as to amend a definition; to substitute or delete certain obsolete references; to provide that the objects of the company are as set out in its memorandum of association; to make it clear that the company has the powers of a company registered in terms of the Companies Act, 1973, subject to the limitations in the Air Traffic and Navigation Services Company Act, 1993; to limit the level of financial risk posed to the core services of the company by its other services; to ensure that air traffic services and air navigation services are provided; to provide for the provision of services outside the Republic; to make it clear that the company may raise or receive income from sources other than air traffic service charges; to delete the restriction on the alienation or encumbrance of assets transferred to the company; to delete the requirement to submit a business plan to the Shareholding Minister and to provide for the requirement to submit an annual budget and corporate plan in accordance with the Public Finance Management Act, 1999; to refine the provisions regarding the annual report and financial statements and their contents in compliance with the Public Finance Management Act, 1999; to delete the restriction on the sale of expropriated land; to refine the provisions regarding certain orders by the Minister and to decriminalise the breach of such order; to adjust the provisions regarding the economic regulation of the company, the sale or closure of air navigation infrastructure and the curtailment of air traffic services or air navigation services by the company; to enhance the provisions relating to the company's failure to comply with the Act; to limit the Minister's general regulation-making powers; to further regulate expropriation by the company in accordance with the Expropriation Act,

1975; to delete certain obsolete transitional and other provisions; to amend the long title; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:-

Amendment of section 1 of Act 45 of 1993, as amended by section 19 of Act 98 of 1996

1. Section 1 of the Air Traffic and Navigation Services Company Act, 1993 (in this Act referred to as the principal Act), is hereby amended by the substitution for the definition of "air traffic service charge" of the following definition:

"'air traffic service charge' means an amount levied by the company on an operator of an aircraft or an aerodrome in connection with the use of any air navigation infrastructure by, or the provision of any air traffic service or any air navigation service to, such operator;".

Amendment of section 2 of Act 45 of 1993

2. Section 2 of the principal Act is hereby amended by the substitution for paragraph (c) of subsection (7) of the following paragraph:

- "(c) The majority of the non-executive directors shall be persons who are –
- (i) not officers [~~or employees~~] as defined in section 1 of the Public Service Act, [1984 (Act No. 111 of 1984)] 1994 (Proclamation No. 103 of 1994); or
 - (ii) not persons deemed to be such officers in terms of section 1(a) of the Public Service Amendment Act, 1996 (Act No. 13 of 1996)."

Amendment of section 3 of Act 45 of 1993

3. Section 3 of the principal Act is hereby amended by the substitution in subsection (4) for the expression "State President" of the expression "President".

Substitution of section 4 of Act 45 of 1993

4. The following section is hereby substituted for section 4 of the principal Act:

"Objects of company"

4. The objects of the company are as set out in its memorandum of association in accordance with the Companies Act, 1973 (Act No. 61 of 1973)."

Amendment of section 5 of Act 45 of 1993, as amended by section 20 of Act 98 of 1996**5. Section 5 of the principal Act is hereby amended –**

- (a) by the substitution for subsection (1) of the following subsection:

"(1) The company shall have the powers of a company as contemplated in section 34 of the Companies Act, 1973 (Act No. 61 of 1973), unless expressly excluded or qualified by this Act."

- (b) by the substitution for paragraph (b) of subsection (2) of the following paragraph:

"(b) not unduly discriminate against or among various users or categories of users of any air navigation infrastructure, [or] air traffic services or air navigation services;"

- (c) by the deletion of paragraph (c) of subsection (2);

- (d) by the deletion of the word "and" at the end of paragraph (f) of subsection (2);

- (e) by the addition to subsection (2) of the following paragraphs:

"(g) provide any service other than an air traffic service or an air navigation service in a manner which will not substantially adversely affect the provision of any air traffic service or any air navigation service or expose any air traffic service or any air navigation service to substantial financial risk;

(h) not later than 18 months after the commencement of the Air Traffic and Navigation Services Company Amendment Act, 2001, adopt such accounting practices and such other measures as are necessary to distinguish in a reasonable manner any income and costs or any shared income and costs between the air traffic services and the air navigation services on the one hand and, on the other hand, other services of the company and of every affiliate, as the Committee reasonably requires;

(i) ensure that any services outside the Republic are provided by an affiliate of the company and in a manner which will not

- substantially adversely affect the provision of any air traffic service or any air navigation service or expose any air traffic service or any air navigation service to substantial financial risk;
- (j) ensure that air traffic services and air navigation services are provided subject to section 11(7)(b).";
- (f) by the insertion after subsection (2) of the following subsection:
- "(2A) In subsection (2)(h) and (i) 'affiliate', in relation to the company, means –
- (a) another company which is –
- (i) the holding company, as described in section 1(4) of the Companies Act, 1973 (Act No. 61 of 1973), of the company;
- (ii) a subsidiary, as described in section 1(3) of the Companies Act, 1973, of the company; or
- (iii) a subsidiary of the company's holding company; or
- (b) another company, or another juristic person, other than a holding company or subsidiary referred to in paragraph (a), in respect of which the company has the power to exercise substantial influence."; and
- (g) by the substitution for subsection (3) of the following subsection:
- "(3) Without limiting its powers referred to in subsection (1), the company shall have the power to raise or receive income from sources other than air traffic service charges, including, but not limited to, the power to enforce any contract providing for such raising or receipt of income."

Amendment of section 6 of Act 45 of 1993

6. Section 6 of the principal Act is hereby amended –
- (a) by the deletion of paragraph (b) of subsection (1);
- (b) by the deletion of subsections (3) and (4); and
- (c) by the substitution for subsection (13) of the following subsections:
- "(13) Unless otherwise provided for in this Act or approved by the Committee, the company shall not alienate or encumber, otherwise than in the normal course of its business, assets transferred to the company in terms of subsection (1)(a) [having a value of more than 10 per cent of the value contemplated in subsection (5)].

 - (iii) a combination of the limits mentioned in subparagraphs (i) and (ii); and
- (b) prescribe in respect of any air navigation infrastructure[s], any air traffic service[s] or any air navigation service[s], service standards which shall conform to internationally accepted and recommended practices.

(8) The Committee shall, subject to subsection (11)(a), not amend any condition in respect of the last two financial years of a permission mentioned in subsection (2) which will be replaced by the permission to be issued in terms of subsection (5).

(9) In exercising any power in terms of subsection (7), the Committee may –

- (a) consult with interested parties as it thinks fit;
- (b) limit increases in the air traffic service charges that may be levied in any manner as it thinks fit; and
- (c) adjust any future air traffic service charge to the extent that the air traffic service charge published for the immediately preceding year deviated from the air traffic service charge contained in the relevant permission.”;

- (c) by the substitution for the words preceding paragraph (a) of subsection (10) of the following words:

"The Committee shall perform its [functions] duties and exercise its powers in terms of [subsection (7)] this Act in such manner as [it deems] is best calculated to –";

- (d) by the substitution for paragraph (b) of subsection (10) of the following paragraph:

"(b) promote reasonable interests and needs of users of [any] air navigation infrastructure, [or] air traffic services or air navigation services";

- (e) by the substitution for paragraph (e) of subsection (10) of the following paragraph:

"(e) ensure that the company, after taking into consideration any compensation paid or to be paid to the company by the State in terms of the provisions of this Act or any other law, is able to finance its obligations and have a reasonable prospect of earning a commercial return for each financial year on capital employed."; and

- (f) by the substitution for subsection (11) of the following subsection:

"(11) The Committee may, after consultation with the company and other interested parties, amend –

(a) any condition mentioned in subsection (7) in respect of the last two financial years of the period of validity of a permission mentioned in subsection (2), if the Minister approves such amendment;

(b) any condition mentioned in subsection (7) other than a condition contemplated in paragraph (a) of this subsection, if the Minister approves such amendment."

(a) is efficient and orderly; and

(b) ensures the safety of aviation and security of people.

(3C) If the company fails to provide any air traffic service or any air navigation service in accordance with subsection (3B), the Committee may take all reasonable steps to ensure such provision, including the provision of such service by a person other than the company.”;

- (b) by the substitution for the words preceding paragraph (a) of subsection (4) of the following words:

"The Committee shall not act under subsection [(3)(b), (c) or (d)] (3A) or (3C) unless –"; and

- (c) by the addition of the following subsection:

"(5) For the purpose of any investigation or adjudication contemplated in this section the Committee shall have such powers with regard to the summoning and examination of witnesses, the confidentiality of information and the production of documents and objects as may be prescribed by regulation under section 14(1)."
