## NOTICE 911 OF 2008

### AMENDMENT NOTICE IN TERMS OF THE RESTITUTION OF LAND RIGHTS ACT, 1994 (ACT NO. 22 OF 1994), AS AMENDED

Notice is hereby given in terms of section 11A(4) of the Restitution of Land Rights Act, Act No. 22 of 1994, as amended, that, with effect from the date of this notice, General Notice No. 1665 of 2004 contained in Government Gazette No. 26663 dated 20 August 2004 ("the original notice"), as amended by Notice 536 of 2005 contained in Government Gazette No. 27470 dated 15 April 2005 ("the first amending notice"), is amended by –

1. deleting the first four paragraphs of the original notice and substituting for them the following:

Notice is hereby given in terms of section 11(1) of the Restitution of Land Rights Act, Act No. 22 of 1994, as amended, that claims for restitution of land rights have been lodged on the under-mentioned farms in Limpopo and Mpumalanga Provinces by -

- 1.1. the Legal Resources Centre on behalf of the Moletele Tribe, a claim submitted to the Advisory Commission on Land Allocation dated 30 July 1992;
  - 1.2. Boy Annos Chiloane (Segodi) apparently on behalf of the Malekane Tribal Community (Authority) dated 8 November 1995;
  - 1.3. Abuthi Lackson Chiloane on behalf of Moletele Tribe dated 3 July 1995;
  - 1.4. Mpowane Gilbert Moraba on behalf of Baropodi ba Moraba dated 7 November 1998;
