FINANCIAL ADVISORY AND INTERMEDIARY SERVICES ACT, 2002 (ACT NO. 37 OF 2002)

EXEMPTION OF RENAISSANCE SPECIALIST FUND MANAGERS REGARDING FINANCIAL SOUNDNESS

I, Dube Phineas Tshidi, Registrar of Financial Services Providers, hereby exempt under section 44(4) of the Financial Advisory and Intermediary Services Act, 2002 (Act No. 37 of 2002), Renaissance Specialist Fund Managers (Pty) Ltd ("Renaissance Specialist Fund Managers") until 31 October 2010 from paragraph 5(2) of the Determination of Fit and Proper Requirements for Financial Services Providers, 2006, subject to the condition that Renaissance Specialist Fund Managers must furnish the Registrar bi-annually with its financial management accounts.

The exemption may at any time-

- (a) be amended by the registrar by notice in the Gazette;
- (b) be withdrawn by the registrar in like manner.

This Notice is called the Notice on Exemption of Renaissance Specialist Fund Managers regarding financial soundness, 2008, and comes into operation on the date of publication in the *Gazette*.
