### GENERAL NOTICE

#### **NOTICE 28 OF 2009**

GENERAL NOTICE ON CONVERTED LICENCES IN TERMS OF SECTION 93 OF THE ELECTRONIC COMMUNICATIONS ACT (ACT NO.36 OF 2005)

The Independent Communications Authority of South Africa ("the Authority") hereby gives notice of the converted Broadcasting, Electronic Communications Services, Electronic Communications Network Services and Frequency Spectrum Licences in terms of section 93 of the Electronic Communications Act.

SCHEDULE 1 briefly sets out the process followed, findings and reasons for decisions.

The following schedules contain a list of converted licences:

- i. SCHEDULE 2 Broadcasting licences
- ii. SCHEDULE 3 Electronic Communications Services Licences
- iii. SCHEDULE 4 Electronic Communications Network Services Licence

As spectrum licences are renewable on an annual basis, the Authority has resolved not to include those in this process as they have already been aligned with the Act. However, the Authority will include in this process those spectrum licences which are affected by the re-positioning of obligations as contained in Schedule 5.

The licensees are notified to collect their licences from ICASA Head Office or Regional Offices from 16 January 2009. No converted licence will be emailed to licensees. A complete list of all converted licences will also be available on the ICASA website (www.icasa.org.za) and at the library, ICASA Head Office.

#### SCHEDULE 1

## LICENCE CONVERSION OF EXISTING LICENCES IN TERMS OF SECTION 93 OF THE ELECTRONIC COMMUNICATIONS ACT, 2005(ACT 36 OF 2005)

#### REASONS FOR DECISION

#### A. INTRODUCTION

- 1. The Independent Communications Authority of South Africa ("the Authority") hereby publishes this document for the purposes of concluding the conversion of electronic communication service (ECS), broadcasting service (BS) and electronic communications network service (ECNS) licences, in terms of section 93 of the Electronic Communications Act ("the Act")<sup>1</sup>.
- Over the past two years, the Authority has engaged in extensive consultation with key stakeholders, culminating in the issuing of converted licenses, as per the attached Schedules.
- In terms of section 2(a), the Act seeks to promote and facilitate convergence in the broadcasting, broadcasting signal distribution and telecommunications sectors.
- 4. Section 92(1) of the Act provides that all existing licences remain valid until converted by the Authority. In terms of section 1 of the Act, existing licences are those that were issued prior to the coming into effect of the Act on 19 July 2006. However, the Authority has decided to also convert licences that were granted after the 19th July 2006<sup>2</sup> since they were licensed in terms of the VANS regulations which according to the Act remain valid until amended or repealed.
- 5. In the repealed legislative dispensation, the Authority issued a composite licence that allowed a licensee to both provide services and operate a network. The current licensing framework empowers the Authority to issue up to four separate licences, namely, the electronic communications services,

broadcasting services, electronic communication network services and frequency spectrum licences<sup>3</sup>.

#### B. LEGISLATIVE CONTEXT

- 1. The Authority is established in terms of section 3 of the Independent Communications Authority of South Africa Act<sup>4</sup>, as amended ("ICASA Act") to regulate broadcasting services, electronic communications services, electronic communications network services and postal services in the public interest<sup>5</sup>.
- 2. The Act repealed the Telecommunications Act<sup>6</sup>, Independent Broadcasting Act<sup>7</sup> in their entirety and amended some sections of the Broadcasting Act<sup>8</sup>.
- The Act provides that the Authority must convert existing licences by granting one or more new licences that comply with the Act on no less favourable terms<sup>9</sup>.
- 4. The Authority was required to convert all existing licences within 24 months of the coming into effect of the Act. The Authority could not complete the conversion process within the 24 months and utilised an additional period of six months as provided for in section 92(6) of the Act.
- 5. Section 93 (4) (b) of the Act empowers the Authority, in converting licences, to grant rights and impose additional obligations on the licensees to ensure that existing licences comply with the Act. Furthermore, obligations imposed on existing licensees under the previous legislative dispensation will continue to be in force until a review has been completed in terms of section 67(8) of the Act.
- 6. The Act lays down a framework which the Authority must use to convert existing licences. A licensee who provided both services and electronic communications facilities or network must be issued with separate licences for

the provision of electronic communications services or broadcasting services, electronic communications facilities or networks and for the use of the radio frequency spectrum<sup>10</sup>.

#### C. LICENCE CONVERSION PROCESS

- 1. On 30 August 2006 the Authority published a notice in Government Gazette 29168 in terms of section 93(3) of the Act containing a list of existing licences that were due for conversion.
- 2. The notice referred to above identify existing licensees, set out timeframes for conversion of the existing licensees, set out information to be provided by the licensees to the Authority and confirmed the right of licensees to participate in the conversion process. The notice did not fully set out the process for converting existing licensees.
- On 4 October 2007 the Authority published a notice in Government Gazette 30352 that amended and revised Government Gazette 29168 to provide for a detailed process of converting existing licences.
- On 18 October 2007, the Authority held a workshop with VANS licensees to consult with the existing licensees on the policy directives published by the Minister of Communications in 2008.
- 5. On 5 November 2007 a notice containing a list of existing licences was published in Government Gazette 30438. This notice invited licensees' comments on the proposed licences to be granted.
- 6. The Authority further published notices in Government Gazettes 30621, 30623 and 30624 on 21 December 2007 for the conversion of Value Added Network Services (VANS), Broadcasting services and Telecommunications services respectively. The Authority held hearings from the 17<sup>th</sup> to 19<sup>th</sup> March 2008 to deal with the submissions received from the VANS licensees regarding licences that were going to be issued to them subsequent to the conversion process.
- 7. The Authority held One-On-One Industry meetings from 24 January 2008 to 04 March 2008, wherein draft licences were presented to licensees for them

- to comment and to request licensees to provide information that would assist the Authority in the conversion process.
- 8. On 17 December 2008 the Authority continued to engage the industry to finalise outstanding issues related to their licences. The meeting considered location of obligations in respect of ECS, ECNS and frequency spectrum licences, implemented obligations and current and ongoing obligations. The meeting also considered parity between licensees and time-frames for the conversion process. Licensees were given an opportunity to comment. An opportunity was afforded for the submission of written comments.
- 9. On 19 December 2008, the Authority published a notice in Government Gazette 31746. The notice called for, amongst other things, information for the purposes of converting VANS into either class or individual licences. The closing date of the submission of information was 6 January 2009. Those licensees who did not submit information by the closing date will have their licences converted but not issued. The Authority has decided to give such licensees 90 working days from 19 January 2009 to 26 May 2009 to furnish the Authority with outstanding information. Failure to submit the required information will be a contravention of section 93(6) of the Act.
- 10. The Authority took into account information and representations submitted by licensees in the finalisation of the conversion process.

#### D. DECISIONS

- The approach taken by the Authority, in its engagement with stakeholders, was principally informed by the Act, applicable regulations and prevailing circumstances such as the need to enhance competition in the communications sector.
- The Authority took cognisance of the need to properly align all licences with the provisions of the Act, which provides that the conversion of licenses should be undertaken on no less favourable terms, provided such terms are consistent with the Act<sup>11</sup>.

- Where possible, the Authority attempted to create parity between similar licences, especially between the former VANS licensees and the former Public Switched Telecommunications Network (PSTN) and Mobile Cellular Telecommunication Service (MCTS) licensees. Significant progress towards parity was achieved by removing exclusionary rights and obligations. It is envisaged that the promulgation of outstanding regulations required in terms of the Act and the review of existing regulation will help achieve the stated goal of establishing parity between the licences.
- With regard to the issuance of bulk and individual radio frequency spectrum licences, the Authority noted concerns expressed by Vodacom regarding current pricing disparities. The Authority has decided that the bulk and individual radio frequency spectrum pricing issues will be addressed during the finalisation of the Spectrum Fees regulations.
- 5. The Authority also had to identify terms and conditions already catered for in other regulations, including regulations that are still to be introduced as required by the law. A decision was thus taken not to repeat matters that will be addressed in regulations as required by the Act. In particular, the Authority decided to remove the obligation to file regulatory financial reports in line with COA/CAM, with the understanding that all matters pertaining to regulatory financial reporting will be addressed in terms of the Chapter 10 processes.
- 6. In the old legislative dispensation, the Authority imposed certain obligations on licensees based on the type of licence issued. Certain spectrum licences, principally the 3G and 1800 MHz frequency spectrum licensees issued in terms of the Telecommunications Amendment Act, had obligations relating to frequency spectrum allocated to a licensee. The Authority has therefore decided with respect to issued 3G and 1800 MHz frequency spectrum licences to incorporate obligations relating to the allocation of frequency spectrum in the frequency spectrum licence issued in terms of the ECA. The Authority has further decided in regard to all other frequency spectrum licences issued that the obligations relating to such licence service/s shall be incorporated in the electronic communications network service licence issued to a licensee. The Authority intends reviewing all spectrum related obligations imposed in terms of the ECA or any other Act.

- 7. To facilitate continuity and certainty, the Authority has decided that licensees whose current licences contain universal service roll-out obligations which apply beyond 19 January 2009 shall ensure that they adhere to the terms of such rollouts. The Authority intends conducting a review of universal service in the 2009/10 financial year with a view to introducing a comprehensive universal service framework and obligations applicable to all licensees. It should however be noted that all licensees who have fulfilled universal service obligations in terms of any prior licence issued have a continuing obligation to ensure that services provided in terms of such universal service obligations remain available to communities dependant on them.
- 8. During its consultation processes in December 2008, the Authority also undertook to review the Standard Terms and Conditions regulations with a specific focus on areas that still need to be amicably resolved. This process will be undertaken during the financial year 2009/2010.
- 9. As already stated, all converted licences must comply with the provisions of the Act and must therefore be converted in line with the Act<sup>12</sup>. On the issue of a right to automatic renewal contained in some of the existing licences, the Authority has decided not to include such right in the converted licences and to subject renewal of licences to the provisions of section 11 of the Act read with the Process and Procedure regulations<sup>13</sup>.
- 10. In the converged environment, the Authority cannot uphold any exclusionary and/or monopolistic rights/obligations<sup>14</sup>. Obligations related to Customer Premise Equipment (CPE), Maritime Services and Operator-Assisted Services (OAS) contained in the existing licences were not retained in the converted licences in view of the provisions of section 93(7) of the Act.
- 11. During the financial year 2009/2010 the Authority will address the requirements of section 75 of the ECA with regard to the Directory of Services This will ensure that the Directory of Services regulations are promulgated which subject ECA licensees to similar obligations with respect to the Directory of Services. All existing Directory of Services obligations will be

- regarded as having force and effect until reviewed in terms of section 75 of the Act.
- 12. The Authority decided that all licence exempt Private Electronic Communication Network Service (PECNS), including municipalities. government departments and private companies shall retain the right to use existing radio frequency spectrum issued to them previously. The Authority decided not to re-issue the spectrum licenses to PECNS as such frequency spectrum licences have already been updated and aligned with the ECA during the renewals in 2007 and 2008.
- 13. The Authority noted that licence conversion, especially the conversion of VANS into ECS and ECNS, was going to result in some entities having multiple licences. The Authority has taken a decision, at this point in time, to issue multiple electronic communications and electronic communications network service licences to entities that are entitled to such licences. In terms of a pending review to the Ownership and Control Regulations, it may not be permissible to hold multiple licences and Licensees should be alert to the possibility that they may have to surrender such licences in terms of applicable regulations. In the event that licensees do not intend to use some of the licences that are issued to them such licensees will be encouraged to surrender such licences to the Authority in terms of section 12 of the Act and applicable regulations. Should a licensee decide to sell any of its licences, such sale shall be preceded by an application to transfer a licence in terms of section 13 of the Act.
- 14. The Authority is currently consulting with industry and interested parties on the new license fee regime in terms of Chapter 2 of the ECA. It is intended that a new licence fee regime will be in place by the beginning of the 2009/2010 financial year. The new licence fee dispensation shall provide for a uniform licence fee regime for similarly licensed parties. Pending the promulgation of the new regulations, the Authority has decided that:
  - a. in respect of annual/variable licence fees, licensees shall continue to pay the licence fees set out in the licences issued to them in terms of the Telecommunications Act.

- b. In respect of any outstanding fixed licence fees imposed in terms of any prior licence issued by the Authority, such fees shall continue to be due and payable until the review thereof in terms of the Act.
- 15. During the financial year 2009/2010 the Authority will undertake a review of the ownership and control regulations. Until the new regulatory dispensation is promulgated the ownership and control provisions of any regulation issued in terms of the Independent Broadcasting Authority Act, the Broadcasting Act and the Telecommunications Act shall remain applicable and where ownership and control terms were included in a licence issued in terms of the Independent Broadcasting Authority Act, Broadcasting Act and Telecommunications Act such terms shall be held to remain applicable until reviewed.
- 16. In some cases, licensees requested the Authority to treat information submitted in response to notices relating to the conversion process as confidential information. The Authority considered such requests in terms of section 4D of the ICASA Act and confidentiality regarding ownership and control was granted to various licensees.
- 17. The Authority has noted that some licensees' submissions contained substantial changes in respect of frequencies, channels and bandwidth allocated to them. The Authority has decided that all applications for additional frequencies, channels and bandwidth that are pending before the Authority's approval will be dealt with outside the conversion process. As a result no additional frequencies or channels or bandwidth were added to the converted radio frequency spectrum licences unless approved by the Authority; and
- 18. The Authority has converted all the existing licences in terms of the Act. In the event where some licensees have failed to submit information as requested, their licences will be granted but not be issued until all the information requested is received by the Authority. Licensees that have submitted all the information requested will be granted and issued with their licences.
