2. ULWAZI OLUYISENDLALELO

Ulwazi oluyisendlalelo olulandelayo lufakiwe ukuze lusize abantu abanothando lokufaka imibono ngeNqubomgomo ephakanyisiwe Yokumbiwa Kwezidumbu.

Ukuthuthukiswa koMthetho Wokubuyisana Nobumbano Kuzwelone we-1995 (uMthetho wama-34 we-1995) i-TRC inikezwe umsebenzi wokuthi yenze izincomo kuMongameli. I-TRC income ukuthi kusungulwe ithimba elizophenya ngamacala acishe afinyelele ema-500 abantu abalahlekile ayebikwe ku-TRC kodwa agcina engaxazululekanga. UMongameli waphasisa lezi ziphakamiso ngo-Ephreli 2003 ngaphambi kokuthi kubekwe Umbiko Wokugcina we-TRC ePhalamende.

Ithimba Elifuna Abantu Abadukile lasungulwa **kuYunithi Yokumangalelana Ngokwephulwa Komthetho okuphambili** (*Priority Crimes Litigation Unit*) (PCLU) kuPhiko Lwezokushushisa Lukazwelone we-2004. Ithimba Elifuna abantu selokhu laqala uphenyo ngamacala abantu abadukile ngezindaba zezepolitiki phakathi komhla woku-1 kuMashi 1960 kuya mhla ziyi-10 kuMeyi 1994. Kuze kube manje sekumbiwe izidumbu zabantu ezingama-54.

Kwabonakala isidingo sokuthi kufanele kwakhiwe inqubomgomo yokuqinisekisa ukuthi uhlelo lokumbiwa kwezidumbu ngokwamacala abantu abalahlekile abikwe ku-TRC, kwensiwa ngendlela enokuxhumana nelawulekayo maphakathi nohlaka lomsebenzi onikezwe abenza umsebenzi neqoqomithetho elifanele.

I-DNA kushiwo i-esidi i-deoxyribonucleic noma i-esidi i-deoxyribose nucleic ephatha ulwazi lofuzo olusenhlaiyeni futhi esetshenziswa kakhulu njengethuluzi lokuphenya emkhakheni wezesayensi yomthetho;

Ukufundwa kwamathambo kushiwo ukusetshenziswa kwesayensi yokufundwa kwamathambo omuntu ohlelwani lwezomthetho kufaka ukuhlukanisa kwamathambo asevunde kakhulu noma ezinsalela zamathambo abantu ezingakhonjwanga;

Isayensi yokufunda amasiko kushiwo ukusetshenziswa kwamasu nezindlela zokufunda amasiko akudala ngezinsalela emkhakheni wezomthetho ikakhulukazi ukuphoqeletwa komthetho ophathelene nokwelelesa;

I-Trust Yampaki Enkululeko kushiwo umgwamanda onomsebenzi wokukhokhela ukuthuthukiswa kwamaPaki Enkululeko, iPhrojekthi Yefa Likazwelone ngokoMthetho Wesizinda Samagugu Kuzwelone we-1999 (uMthetho wama-25 we-1999) ngokombono wokucacisa konke ukubaluleka kwamagugu, okuzohlanganisa kuhombise ngendlela ecacile nenokuxhumana eNingizimu Afrika eyizwe elisathuthuka ngokolwazi nangokuyona uqobo;

Umqondisi Wezokushushiswa Komphakathi Kuzwelone (NDPP) kushiwo Umqondisi Wezokushushiswa Komphakathi Kuzwelone oqokwe ngokwesigabese-179(1)(a) soMthethosisekelo waseRiphabhlikhi yaseNingizimu Afrika we-1996 (uMthetho we-108 we-1996) (uMthethosisekelo);

Uphiko Lwezobunhloli Kuzwelone (NIA) kushiwo Uphiko Lwezobunhloli Kuzwelone ukusungulwa kwalo kwabekwa uMthetho Wemisebenzi Yezobunhloli wezi-2002 (uMthetho wama-65 wezi-2002);

Uphiko Lwezokushushisa Kuzwelone (NPA) kushiwo Uphiko Lwezokushushisa Kuzwelone elasungulwa ngokwesigaba se-179 soMthethosisekelo futhi esihambise ngoMthetho Wophiko Lwezokushushisa Kuzwelone we-1998 (uMthetho wama-32 we-1998);

UMgcinimafa Kazwelone kushiwo uMgcinimafa Kazwelone owasungulwa futhi wahanjisa ngokoMthetho Wokuphathwa Kwezimali Zikahulumeni we-1999 (uMthetho woku-1 we-1999) (njengoba usuchitshiyelwe);

Uphiko Lwamaphoyisa Olulwa Namacala Abucayi (PCLU) kushiwo Uphiko Lwamaphoyisa Olulwa Namacala Abucayi elasungulwa Ehhovisi le-NDPP futhi laphathwa Umqondisi Okhethekile ngokwesiMemezelo sama-46 somhla zinga-23 kuMeyi 2003 *kuSomqulu Kahulumeni* wezi-24876;

Uphiko Lwesizinda Samagugu aseNingizimu Afrika (SAHRA) kushiwo inhlango esungulwe ngokwesigaba se-11 soMthetho Wesizinda Samagugu Kuzwelone we-1999 (uMthetho wama-25 we-1999) ukuxhumanisa ukuhlonzwa nokuphathwa kwezizinda zamagugu kuzwelone;

Umkhosи Wezokuvikela Kuzwelone waseNingizimu Afrika (SANDF) kushiwo uMkhosi Wezokuvikela ngamunye owasungulwa ngokwesigaba sama-224(1) soMthethosisekelo waseRiphabhlikhi yaseNingizimu Afrika we-1993 (uMthetho wama-200 we-1993) nosebenza noMthetho Wezokuvikela wezi-2002 (uMthetho wama-42 wezi-2002);

Umsebenzi Wamaphoyisa aseNingizimu Afrika (SAPS) kushiwo umsebenzi wamaphoyisa ngamunye owasungulwa njengoba kushiwo esigabeni se-199(1) soMthethosisekelo. Umsebenzi wamaphoyisa osebenza ngoMthetho Womsebenzi Wamaphoyisa AseNingizimu Afrika we-1995 (uMthetho wama-68 we-1995);

iKhomishane Yamaqiniso Nokubuyisana (TRC) kushiwo iKhomishane eyasungulwa ngokoMthetho Ogquqquzelwa Ubumbano Kuzwelone Nokubuyisana we-1995 (uMthetho wama-34 we-1995), ngenhloso

yokuthuthukisa ubumbano kuzwelonke nokubuyisana ngomoya wokuzwana, odlula izingxabano nokuhlukana okwadlula.

2. INHLOSO

- 2.1 Inhoso yale nqubomgomo ukuqinisekisa ukuthi uhlelo lokumbiwa kwesidumbu mayelana namacala abantu abalahlekile abikwa ku-TRC, kwenziwa ngendlela enokuxhumana nehamba ngokomthetho ngaphakathi kohlaka lomsebenzi wabenzimsebenzi neqoqomthetho elifanele.
- 2.2 Ukungabi bikho kwenqubomgomo ecacile nekuyiyo ukuqondisa uhlelo lokumbiwa kwesidumbu kudale ukuthi kube nezinkinga nezinselelo eziningi ezidalekile, kufaka:
- (a) Ukungaqondakali kahle komsebenzi we-NPA ne-SAPS maqondana:
 - (i) nokuphathelene kanye nokuqondisa uphenyo emacaleni abantu abalahlekile kanye nokumbiwa kwezinsalela zeqidumbu zabantu abashonile; kanye
 - (ii) nasekuqhutshweni kophenyo lwamacala abantu abalahlekile nasekumbiweni kwezinsalela zeqidumbu zabantu abashonile.
 - (b) Ukungabibikho kokucaciseleka mayelana nendima okufanele idlalwe iminyango/nemigwamanda kahulumeni eyahlukeni okudingeka yenze imisebenzi ngezigaba ezithile zohlelo lokumbiwa kweqidumbu.
 - (c) ukudlulisa umsebenzi okungacacile mayelana nezimali zokuqhuba umsebenzi.
 - (c) Ukungabibikho kokuxhumana ngemisebenzi yabenzimsebenzi okudala izingqinamba ekwenzeni nasekuhleleni ukwenza umsebenzi

- 2.3 UNgqongqoshe Wezobulungiswa Nokuthuthukiswa Komthethosisekelo (uNqongqoshe) njengenhloko yezopolitiki yoMnyango unikezwe umsebenzi wokuqapha ukuthi izincomo ze-TRC ziyeziwa bese ebika njalo kuKhabhinethi nasePhalamende bese ezibekela uhlelo lokuthuthukisa inqubomgomo okuyiyo necacile ukuze iqondise uhlelo.
- 2.4 Ngaphansi kokuqondiswa uNqongqoshe imihlangano eminingi yokuxhumana yabanjwa u-DoJ no-CD nabasebenza nabo. Le nqubomgomo ingumphumela walolu hlelo.

3. ISENDLALELO

- 3.1 Ngokwesigaba sesi-4(f), (g) no-(h) soMthetho Wokuthuthukisa Ubumbano Nokubuyisana we-1995 (uMthetho wama-34 we-1995) i-TRC yayinikwe umsebenzi wokuthi yenze izincomo kuMongameli. Zingama-21 kuMashi 2003 i-TRC yanikeza uMongameli umbiko wesikhashana owengeziwe yase iphetha izinhlelo zayo ezithile. Ziyi-15 ku-Ephreli 2003 uMongameli Ekuhlaleni kwePhalamende okuhlanganyelwe wabeka lo mbiko waba semthethweni waqala ngokuthi uMnyango Wezokulungiswa Nokuthuthukisa Komthethosisekelo (u-DoJ ne-CD) bazoqapha ukwenziwa kwalezi zinhlelo bese bebika kuKhabhinethi ngenqubekela phambili.
- 3.2 UMongameli naye ukubekile ukuthi i-NDPP neminyango efanele bazocela ukuthi babhekane nezindaba eziphathelene nabantu abangazange babhekeleke, *imininingwane yokuhlolwa kwesidumbu* kanye nenqubomgomo maqondana nokungcwatshwa kwabantu ezingakhonjwanga izidumbu zabo.

- 3.3 Mhla zingama-23 kuMeyi 2003 uMqondisi Okhethekile waqokwa ngokuMemezela kunhloko ye-PCLU ukuze aphaphe futhi aqondise uphenyo nokushushisa ngamacala enziwa ebantwini, ukubulawa komndeni wonke nezimpi zobugebengu njengoba kuvezwe ekwenziweni kwe-Rome Statute soMthetho Wenkantolo Yobugebengu Yamazwe Omhlaba wezi-2002 (uMthetho wama-27 wezi-2002) kanye nobugebengu obukhulu kuzwelonke nasemazweni omhlaba okufaka izimpi zepolitiki nokucekela phansi, ukuvukela umbuso namacala enziwa amavukela mbuso asemazweni angaphandle noma obunye ubugebengu obuhlelwe yi-NDPP.
- 3.4 NgokweNqubomgommo Yezokushushisa ye-NPA (njengoba isichitshiyelwe), yi-PCLU kufanele ibe nomsebenzi wokuqapha uphenyo nokuthi ishushise izigebengu maqondana nobugebengu obaqala ngezingxabano zakudala. I-PCLU kufanele isizwe ekwenzeni umsebenzi wayo ngumsebenzi onesikhundla esiphezulu wale minyangko kahulumeni elandelayo:
- (a) I-NIA
 - (b) Ingxeny Yeabaseshi ye-SAPS
 - (c) U-DoJ ne-CD
- 3.5 I-PCLU iqale umsebenzi wayo maqondana namacala abantu abalahlekile ekupheleni konyaka wezi-2004. Ukuthola izindawo ababengcwabe kuzo abantu abalahlekile nokuthi bathole imvume efanele ku-SAHRA, kwambiya nezinsalela zejidumbu zabantu abalahlekile. Ngemuva kwalokho kwahlolwa izinsalela, ne-DNA yahlolwa abafunda amathambo basekhaya nabamazwe omhlaba nabafunda amasiko ngezinsalela ukukhomba izinsalela ukuthi ezobani. Okwalandela lolu hlelo ukuthi kudluliselwe izinsalela zejidumbu emindenini yazo ukuze bazingcwabe kabusha.

4. IMIGOMO YENQUBOMGOMO

Imigomo yenqubomgomo -

- (a) ukuhlinzeka ngakho konke kanye nohlaka lokuthi uhlelo lokumbiwa kwezidumbu kufanele lwenziwe;

- (c) ukuxhumanisa izinto okufanele zenziwe nemisebenzi yabo bonke abenzimsebenzi;
- (d) ukuhlinzeka ukuze kusungulwe iKomidi Elibhekele Ukumbiwa Kwezidumbu, elakhwi abenzimsebenzi abaphambili ukuze baxhumanise uhlelo lokumbiwa kwezidumbu;
- (e) ukuqinisekisa ukuthi imigomo yamagugu enesisindo iyathuthukiswa, ngezindlela ezahlukene yezikhumbuzo zezinsalela zezidumbu ezimbiwe;
- (f) ukuqinisekisa ukuthi izinsalela zigcinwe ngesizotha nangesithunzi ngesikhathi kuqhube ka uhlelo lokumbiwa kwezidumbu ngokuhambisana nemihlahlandela elungile yamazwe omhlaba.
- (g) ukuqinisekisa ukuthi iminden ethintekayo kuyaxhunywana nayo kuze kuphele ukumbiwa kwezidumbu;
- (h) ukugqugquzel a ukuthi iminden ethintekayo kudlulise okwenzekile futhi ivale le ndima ngokudlulisa ngendlela kwezinsalela zezidumbu nangolunye usizo oludalulwe yiKomidi Elibhekele Ukumbiwa Kwezidumbu;
- (i) ukuqinisekisa ukuthi uhlelo lokumbiwa kwezidumbu kanye nokukhonjwa kwezinsalela nakho ukumbiwa kwezidumbu kuhambisana nezenzo okuyizo zamazwe omhlaba neqoqomithetho elifanele; kanye
- (j) nokulawulwa kwezindleko maqondana nokumbiwa kwezidumbu

5. UBUNGAKO BENDAWO YOKWENZA UMSEBENZI

- 5.1 Inqubomgomo ifaka uhlelo lokumbiwa kwezidumbu maqondana nezinsalela zabantu abalahlekile noma abadukile amacala abo abikwa ku-TRC kodwa agcina engaxazululiwe.
- 5.2 I-TRC ihlukanise la macala abantu abalahlekile izingxenye ezinhlanu. Ngokwenhoso yale nqubomgomo, lawa amane alandelayo ayahambisana:
- (a) Ukulahleka okuphoqiwe.
 - (b) Ukulahleka ekudingisweni.
 - (c) Ukulahleka ngezikhathi zodlame.
 - (d) Amacala engaziwa imbangela yawo.

- (f) Ukudluliselwa kwezinsalela zesidumbu emindenini yazo.
- (g) Ukungcwatshwa kabusha kwezinsalela zesidumbu yimindenri yazo.
- (h) Ukwensiwa kwamatshe ezikhumbuzo ezindaweni zokungcwaba ezindala nezintsha nokugcinwa kwazo.
- (i) Ukudluliselwa kwamacala ekomidini elishushisayo ukuze lithathe izinqumo maqondana nokushushisa.

7. **UKUKHONJWA KWABENZIMSEBENZI**

7.1 Abenzimsebenzi abakhonjiwe nababhalwe kule nqubomgomu akusho ukuthi yibona kuphela okufanele benze umsebenzi, njegoba olunye usizo lwabanye abenzimsebenzi lungacelwa uma kunesidingo.

7.2 IKomidi Elibhekele Ukumbiwa Kwezidumbu zabantu abalahlekile

7.2.1 IKomidi Elibhekele Ukumbiwa Kwezidumbu zabantu abalahlekile kufanele lixhase liphinde lisize abenzimsebenzi okwesikhashana ekuqhubeke ni nokwenza umsebenzi wabo.

7.2.2 IKomodi Elibhekele Ukumbiwa Kwezidumbu zabantu abalahlekile (IKomidi) kufanele libe nalaba benzimsebenzi abalandelayo:

- (a) U-DoJ no-CD.
- (b) I-PCLU yo-NPA.
- (c) I-SAPS.
- (d) UMnyango Wezobuciko Namasiko.
- (e) I-SAHRA.
- (f) I-Trust Yamapaki Enkululeko.

7.2.3 Usihlalo weKomidi kufanele kube u-DoJ no-CD njengoba umnyango unikezwe umsebenzi wokuqapha nokwenza izincomo ze-TRC bese bebika kuKhabhinethi nasePhalamende ngokuqhube kayo.

7.2.4 Imisebenzi yekomidi ukuthi -

- (a) lixhumanise, liqaphe futhi lixhase imisebenzi eyenziwa ngesikhathi kuqhube ka uhlelo lokumba izidumbu;
- (b) babize njalo imihlangano yamalungu Ekomidi, kanye nemihlangano ephakathi kwamalungu ekomidi nabenzimsebenzi owengeziwe wokumbiwa kwezidumbu, ngenhoso -

- (i) yokugqugquzel a ingxoxo phakathi kwabenza umsebenzi abahlukene;
- (ii) ukuhlinzeka ngendawo yokuxoxa ngezinkinga futhi zixazululwe.
- (c) ukungenelela lapho kunesidingo khona ukuqinisekisa ukuthi izinqubo nemisebenzi ebekiwe kuhanjiswa nayo;
- (d) ukukhomba izindawo ezinezinkinga bese benikeza izixazululo njalo nje ukuze kuqinisekiswe ukusebenza okuyikho kohlelo;
- (e) ukuqapha ukwenziweni kwezixazululo ezibekiwe;
- (f) ukuthatha izinqumo maqondana nezikhalazo;
- (g) ukuthola umbiko wenqubekela phambili kubenzimsebenzi;
- (h) ukuhlanganisa isicelo esiya kuNgqongqoshe Wezobulungiswa Nokuthuthukiswa Komthethosisekelo (uNgqongqoshe) ngenhloso yokuthola isiqondiso maqondana namacala ayizinkinga/nanokuzwela;
- (i) ukubika njalo kuNgqongqoshe maqondana nokulandelwa kwenqubomgom; futhi
- (j) ukubika kuNgqongqoshe ngesicelo sakhe ngezindaba eziphathelene nokumbiwa kwesidumbu.

7.3 Abenzimsebenzi abangeziwe

- (b) UMnyango Wezindaba Zasekhaya.
- (c) UMnyango Wezempi.

- (d) Umgcinimafa Kazwelone.
- (e) I-NIA.
- (f) UMnyango Wezindaba zangaphandle (emacaleni lapho umuntu oshonile angcwatshwa kwelinye izwe).
- (g) I-SANDF.

8. IZINDAWO ZOKWENZA UMSEBENZI ZABENZI BOMSEBENZI

- 8.1 Ubudlelwane phakathi kwabenzimsebenzi kufanele kube obunye obuyimpumelelo nobunokusebenzisana okusondelene nokuhloniphana ngemisebenzi enomahluko ocacile nesebenza ngokuzimela emkhakheni womsebenzi ngamunye.
- 8.2 Umenzimsebenzi ngamunye kufanele athule umbiko wenqubekela phambili maqondana nezindawo zakhe zokwenza umsebenzi kuSihlalo weKomidi Elibhekele Ukumbiwa Kwezidumbu ngesikhathi esimisiwe njengoba kunquma Ikomidi.
- 8.3 **U-DoJ ne-CD kufanele:-**
 - (a) baqinisekise ukuthi izibonelelo ngohlolo loxhasomali kumuntu ngamunye olukhokhwa kanye kuphela luyakhokhwa liphuma eSikhwameni Sikamongameli ukukhokhela iminden efanele;
 - (b) baxhumane neminden yabantu abalahlekile;
 - (c) baqaphe inqubekela phambili ekwenziweni kwenqubomgommo bese bebika kuNgqongqoshe, kanti futhi
 - (d) benze umbiko weminyaka yonke ngoNgqongqoshe ukuya kuKhabhinethi nasePhalamende ekwenziweni kwezincomo ze-TRC.

8.4 I-PCLU ye-NPA kufanele iphathe iphinde iqondise uphenyo emacaleni abantu abalahlekile nesikhungo sokushushisa, lapho kufanele khona ngokwenqubomgomgo yezokushushisa .

8.5 I-SAPS -

- (a) ngaphansi kokuphathwa nokuqondiswa yi-PCLU kufanele -
 - (i) yenze uphenyo ngamacala abantu abalahlekile;
 - (ii) iqinisekise ukuthi izidumbu zimbiwe ochwepheshe abasemthethweni;
